Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Legal Services of the Hudson Valley 403(B) Thrift Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note 1 Description of Plan

The following description of the Legal Services of the Hudson Valley 403(B) Thrift Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Legal Services of the Hudson Valley (the “Organization”). Employees are immediately eligible to make 403(B) contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to the Internal Revenue Service dollar limits as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty-seven mutual funds and a money market as investment options for participants. The contributions are subject to certain limitations. The Organization contributes 6% of eligible compensation bi-monthly for employees with one year of eligible service.

Participant’s Individual Accounts

Each participant’s account is credited with the participant’s contribution, Organization’s contribution and Plan earnings, and charged with an allocation of administrative and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contribution plus actual earnings thereon. Vesting in the Organization’s contribution portion of their account is based on years of service. A participant is 100% vested after five years of credited service or reaching the age of fifty-five.

Forfeited Accounts

Unallocated forfeitures at December 31, 2024 and 2023 were \$0, respectively.

If a participant receives a distribution and the participant resumes employment and coverage under the Plan within five years, the previously forfeited portion of the participant’s account shall be restored to the account on the date of distribution.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans bear interest at commercial bank rates, determined at the time of the loan. Loans currently outstanding bear interest at rates of 6.00%. Principal and interest is paid ratably through bi-monthly payroll deductions.

Loan proceeds are not provided from Plan funds and as a result are not reflected in the 2023 financial statements. These proceeds were provided by the Plan Custodian, and were collateralized by the participant's account balance. During December 2024, loans in the amount of \$355,538 were transferred into the plan. The total loans outstanding amounted to \$355,538 and \$259,713 as of December 31, 2024 and 2023, respectively.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a uniform monthly annuity or a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant will receive the value of their vested interest as a lump-sum distribution.

Funding Policy

The Organization remits employee deferrals and organization contributions to the Plan bi-monthly.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America except for benefit payments which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Participant contributions are recorded when the Organization makes payroll deductions from eligible Plan participants. Employer contributions are accrued in the period in which they become obligations of the Organization.

Effective December 5, 2024, the plan assets were transferred from Mutual of America (“MOA”) to Principal Trust Company,

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Professional fees and other administrative expenses are paid by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3 Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Observable inputs based upon quoted market prices for identical assets or liabilities within active markets.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

General Fund Account: Investments in the General Fund Account are liquid and credited with a current interest rate. This investment is comparable to a cash equivalent.

Pooled Separate Accounts: Valued at the Net Asset Value (“NAV”) of units held by the Plan at year end. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised, primarily, of shares of registered investment companies held through sub-accounts of a separate account of an insurance company. The Plan Administrator has concluded that the NAV reported by the insurance company, approximates fair value of the investments. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. Due to the nature of the investments, changes in the market conditions, liquidity requirements and the economic environment may significantly affect the NAV of the registered investment companies and, consequently, the fair value of the Plan’s investments.

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Principal Trust Company, the current custodian and Mutual of America Life Insurance Company, the former custodian, the trustees of the Plan, certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 5 Transfer of Assets

In December of 2024, assets in the amount of \$374,083 was transferred in from a separate plan maintained by the Organization. In addition, assets in the amount of \$392,577 were transferred from Hudson Valley Justice Center, a related entity. Lastly, loans in the amount of \$355,538 were transferred in from MOA.

Note 6 Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by MOA. In addition, MOA provides record keeping services to the Plan. MOA is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. These transactions, are not, however, considered prohibited transactions under 29 CFR 408 408(b) of the ERISA regulations.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

Note 8 Tax Status

The Plan Sponsor has adopted a prototype plan, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan Administrator timely adopted the restated prototype plan. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with IRC requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by federal, state and/or local taxing authorities. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 10 Subsequent Events

Management has evaluated subsequent events through September 4, 2025, the date that the financial statements are available for issuance, for disclosure and/or recognition in the financial statements.
