Note 1 – Plan Description

The following description of the TRB Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution employee benefit plan that provides retirement savings benefits to eligible employees of Triple R. Brothers, LTD (the “Company” or “Employer”). The Plan commenced effective January 1, 2018, and was amended and restated effective December 22, 2024, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustees

American United Life Insurance Company (“AUL”), a OneAmerica Financial company (“OneAmerica,” or the “Custodian”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, OneAmerica receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Certain employees of the Company serve as the Plan’s trustees.

Eligibility and Plan Entrance Date

Employees under collective bargaining agreements, nonresident aliens who receive no United States source income, and leased employees are not eligible to participate in the Plan. All other employees become eligible to participate in the Plan after the employee has reached 21 years of age and completed one year of service. Eligible employees are permitted to enter the Plan monthly, upon the first day of each month coincident with or next following satisfaction of the eligibility requirements.

Prior to December 22, 2024, part-time, temporary, and seasonal employees were not eligible to participate in the Plan.

Participant Contributions

Participants may elect to contribute, on a before tax or Roth basis, up to 90% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Effective December 22, 2024, participants may contribute up to 100% of their annual compensation as defined by the Plan. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

The Plan provides for Safe Harbor Employer matching contributions equal to 100% of the first 3% of the participant’s eligible compensation contributed to the Plan, and 50% of the next 2% of the participant’s eligible compensation. The Plan uses a year end true-up matching contribution feature to allow participants to receive the maximum matching contribution available by making up for any loss in matching contributions resulting from the participant’s individual savings strategies.

Note 1 – Plan Description (continued)

Employer Contributions (continued)

The Company may make a discretionary matching contribution on a participant's behalf during the Plan year. Each year, the Company will determine the amount of the discretionary matching contribution percentage. The discretionary matching contribution will be based on business units or locations. The Company may determine a separate discretionary matching contribution for participants working in different business units or locations. All participants share in the allocations regardless of service completed during the Plan year or employment status on the last day of the Plan year. For 2024, the Company elected not to make a discretionary matching contribution.

The Company may also make a discretionary profit-sharing contribution to the Plan on a participant's behalf. All participants share in the allocations regardless of service completed during the Plan year or employment status on the last day of the Plan year. For 2024, the Company elected to not make any discretionary profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Safe Harbor Employer matching contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollover contributions, Safe Harbor Employer matching contributions, and any earnings thereon. Discretionary matching and profit-sharing contributions will vest based on years of service. A participant's match or profit-sharing vests 20% after two years of service and gains 20% each year thereafter until fully vested in year six.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may designate the allocation of their account balances to one or more of these options. The options vary in types of investments, rates of return, and investment risk.

Payment of Benefits

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant receives a lump sum distribution of the vested portion of their account balance. Effective December 22, 2024, participants can take a distribution in equal installments. In the case of death, distributions are made to the participant's beneficiary. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions.

A participant may withdraw all or a portion of their pre-tax deferrals or rollover contributions in the event of financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59½.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because it is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Reclassifications

Certain reclassifications have been made to the 2023 financial statement to conform to the 2024 financial statement presentation. These reclassifications had no effect on changes in net assets available for benefits.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses incurred by, or attributable to, a specific participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodian. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate accounts, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations are carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan maintains a traditional, fully benefit-responsive guaranteed investment contract-related investment option, the Stable Value Account, a Fixed Interest Account (the “Fixed Option”), issued by American United Life Insurance Company. The contract issuer is contractually obligated to repay principal and interest at a specified interest rate guaranteed to the Plan. Interest earned on the Fixed Option is compounded daily to the effective annual interest rate. The interest rate to be credited to the Plan will be determined by the insurance company 35 days prior to January 1 of the following year.

Note 5 – Guaranteed Investment Contract with Insurance Company (continued)

The contract meets the fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount which would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 – Related Party and Party-in-Interest Transactions

Plan investments are managed by the Custodian, as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

Prior to December 22, 2024, the Plan adopted a volume submitter profit-sharing plan (the "Volume Submitter Plan") sponsored by Nova 401K Associates, Inc. The Internal Revenue Service ("IRS") has determined and informed the Volume Submitter Plan Sponsor by letter, dated June 30, 2020, that the Volume Submitter Plan was designed in accordance with applicable sections of the IRC. The Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

Effective December 22, 2024, the Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by OneAmerica Financial Partners, Inc. The IRS has determined and informed OneAmerica Financial Partners, Inc., by letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC.

Note 8 – Tax Status (continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Prohibited Transactions

During the Plan year December 31, 2024 and 2023, employee withholdings totaling \$50,373 and \$35,305, respectively, were not remitted to the trust within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. Lost earnings for 2023 employee withholdings were remitted to the Plan in 2024. During 2025, the Company is in the process of correcting contributions to the affected participants' accounts to compensate those participants for potential lost earnings due to the delays.
