To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pavion Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pavion Corp. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



1. DESCRIPTION OF PLAN

The following description of the Pavion Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established effective February 18, 2000, as restated June 16, 2021. The Plan covers all employees of Corbett Technology Solutions, Inc. and its affiliates, Daved Fire Systems, Inc., AFA Protective Systems, Inc., Communications Specialists, LLC, ION247 LLC, Interactive Video Technologies, LLC, Philadelphia Protections Bureau, Inc., Star Asset Security, LLC, Structure Works, Inc., Systems Electronics, Inc., and Enterprise Security Solutions, LLC (collectively, the Company or Plan sponsor) who are age 18 or older. The Plan excludes non-resident aliens and employees covered under a collective bargaining agreement. On October 7, 2022, the Company and its portfolio of recently acquired companies relaunched as "Pavion".

The Plan was amended effective January 1, 2023, to change the name of the Plan to Pavion Corp. 401(k) Plan and add the following additional participating employers to the Plan: Casey Fire Systems, LLC, FRCM Case-Acme, LLC, FT Clearing LLC, Fire Service, LLC, Firecom West, LLC, Firecom, Inc, Multiplex Electrical Services, Inc. and Synergx Systems, LLC. The Plan was amended effective May 1, 2023, to add the following additional participating employer to the Plan: Short Circuit Electronics, Inc. The Plan was amended effective December 1, 2023, to add the following additional participating employers to the Plan: 275 Technology Solutions, Inc. dba Safeway Fire and Protection, ELA Holding Corporation dba Turnkey Technology, LP Network, Inc. dba Security Source, Netronix Integration, Inc. and Premier Security Solutions Corporation.

The Plan was amended effective March 1, 2024, to add the following additional participating employers to the Plan: RFI Electronics, Inc. Oregon, RFI Enterprises, Inc. and K&J Integrated Systems, Inc.

The Plan has appointed Fidelity Management Trust Company (FMTTC) to be the trustee and custodian of the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The board of directors is responsible for oversight of the Plan. The Plan's administrative committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the board of directors.

Contributions - Each year, participants may contribute up to 50 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1 percent on the anniversary of their enrollment date until their deferral rate reaches 7 percent.

The Company contributes a discretionary match of 4 percent of the base compensation up to the amount that a participant contributes to the Plan. For the year ended December 31, 2024, the Company made employer matching contributions of \$6,267,353. The Company may also make additional discretionary amounts and non-elective employer contributions to those participants who have at least 500 hours of service or are employed on the last day of the plan year. Additional matching contributions and non-elective contributions are at the option of the board of directors. For the year ended December 31, 2024, there were no additional matching contributions or non-elective employer contributions to the Plan during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 30 percent vested after one year of credited service, 60 percent vested after two years of credited service and becomes 100 percent vested after three years of credited service.

Regardless of years of service, participant accounts are 100 vested in Company contributions when the participant reaches normal retirement age, becomes permanently disabled, or dies.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at the local prevailing rates as determined by the plan administrator, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$81,257 and \$124,225, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$326,626 and plan administrative expenses were reduced by \$0, from forfeited nonvested accounts, in accordance with plan provisions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent events - Subsequent events were evaluated through October 21, 2025, the date the financial statements were available to be issued. Other than as described below, there were no subsequent events that require recognition or disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

The Plan was amended effective January 1, 2025 to: (1) increase the amount participants may contribute as pre-tax deferrals to 90 percent of their annual eligible compensation, (2) add a safe harbor matching contribution equal to 100 percent of the first 3 percent of participant's compensation contributed to the Plan and 50 percent of the next 2 percent of participant's compensation contributed to the Plan, (3) limit participant loans to one loan outstanding at a time with a 30-day waiting period between loans and (4) add the following merged-in plan: Signet Electronic Systems 401(k) Plan.

The Plan was amended effective February 1, 2025, to (1) add the following merged in plan: ECD Systems, LLC 401(k) Plan and (2) add one additional participating employer to the Plan.

The Plan fully corrected the delinquent participant contributions as indicated in Note 10 by remitting lost earnings to all impacted participants in September 2025.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Blended funds: Valued at the NAV of units held in the blended portfolio account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying fixed investment and the Fidelity Money Market Government Portfolio at a blended mil rate.

Accordingly, FMTC, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Investments, an affiliate of FMTC. FMTC is the custodian and recordkeeper, and, therefore, these transactions qualify as party in interest transactions. Commonwealth Financial Network is an investment advisor and, as such, any transactions with them also qualify as part in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. TAX STATUS

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Determination Letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Determination Letter, the Plan sponsor believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS

For the years ended December 31, 2024 and 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$239,710 and \$1,153,098 for the years ended December 31, 2024 and 2023, respectively. The Company compensated participants for lost earnings resulting from the delay in contributions and remitted both years to the Plan in September and October 2025.



Addendum to Form 5500 of the Pavion Corp. 401(k) Plan

The Pavion Corp. 401(k) Plan is a defined contribution plan that covered more than 100 participants as of the beginning of the 2024 plan year. Thus, the Plan is required to file a Schedule H containing audited financial statements regarding the Plan and an Independent Qualified Public Accountant (“IQPA”) opinion regarding the financial statements and schedules included with Schedule H. The Plan’s plan year runs from January 1 through December 31. Thus, the due date for the 2024 plan year Form 5500 was initially July 31, 2025, but the Plan timely filed a Form 5558 which extended the deadline to timely file the Form 5500 until October 15, 2025. The Plan has engaged an IQPA to audit the financial statements of the Plan and to render an opinion regarding the financial statements. The 2024 audit is still currently in process, and despite best efforts, has not been completed. Therefore, the 2024 IQPA was not able to be completed or render an opinion as of the October 15, 2025 filing deadline. In order to comply with the filing deadline, the Plan has filed the Form 5500 and as soon as the IQPA completes the audit, the Plan will amend the Form 5500 filing to attach a copy of the IQPA's opinion and to make any other necessary corrections.
