Independent Auditors' Report

To the Board of Directors and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Healthcare Support Staffing, LLC. 401(K) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



1. Description of the Plan

The following description of the Healthcare Support Staffing, LLC. 401(K) Profit Sharing Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2006, by Healthcare Support Staffing, LLC (the “Company”). On December 26, 2014, Healthcare Scouts, Inc. 401(k) Profit Sharing Plan and Trust was merged into the Plan. The Plan includes eligible employees from the Company and Healthcare Scouts, Inc. (collectively known as the “Companies”). The Plan was amended and restated on January 1, 2016 to conform the Plan to new tax laws.

Eligibility

The Plan is a participant directed defined contribution plan where all of the Company’s employees, who are age 21 or older are eligible to participate in the employee deferral component of the Plan. Participants are eligible for the employer match once they have one year of service and have worked at least 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Participants may make elective deferrals of up to 86 percent of their annual eligible compensation. This maximum percentage may be reduced by the plan administrator in certain circumstances. The Plan permits employees to make either pre-tax or Roth elective deferrals. Provided requirements are met, withdrawals of Roth 401(k) contributions and any earnings are tax free to the participant. A participant's combined pre-tax and after-tax contributions cannot exceed the maximum annual amount allowed by law. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Employee contributions to the Plan are made through regular payroll deductions. Participants may change their elective deferral contributions at any time during the year.

The Company makes a safe harbor matching employer contribution equal to 100 percent of the first 3 percent of employee deferral contributions and an additional 50 percent up to 5 percent (for a maximum match of 4 percent) of eligible compensation to the Plan on a per pay period basis. Participants are eligible to receive safe harbor matching employer contributions on the first day of the month coincident with or following the date one year after their date of hire.

Rollovers from other qualified plans are permitted.

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. A participant is 100% vested after two years of credited service for QACA Safe Harbor matching contributions funded prior to January 1, 2023.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over specified period as defined in the Plan document. For termination due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

If, at the time of termination of employment, the participant is not 100% vested, the non-vested portion of the participant's account will become a forfeiture. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. Forfeitures in the amount of \$20,964 was applied to pay administrative fees during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited account balances totaled \$1,816 and \$18,156, respectively.

Investments

The Plan is participant directed and participants may invest their contributions in any of the investment funds offered by the Plan. The Plan's trustee during 2024 is BOKF with the exception of the fully benefit responsive investment contract which is held by Empower.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting and in accordance with generally accepted accounting principles. The financial statements present the net assets available for benefits and changes in net assets available for benefit.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan follows the fair value measurement requirements of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan Sponsor's Board of Directors determines that Plan's valuation policies utilizing information provided by the investment custodial. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments during the year.

The Plan has invested in a fully benefit-responsive investment account with an insurance company. Fully benefit-responsive contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Expenses

Expenses of the Plan are paid either by the Plan or the Company, as provided by the Plan document.

3. Information Prepared and Certified by Trustee

Plan management has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by the custodian and was not subjected to any auditing procedures performed by the independent public accountants:

- Investments, notes receivable from participants, cash and cash equivalents
- Net appreciation in investments, and other investment income
- Information presented in the accompanying supplemental Schedule H, Line 4i

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions (i.e. any non-Safe Harbor contributions).

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes of risk associated with certain investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Tax Status

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The Plan has not individually sought its own determination letter.

7. Party in Interest Transactions

Beginning in January 2023, BOKF acts as the trustee/custodian and the recordkeeper. Therefore, these transactions qualify as party in interest.

8. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 from those used in the prior year.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Investment Contract at Contract Value

The Plan has entered into a benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the separate account guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023 was \$45,350 and \$55,143, respectively. The average crediting interest rate is calculated by dividing the annual interest credited to the participants during the plan year by the average annual fair value of the underlying investment. investment contract does not allow the crediting interest rate to fall below zero percent. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The separate account guaranteed investment contract does not permit the insurance company to terminate the agreement unless the Plan is not in compliance with the investment agreement. The crediting interest rate was 2.80% and 2.15% at December 31, 2024 and 2023, respectively.

10. Operational Compliance Matter (Missed Deferral Opportunity)

In 2023, the Plan Sponsor identified an operational error in which certain eligible employees were not provided the opportunity to make elective deferrals to the Plan in accordance with plan provisions. The error resulted in missed employee deferrals and related employer matching contributions for the affected participants during the impacted periods of 2018-2022.

In 2024, the Plan Sponsor made corrective contributions to the Plan consisting of qualified nonelective contributions (QNECs) and associated employer matching contributions, in accordance with the Internal Revenue Service's Employee Plans Compliance Resolution System (EPCRS). These amounts total \$2,795,579 and are included in the financial statements as employer contributions.

As of December 31, 2024, the associated loss on the corrective contributions had not yet been remitted to the Plan. The estimated pending lost earnings as of December 31, 2024, in the amount of \$1,899,307 are recorded in the financial statements as an employer contribution receivable. The Plan Sponsor intends to contribute the related earnings in 2025.

11. Delinquent Participant Contributions

As reported on Schedule H, line 4a, Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, certain participant contributions were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 CFR 2510-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. Delinquent participant contributions in the amount of \$36,019 was made to the Plan outside of the time frame specified by the DOL. The Company is working to calculate the lost earnings amount on the delinquent participant contributions remitted.

The Company is in the process of filing IRS form 5530 to report and pay an excise tax with respect to the 2024 late remittances as required pursuant to Section 4975 of the Code.

12. Subsequent Events

Management has conducted a review of subsequent events for possible disclosure in or correction of these financial statements through October 20, 2025, the date the financial statements were available to be issued.
