To Whom It May Concern:

This letter is to explain the reason for the late filing of the Form 5500-SF for the Woodland Montessori School Inc, EIN 39-1195818 Plan Number 01, for the plan year ending 12/31/2024.

The delay in filing was due to internal administrative changes that temporarily affected the plan's reporting process. During this transition, certain responsibilities and access to plan records were reassigned, which led to an unintentional delay in the completion and submission of the Form 5500-SF.

Once the issue was identified, we took immediate steps to resolve it, ensure the accuracy of the filing, and submit the required form as promptly as possible. We have since updated our administrative procedures to prevent similar delays in the future.

We respectfully request that this explanation be considered in connection with the late filing.
