Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cytovance Biologics, Inc. 401(k) Profit Sharing Plan And Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). DESCRIPTION OF PLAN

The following description of Cytovance Biologics, Inc. 401(K) Profit Sharing Plan And Trust (the “plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provision.

Human resources management are responsible for the oversight of the Plan. Reliance Trust Company (the Trustee) serves as the trustee of the Plan and holds the Plan assets. ADP, LLC maintains the records of the participant data.

The Plan is a defined contribution plan covering all full-time employees of Cytovance Biologics, Inc., (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible employees may make voluntary contributions through payroll deductions of not less than 1% and up to 50% of compensation on a tax deferred basis pursuant to Section 401(k) of the Internal Revenue Code of 1986. The plan allows participants to designate contributions as Roth contributions. These employee contributions in any calendar year may not exceed a prescribed dollar amount that is increased from year to year for cost-of-living changes. Employer matching contributions are equal to 100% of participant salary deferrals up to a 6% matching contribution limit. Each year, the Company may make a discretionary profit-sharing contribution to the Plan. The plan also allows rollover contributions from other plans.

Each participant’s account is credited with the participant’s 401(k) contribution and is allocated the Company’s contribution and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Participants are vested immediately in all participant deferral contributions plus actual earnings thereon. See vesting schedule below for all employer matching and profit-sharing contributions plus actual earnings thereon.

The Plan Sponsor may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$87,563 and \$38,303 from forfeited, non-vested accounts, respectively.

Upon enrollment in the Plan, participants may direct their contributions among the various investment options as identified in the statement of assets available for plan benefits. Participants may change their investment options at any time.

On termination of service, a participant may elect to receive a lump-sum distribution of his or her vested account balance.

ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENTS

The plan assets, administered by the Company, are part of a separate account established by Reliance Trust Company. This separate account has varying investment divisions that invest in shares of diversified, open-end management investment companies. These investments are valued at the closing net asset value per share as determined by the appropriate fund portfolio at the end of each day. The cost of investments represents shares of the funds that were purchased for this separate account. Purchases are made at the net asset value from the net purchase payments or through reinvestment of all distributions from this separate account.

The Plan represents in the statement of changes in net assets available for plan benefits the net appreciation (depreciation) in the fair value of its security investments in registered investment companies. This net appreciation (depreciation) consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

A participant may request to borrow a minimum of \$1,000 and a maximum amount of the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. All loans from plans maintained by the participant's employer or a related employer will be considered for purposes of determining the maximum amount of the loan. Up to 50% of their vested account balance may be used as collateral for any loan. Participants will be charged an interest rate equal to the prime rate as published in the Wall Street Journal on the 14th day of each month (or on the first business day preceding the 14th in the event the 14th is not a business day), plus one percent. The interest rate will be fixed for the duration of the loan except as otherwise required by law.

RECOGNITION OF REVENUE

Employer contributions are accrued in the year in which the contributions are determined to be payable. Dividend income is recorded at the ex-dividend date.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Administrative expenses of the Plan, including accounting fees, have been paid by the Company. Certain expenses that are paid directly by the Company are excluded from the financial statements and no reimbursement is expected. Other expenses related to general administration or investment related expenses are included in the statement of changes in net assets available for plan benefits.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

The Plan holds notes receivables from participants. These transactions qualify as party-in-interest transactions.

Certain administrative duties are performed by officers and employees of the Plan Sponsor. No officer or employee receives compensation from the Plan for these services.

NOTE 4 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE 5 - TAX STATUS

The trust established under the Plan to hold the Plan's assets qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from federal income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

NOTE 6 – ACCOUNTING FOR UNCERTAINTY IN INCOME TAXES

Accounting principles generally accepted in the United State of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for the years before 2021.

NOTE 7 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for similar assets or liabilities in an inactive market;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: A collective trust fund that is composed primarily of fully benefit responsive investment contracts and is stated at fair value as determined by the issuer of the collective trust fund based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) of the units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
