NOTES TO FINANCIAL STATEMENTS

A - DESCRIPTION OF PLAN

The following description of the Mortgage Financial Services 401(K) Plan (the “plan”) is provided for general information purposes only. The plan sponsor is Mortgage Financial Services, LLC. Participants should refer to the Summary Plan Description (SPD) for additional information.

General

The plan was adopted effective January 1, 2016 and conformed to Federal regulations, and is a qualified defined contribution plan covering all eligible employees of Mortgage Financial Services, LLC (The Company) who have completed thirty days of employment. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). ADP, LLC is the third-party administrator and recordkeeper for the plan and Reliance Trust Company is the custodian. The custodian of the plan has been designated to hold the assets of the plan for the benefit of plan participants and their beneficiaries in accordance with the terms of this plan. The trust fund established by the plan's custodian will be the funding medium used for the accumulation of assets from which plan benefits will be distributed.

Allocations to participant accounts

Assets of the plan are allocated to participant accounts based on specific contributions made by each participant and respective matches made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant's account and any earnings thereon.

Contributions

In order to allow participants the opportunity to increase their retirement income, each participant may, in accordance with nondiscriminatory procedures established by the administrator, elect to make employee voluntary contributions to the plan. Such contributions must generally be paid to the custodian within a reasonable period of time after being received by the employer. There are two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401 (k) deferrals.

The Company may make discretionary matching and/or profit sharing contributions based on decision of management. During the year, the Company chose not to make discretionary matching or profit sharing contributions.

Corrective distributions may be required in the event that employee contributions exceed contribution limitations of the plan. Such amounts, if incurred, are recorded as a liability in the year in which they are initially contributed to the plan. In addition, they are netted against contributions received in the statement of changes in net assets available for benefits. There were \$37,774 and \$94,951 of corrective distributions accrued in the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively.

A - DESCRIPTION OF PLAN (Continued)

Participant rollovers

Participants are allowed to transfer or rollover funds into the plan from other qualified plans.

Vesting

With regard to any discretionary employer matching contributions the participant's portion of the contribution plus actual earnings thereon vest at 20% after the first year of service and increases by 20% each year until fully vested after five years. A plan participant earns a year of service for purposes of vesting if they are credited with 1000 hours of service during the plan year.

Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equivalent to the value of the vested interest in their account.

For termination of service due to other reasons, participants with vested account balances of more than \$5,000 as of distribution date may receive a lump sum distribution from the plan or may elect to rollover all (or any portion) of their distribution to an IRA or to another qualified plan. If the participant's total vested account balance under the plan is \$5,000 or less as of the distribution date, they will receive a distribution of their entire vested account balance in a lump sum payment.

A participant may receive a hardship distribution from their vested account balances, if the distribution is (1) on account of medical expenses incurred by the participant, their spouse or dependents, (2) to purchase (excluding mortgage payments) a principal residence of the participant, (3) for the payment of tuition, related educational fees and room and board for the next twelve months of post-secondary education for the participant, their spouse, children or dependents, (4) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence, (5) payments for burial or funeral expenses of their deceased parent, spouse, children or other dependents, or (6) expenses for the repair of damage to their principal residence that would qualify for the casualty deduction under the Internal Revenue Code.

Forfeitures

The plan may use any forfeitures of the employer's matching contribution to reduce amounts otherwise required to be contributed to the plan by the employer. There were no forfeitures during the current year. There were no unallocated forfeitures at December 31, 2024.

A - DESCRIPTION OF PLAN (Continued)

Investment valuation and income recognition

Mutual funds are reported at fair value based on published market prices, which represent the quoted net asset values of shares held by the plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex dividend date. Net appreciation in fair value of investments includes the plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

Common/collective trusts (CCTs) as defined, are pooled investment vehicles sponsored and maintained by a bank or trust company. Principal has a trust company subsidiary that establishes trusts and maintains their activities. The plan's investment in a CCTs is not considered part of an insurance company's assets like pooled separate accounts and is therefore not subject to insurance regulations. Common collective trusts are reported at fair value as based on inputs other than quoted prices within Level 1 that are observable, either directly or in indirectly.

The plan also offers a self-directed brokerage accounts option. Within the self-directed brokerage accounts, participants can purchase registered investment companies and individual securities listed on major U.S. securities exchanges. These investments are stated at fair value based upon quoted market prices.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time, and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Because the plan is a defined contribution plan, it is not covered by Pension Benefit Guaranty Coverage insurance.

Notes receivable from participants

Participant loans are permitted under the plan. A participant can borrow the lesser of fifty percent of their vested account balance or \$50,000. The initial loan must be at least \$1,000. All loans are considered a directed investment of the participant's account and all payments of principal and interest will be credited to their account. A participant may have two loans outstanding at any given time. Loan terms may not exceed five years except in the case of a loan for a primary residence which may be amortized over a longer term, but not to exceed twenty years. The participant's loan is collateralized by the balance in the participant's account and bears interest at two percent above prime. Principal and interest are paid ratably through payroll deductions each pay period.

Administrative expenses

Any fees related to the administration of the plan or associated with the investment of plan assets may be paid by the plan or by the plan sponsor. If the sponsor does not pay plan-related expenses, such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the plan.

B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following summary of the plan's significant accounting policies is presented to assist in understanding the financial statements. The financial statements and notes are representations of the plan's management, who is responsible for their integrity and objectivity.

Basis of presentation and use of estimates

The plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The accrual basis of accounting requires the use of estimates and assumptions that affect the assets, liabilities, revenues and expenses reported in the financial statements, as well as amounts included in the notes thereto, including discussion and disclosure of contingent liabilities. Although the plan uses its best estimates and judgments, actual results could differ from these estimates as future confirming events occur.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the cash basis when received. Related fees are charged directly to the borrowing participant's account when incurred. Consequently, no allowance for credit losses was considered necessary at year end.

Contributions

Contributions from employees are recorded in the period in which they are deducted from participant earnings. Company contributions may be recorded when received or accrued.

Plan expenses and payments of benefits

Plan expenses and the payment of benefits are recorded when paid by the plan.

Fair value measurements

The framework for measuring fair value is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1

Fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2

Fair values are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly.

Level 3

Fair values are based on at least one significant unobservable input for the asset.

C - TAX STATUS

Mortgage Financial Services 401(K) Plan is based upon a volume submitter plan instrument from ADP, LLC which received an IRS advisory letter dated October 6, 2020. The volume submitter plan instrument has been updated for legislative and regulatory changes. The management committee of ADP, LLC and plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for federal or state income taxes has been included in the plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

Investment securities

The plan's investments are not insured by agencies of the United States government. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits. The maximum amount of loss due to credit risk that the plan would incur if parties to the financial instruments failed to perform according to the terms of the contracts and the collateral, if any proved to be of no value, would approximate the balances that appear on the Statement of Net Assets Available for Benefits.

Notes receivable from participants

If a participant establishes a notes receivable through the plan and does not make loan repayments, the plan administrator may deem the participant loan to be in default. If so, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Certain events could limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

H - PARTY IN INTEREST TRANSACTIONS

A related party is any party who can control or significantly influence plan management or operating policies. Parties-in-interest are defined under DOL Regulations as any employees of the plan, fiduciaries of the plan, service providers to the plan, the employer whose employees are covered by the plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third party administrator (the TPA), investment managers, investment advisors, legal counsel, and plan auditor.

The plan sponsor pays directly any other fees related to the operation of the plan. Fees incurred by the plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment. During 2024, the plan made direct payments of \$5,378 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA.
