### **Opinion**

**Note 1 DESCRIPTION OF PLAN**

The following description of the PB Leiner USA Health Care Plan (“the Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

The PB Leiner USA Health Care Plan is sponsored by PB Leiner USA (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is available to all employees who work for the Company in a position that has been designated as a regular full-time position.

**Benefits**

The Plan provides medical, prescription drug, dental, vision, life, and disability coverage for its eligible participants and their eligible dependents.

Under the flexible spending arrangement, participants may receive reimbursement of their health care expenses that are excludable from the participant’s gross income under Section 105(b) of the Internal Revenue Code and reimbursement of their dependent care expenses that are excludable under Section 129 of the Code.

**Contributions**

The Plan agreement provides that the employee or retiree will pay a portion of the cost of coverage based on coverage elected. Specific amounts contributed are available from the personnel department. Life and disability coverage is provided by the employer.

**Administrative Fees**

The plan sponsor absorbs substantially all administrative fees incurred.

**Note 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the cash basis of accounting. Under this basis, the only asset recognized is cash, and no liabilities are recognized. All transactions are recognized as either cash receipts or disbursements, and non-cash transactions are not recognized. The cash basis differs from accounting principles generally accepted in the United States of America primarily because the effects of contributions receivable and health claims payable are not included in the financial statements. The cash basis is also used on the Department of Labor’s Form 5500, which is filed annually.

**Note 2      SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Use of Estimates**

The preparation of financial statements, in conformity with the cash basis of accounting, requires management to make estimates and assumptions that affect the reported amounts of incurred but not reported claims payable and disclosures of contingent assets and liabilities and the reported changes in net assets during the reporting period. Actual results could differ from those estimates.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**Note 3      CLAIMS ADMINISTRATOR**

The trustees of the Plan have contracted with Self Insured Services Company (SISCO) to provided administrative services through January 2024, and then with United Medical Resources (UMR) from February 2024 through the end of the year.

**Note 4      PLAN TERMINATION**

Although it has not expressed any intent to do so, the sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

**Note 5      TAX STATUS**

The Plan was established and is intended to qualify pursuant to section 501(c) (9) of the Internal Revenue Code as a tax-exempt plan and accordingly, the Plan's net investment income is exempt from income taxes. The Plan has been amended since inception, and the plan sponsor believes the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

**Note 6      CLAIMS PAYABLE AND CLAIMS INCURRED BUT NOT REPORTED**

The Plan's obligation for medical and dental claims payable and claims incurred but not reported is estimated at \$130,797 and \$257,968 as of December 31, 2024 and 2023, respectively. This obligation is based upon the total actual claims incurred prior to the Plan's year-end and paid subsequent to the Plan's year-end as reported in a special claim lag study provided by the claim administrator.

**Note 7 FUNDING POLICY AND STOP LOSS INSURANCE**

The Plan provides that the employer will determine the amount to be contributed by the employee-participants. No specific formula for determining employer contributions is required by the Plan.

The structure of the Plan is to pay claims as they become due and to be reimbursed for those amounts by the plan sponsor on a regular basis. This procedure will continue in the future in order to fund the claims incurred but not reported as of December 31, 2024.

The employer has purchased insurance to cover claims exceeding \$55,000 per year for 2024 and 2023 with an unlimited maximum reimbursement for each individual covered. Excluding two separate individuals whose specific deductibles total \$480,000 for the policy period. The employer received stop loss insurance proceeds of \$614,527 and \$743,091 to cover total eligible plan claims exceeding the amounts noted above for the plan years ended 2024 and 2023, respectively. The proceeds are offset against claims on the statement of changes in net assets. As of December 31, 2024 and 2023, the employer had \$37,987 and \$271,255 receivable under this contract, respectively.


