Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Xodus Medical, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan established effective January 1, 2011 and most recently restated effective January 1, 2021. Substantially all employees of Xodus Medical, Inc. (the "Company") are eligible to participate upon completion of age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

*Contributions* - Participants may elect pre-tax and Roth contributions subject to limits established by the Internal Revenue Service.

The Plan provides for employer nonelective safe harbor contributions and discretionary profit sharing contributions, for which employees are eligible upon completion of one year of service. For the years ended December 31, 2024 and 2023, the safe harbor contribution formula was 3% of employee compensation. Employer safe harbor contributions were \$456,208 and \$417,083 for the years ended December 31, 2024 and 2023, respectively.

*Participant Rollovers* - Participant rollovers represent nonforfeitable transfers from other qualified plans.

*Participant Accounts* - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings. Allocations of plan earnings are based on a participant's account balance as a percentage of the total account balances for the applicable investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Investment Options* - Participants may direct their contributions, as well as their share of employer contributions and any related earnings, into various investment options. The Plan is invested in various funds maintained by Ascensus, LLC, formerly Newport Trust Company.

*Vesting* - Participants are immediately vested in their voluntary contributions, employer matching contributions, and investment income thereon. Employer profit sharing contributions vest according to the following schedule:

2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%

6 or more	100%

*Forfeitures* - Forfeited amounts from terminated participants' non-vested accounts are used to reduce employer contributions or pay plan expenses for the Plan year immediately following the Plan year in which the forfeiture occurs. Forfeitures available for future use at December 31, 2024 and 2023 were \$18,206 and \$20,819, respectively; forfeitures of \$26,044 and \$13,696 were applied toward employer contributions for the years ended December 31, 2024 and 2023, respectively.

*Payment of Benefits* - On termination of service due to death, disability, retirement or other reasons, and subject to certain restrictions, a participant or designated beneficiary may elect to receive an amount equal to the value of the vested interest in his or her account, subject to applicable tax withholding requirements. If a participant's vested account balance exceeds \$5,000, he or she may elect to receive a distribution in a lump-sum payment or IRA rollover. If a participant's vested account balance is less than \$5,000, his or her account will be automatically distributed.

*Cash and Cash Equivalents* – The Plan considers all highly liquid debt securities with original maturities of three months or less to be cash equivalents.

*Administrative Expenses* - The Plan's expenses are paid by the Company or the Plan as provided by the plan document.

*Investment Valuation and Income Recognition* - Investments are carried at their fair value based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the undistributed realized gains or losses and the unrealized appreciation (depreciation) on these investments, in the statements of changes in net assets available for benefits. Gain and losses on securities sold or redeemed are determined on the basis of specific identification.

*Fair Value Measurements* - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to

measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3, measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments in mutual funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded (Level 1 inputs).

This method may produce fair value calculations that may not be indicative of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting dates.

There have been no changes for the years ended December 31, 2024 and 2023.

*Risks and Uncertainties* - Plan assets are composed of various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

*Prior period adjustment* - Employer contributions receivable relating to catch-up at December 31, 2023 was overstated by \$21,836. Accordingly, the 2023 financial statements were restated resulting in decreases to

employer safe harbor contributions of \$16,442 and employer profit sharing contributions of \$5,394 for the year ended December 31, 2023 and a \$21,836 decrease in the employer contributions receivable and net assets available for benefits at December 31, 2023.

*Subsequent Events* - Management has analyzed subsequent events for recognition and disclosure purposes through October 14, 2025, the date which the financial statements were available to be issued.

## **2. INCOME TAX STATUS**

The Plan operates under a non-standardized pre-approved defined contribution plan for which the sponsoring organization has obtained a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed was in compliance with the applicable requirements of the Internal Revenue Code. Although, the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years before December 31, 2021.

## **3. CERTIFIED FINANCIAL INFORMATION**

Ascensus, LLC (formerly Newport Trust Company) and Newport Trust Company, the custodians, have certified that the following data included in the accompanying financial statements is complete and accurate.

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

## **4. PLAN TERMINATION**

The Company anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The net assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

## 5. RELATED PARTIES AND PARTIES-IN-INTEREST

The Plan has investments with Ascensus, LLC, formerly Newport Trust Company, and has incurred certain administrative fees with Ascensus, LLC and Newport Trust Company, which are considered a party-in-interest under ERISA. Certain administrative functions of the Plan are performed by employees of the Company. Neither the Company nor its employees receive any compensation from the Plan.
