### Note 1—Description of the Plan

The following brief description of the 401(k) Incentive Savings Plan for Salaried and Hourly Employees of Kewaunee Scientific Corporation (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering substantially all employees of Kewaunee Scientific Corporation (the “Company” or “Employer”) who have attained age 20 and completed three consecutive months of service. Participants may enter the Plan on the first day of the month after they meet the eligibility requirements. The Plan was established effective January 1, 1984, and was most recently amended effective May 15, 2023. The most recent amendment allowed for the Plan to allow after-tax Roth contributions and to accept rollovers of Roth contributions into the Plan. The Plan is administered by a committee (the “Committee”) composed of employees appointed by the Board of Directors of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Participant Contributions* – Participants may contribute to the Plan any whole percentage up to 60% of their covered compensation up to the Internal Revenue Service (“IRS”) maximum allowable contribution of \$23,000 for the year ended December 31, 2024. Additional contributions of any whole percentage up to 100% of participants’ covered compensation may be made. If a participant is eligible to make deferrals and turns 50 before the end of the calendar year, the participant may defer an additional \$7,500 for the year ended December 31, 2024, into the Plan as a contribution subject to certain Internal Revenue Code (“IRC”) limitations.

*Employer Contributions* – The Company makes safe harbor matching contributions of 100% of the participant’s first 3% of compensation contributed and 50% of next 2% of compensation contributed. The safe harbor contribution for the year ended December 31, 2024, totaled \$999,238. The Company may also make a discretionary profit-sharing contribution. To receive the profit-sharing contribution, generally, participants must be employed on the last day of the Plan year. However, for participants that retire, become totally and permanently disabled, or die during the Plan year, the profit-sharing contribution would be computed through their last day of service with the Company. For the year ended December 31, 2024, there was no discretionary profit-sharing contribution.

*Participant Accounts* – Each participant’s account is credited or reduced with the participant’s contributions, benefit payments, Company contributions, an allocation of Plan earnings (losses), and expenses not paid by the Company. Allocations are based on the ratio the participant’s account balance bears to the total account balances of all participants in the same investment option, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Investment Options* – Upon enrollment in the Plan, a participant may direct contributions in 1% increments in any of the investment options provided by the Committee. Participants may change their investment options daily. The Plan offers an array of participant directed investment options. The Plan has elected to provide such investment options with the intention of appropriately addressing concentrations of credit risk.

*Vesting* – Plan participants vest immediately in all participant and Company contributions. As such, there were no forfeited accounts at December 31, 2024 or 2023.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are only permitted to have one loan outstanding at any given time. Note terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant’s account and bear interest at the prevailing rates. Rates ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

### Note 1—Description of the Plan (continued)

*Benefit Payments* – Distributions are made upon retirement, or in the event of a participant's total and permanent disability, death, or other termination of employment. Participants may elect to defer distributions until the participant reaches the age of 72. In-service distributions can be received while a participant is still actively employed if the participant has experienced a financial hardship, as defined by the Plan. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The Plan's financial statements are prepared on the modified accrual basis of accounting. The modified accrual basis of accounting represents accounting principles generally accepted in the United States of America ("U.S. GAAP"), except for contributions and Plan expenses, which are not recorded until received or paid.

*Use of Estimates* – The preparation of financial statements in conformity with the modified accrual basis requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are stated at fair value, based on quoted prices in an active market less administrative expenses deducted directly from the funds. The difference between proceeds received and the cost of investments sold, as determined using the average cost method, and the change in the difference between fair value and the cost of the investments are reflected in the statement of changes in net assets available for benefits – modified accrual basis as net appreciation in fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Contributions* – Participant and Company contributions are recorded in the period during which the Company remits the contributions to the Plan. See *Basis of Accounting*.

*Payment of Benefits* – Benefits are recorded when paid. The Plan did not have any amounts at December 31, 2024 or 2023, allocated to participants who withdrew from the Plan but have not been paid.

*Administrative Expenses* – Certain administrative expenses incurred by the Plan, such as audit and legal fees, are paid for by the Company while other expenses are deducted from the Plan's assets.

*Notes Receivable from Participants* – Notes receivable from participants are stated at unpaid principal balances plus accrued interest. Delinquent notes receivable from participants are included in benefits paid in the year of default.

*Risks and Uncertainties* – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified accrual basis.

*Fair Value Measurements* – Investments are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

### Note 2—Summary of significant accounting policies (continued)

Three levels of inputs that may be used to measure fair value are described as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Funds* – These investments are public investment vehicles valued using \$1 for NAV. The underlying assets are generally comprised of short-term securities representing high-quality liquid debt and monetary assets and classified within Level 2 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (the “qualified institution”), has certified to the completeness and accuracy of the following data included in the accompanying financial statements – modified accrual basis and supplemental schedule – modified accrual basis as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

- Investments, at fair value, and notes receivable from participants as shown on the statements of net assets available for benefits – modified accrual basis as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits – modified accrual basis for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements – modified accrual basis and supplemental schedule, Schedule of Assets (Held at End of Year) – modified accrual basis.

**Note 5—Party-in-interest transactions**

Certain Plan investments are shares of mutual funds and money market funds managed by the qualified institution. Fees paid to the qualified institution of the Plan totaled \$9,456 for the year ended December 31, 2024. These fees are reported on the statement of changes in net assets for benefits – modified accrual basis, along with a (\$63,506) recordkeeping revenue credit. Additionally, the Plan uses Strategic Advisors, Inc. and Kestra Advisory Services, LLC for investment advisory services. Expenses paid to Strategic Advisors, Inc. and Kestra Advisory Services, LLC totaled \$15,369 and \$24,487, respectively, for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

Notes receivable from participants qualify as party-in-interest transactions.

**Note 6—Plan termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amount credited to each participant’s respective account at the effective date of such termination.

**Note 7—Tax status**

The Company adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the IRS on June 30, 2020 which stated the prototype plan is designed in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements. The prototype plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan also has no income subject to unrelated business income tax and, therefore, continues to be tax exempt.

**Note 7—Tax status (continued)**

The modified accrual basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated subsequent events through October 14, 2025, the date these financial statements were available to be issued.

Effective January 1, 2025, The Plan was amended to change the contribution period from each payroll period to each Plan year for purposes of calculating employer safe harbor matching contributions.

Effective May 1, 2025, the Plan was amended to automatically enroll eligible employees hired on or after the effective amendment date, upon meeting eligibility requirements at a deferral rate of 3%, unless affirmatively elected otherwise. The Plan was also amended to allow in-plan Roth conversions of employee deferrals and safe harbor matching contributions and to allow partial withdrawals from the Plan.
