Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Chevron Phillips Chemical Company LP 401(k) Savings and Profit-Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 – Plan Description

The following description of the Chevron Phillips Chemical Company LP 401(k) Savings and Profit-Sharing Plan (the Plan) is subject to and qualified by more complete information appearing in the Plan document.

The Plan, established on January 1, 2001, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is available to eligible employees of Chevron Phillips Chemical Company LP (the Company), as defined in the Plan document. Upon hire, an eligible employee is automatically enrolled as a participant in the Plan at a pre-tax contribution rate of 6%, and shall have that rate increased annually by 1% on the first of the month following the participant's anniversary of employment, until the rate reaches 8%, unless the participant opts out of deferring to the Plan or otherwise enters his or her own deferral election.

Participants may contribute to the Plan through payroll deductions in whole percentages, pre-tax, Roth after-tax, and/or after-tax medical savings account (MSA) contributions in a combined amount of 1% to 40% of eligible earnings as defined in the Plan document, subject to federal limitations. Although earmarked to help pay medical expenses after participants' retirement, after-tax MSA contributions can be used for any purpose after retirement or termination.

Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans, or accounts from other allowable sources, into the Plan. In addition to pre-tax, Roth after-tax, and after-tax MSA contributions mentioned above, participants who are age 50 or older during a given plan year can make pre-tax and/or Roth after-tax "catch-up" contributions to the Plan, subject to federal limitations. Such catch-up contributions do not receive Company matching contributions and do not count towards the annual contribution limits.

The Company makes a matching contribution equal to 100% of a participant's pre-tax and/or Roth after-tax contributions dollar-for-dollar up to 8% of a participant's eligible earnings. Some employees of Performance Pipe (a division of the Company) are subject to different Company match terms. A participant's after-tax MSA contributions and any rollovers are not eligible for Company matching contributions.

Participants direct the investment allocation of all contributions into the various mutual fund and common collective trust (CCT) options offered by the Plan. The Plan also offers a self-directed brokerage account for the investment of contributions. This self-directed brokerage account is comprised only of investments in mutual funds. Investments in the common stock of Chevron Corporation (Chevron), Phillips 66, and ConocoPhillips are frozen, and therefore may be reallocated to the mutual funds and/or CCTs, but are not offered as current investment options to participants.

The Plan includes only one core revenue sharing investment option. The revenue sharing for this fund is refunded to the participants holding the fund and is not retained by the Company or Trustee of the Plan, Fidelity Management Trust Company. All other revenue sharing activity derives from the self-directed brokerage account and related investment activity made at the direction of fund participants.

A participant's interest in his or her contributions and rollovers, and any associated earnings, is fully vested at all times. Vesting of a participant's interest in Company matching contributions occurs at the earliest of: (a) the date of completion of three years of vesting service; (b) the date of a participant's death occurring prior to termination of employment; (c) the date a participant is declared permanently and totally disabled; or (d) the date a participant reaches age 65. A participant is 100% vested in his or her interest in Company matching contributions if the participant is laid off for lack of work for a period of at least 365 days (or the Company expects such layoff to last at least 365 days).

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$508,768 and \$1,202,279, respectively. These accounts are first used to restore participant accounts, then to reduce employer contributions or Plan expenses. During 2024, forfeited nonvested accounts were used to fund Company contributions of \$1,167,902 and Plan expenses of \$392,225.

The full value of a participant's vested account is available for distribution, either as full or partial cash or rollover lump sum or in periodic cash installments, upon retirement or termination of employment from the Company, permanent and total disability, or death of the participant.

A participant may make regular withdrawals from his or her vested account once every 30 days. Hardship withdrawals are also permitted under certain circumstances.

Participants may borrow from their accounts (participant loans) at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from six months to five years or up to thirty years in the case of loans for the purpose of purchasing a principal residence. Loans are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%.

The Plan is administered by a committee (the Plan Administrator) that makes all decisions with respect to the Plan's operations. Determinations by the Plan Administrator are final and conclusive. Any committee member may participate in the Plan if he or she is otherwise eligible. The Company pays certain administrative expenses of the Plan. The Plan Administrator conducted a fee benchmarking study in 2022 to help fulfill its duty to periodically monitor fees paid by the Plan.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account.

Note 2 – Summary of Accounting Policies

Basis of Accounting. The accompanying financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

Benefit payments are recorded when paid.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions. Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition. Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

Following is a description of the valuation methodologies used for the Plan's investments measured at fair value:

- Common stock values are based on their quoted market prices.
- Mutual funds are valued using quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year-end.
- Participant-directed brokerage accounts consist of mutual funds that are valued on the basis of readily determinable market prices.
- CCTs are valued at the NAV, as reported by the issuer of the fund, as a practical expedient to estimate fair value.

Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Participant Loans. Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced to zero and a benefit payment is recorded.

Risks and Uncertainties. The Plan provides for various investment choices. In general, investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.

Note 3 – Certified Investments

All investment information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, investments at fair value, notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan.

Note 4 – Income Tax Status

The Plan received a determination letter from the Internal Revenue Service (IRS) dated September 16, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (Code), subject to timely adoption of the proposed restated Plan and amendments. The restated Plan and amendments were executed by the Company on December 12, 2014. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since the IRS determination. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6 – Fair Value Measurements

Accounting standards require disclosures that categorize assets and liabilities measured at fair value into one of three different levels, depending on the observability of the inputs employed in the measurement. Level 1 inputs are quoted prices in active markets for identical assets or liabilities. Level 2 inputs are observable inputs other than quoted prices included within Level 1 for the asset or liability, either directly or indirectly through market-corroborated inputs. Level 3 inputs are unobservable inputs for the asset or liability reflecting significant modifications to observable related market data or management’s assumptions about pricing by market participants.
