INDEPENDENT AUDITORS' REPORT

To the Participants and the Trustee of
Ancora – MEP – Canterbury Capital, LLC

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ancora – MEP – Canterbury Capital, LLC, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report.

1. DESCRIPTION OF PLAN:

The following description of the Ancora – MEP – Canterbury Capital, LLC (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, multiple employer plan covering eligible employees, as defined, of Canterbury Capital, LLC and participating affiliated companies (collectively, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following is a list of participating affiliated companies:

Canterbury Capital, LLC
KAC Partners, LLC
MRT Partners, LLC
Columbus Roof Trusses, Inc.
Vincent Lighting Systems Company
Platinum Partners, LLC

Eligibility

Under the terms of the Plan, eligible employees, as defined by the Plan, who have attained the age of 18 and completed 3 months of service are eligible for Plan participation on the first day of each month coinciding with, or next following the date the employee satisfied the eligibility requirements.

Contributions

Each year, participants may contribute pre-tax or Roth salary deferrals on up to 100% of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary matching contribution. The Employer has elected to make a matching contribution for 100% of the first 4% of compensation for the years ended December 31, 2024 and 2023. The Employer may also make a discretionary profit-sharing contribution. There was no discretionary profit-sharing contribution made in 2024 or 2023. The Plan also provides for a safe harbor nonelective contribution; however, no participating employer elected to have safe harbor contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer match contribution portion of their accounts is based on years of continuous service. For all participating affiliated companies a participant is 0% vested after 2 years of credit service and 100% vested in Employer matching contributions after three years of credited service. All other participants vest in discretionary profit-sharing contributions 20% after one year of credited service, 40% after two years of credited service, 60% after three years of credited service, 80% after four years of credited service, and 100% after five years of credited service for all participating affiliated companies.

Participant notes receivable

If elected by a participating employer, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. The note interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination, death, disability, or retirement, a participant may elect to receive a lump sum, partial withdrawal, or substantially equal installment payment in amounts equal to the value of the participant's vested interest in their account. Normal retirement age is 65. The Plan also provides for in-service distributions upon reaching age 59 ½. Hardship distributions are permitted in accordance with IRS guidelines.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,347 and \$8,633, respectively. These accounts may be used to restore participant balances, pay administrative expenses, or reduce future Employer contributions. During the years ended December 31, 2024 and 2023, there were \$9,240 and \$0, respectively, used to reduce Employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant notes receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Upon default, as defined, the plan administrator treats the default as a distribution and offsets the outstanding balance of the note against the participants' vested account balance.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of participant notes receivable or other participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

Effective January 1, 2025, the participating employers amended their participation agreements to allow for a safe harbor contribution which is always 100% vested.

The Plan has evaluated subsequent events through October 20, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEES:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC (Ascensus), the trustee, has certified to the completeness and accuracy of all investments and participant notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on participant notes receivable reflected in the statements of changes in net assets available for benefits for the period from November 14, 2024 through December 31, 2024.

Newport Trust Company (Newport), the prior trustee, has certified to the completeness and accuracy of all investments and participant notes receivable reflected on the accompany statements of net assets available for benefits as of December 31, 2023 and the related investment activity and interest income on participant notes receivables reflected in the statements of changes in net assets available for benefits for the period from January 1, 2023 through November 13, 2024.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate account: The pooled separate account is held in investment contracts with the trustee and is invested according to the stated objectives of the various accounts. The principal is not guaranteed. The pooled separate account is valued at the net asset value (NAV), which is based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Newport and Ascensus are the trustees as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7. TAX STATUS:

The Employer adopted a pre-approved defined contribution plan which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Employer has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

9. NONEXEMPT TRANSACTIONS:

During the years ended December 31, 2024 and 2023, certain employee withholdings totaling \$21,811 and \$3,542, respectively, were not remitted to the Plan in a timely basis within the Department of Labor guidelines. Those transactions constitute nonexempt prohibited transactions. The Employer took the necessary corrective action in 2024 for the affected participants from 2023. The Employer is in the process of taking the necessary corrective action for the remaining affected participants in 2025.
