### **Notes to Financial Statements December 31, 2024 and 2023**

---

#### **Note A – Description of Plan**

The following description of Perform[cb], LLC 401(k) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all employees of Perform[cb], LLC (the “Employer” or the “Company”). The Plan was formed and adopted on January 1, 2009, and most recently restated effective June 30, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees aged 18 or older become eligible to participate in the Plan upon the completion of three months of service. Employees enter the Plan on the first day of the first month coinciding with or next following the date eligibility requirements are satisfied. Employees that are excluded from the Plan are those that are union employees under a collective bargaining agreement, independent contractors and nonresident aliens.

Upon satisfying eligibility requirements, and in the event a deferral election has not been made, employees are automatically enrolled in the Plan at 6% deferral of compensation. The Plan will automatically increase the participant’s deferral percentage by 1% per year, up to a maximum of 10%.

##### **Administration**

The Plan is administered by the Company. The Plan’s assets are held and managed by Ascensus Trust Company (the “Trustee”). The Vanguard Group, Inc. is the record keeper of the Plan.

##### **Contributions**

Participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, subject to limitations imposed by the Internal Revenue Code (“IRC”). The maximum participant deferral for the year ended December 31, 2024, was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the year ended December 31, 2024. Participants may also make post-tax Roth contributions to the Plan.

Under the terms of the Plan, the Company is required to make safe harbor matching contributions in an amount equal to 100% of the participant’s salary deferrals up to 4% of compensation. The Company may also make discretionary profit-sharing contributions to the Plan during the year. No profit-sharing contributions were made during the year ended December 31, 2024. In order to share in allocations of Company profit sharing contributions, participants must be employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year.

The Plan also allows participants to contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution, if any, and Plan earnings. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

##### **Vesting**

Participants are fully vested immediately in the Company’s contributions plus or minus any earnings or losses thereon.

**Note A – Description of Plan (continued)**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account, or other acceptable collateral, and bear interest at a rate of one percentage point over the prime interest rate. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution as of the first day of the second calendar quarter following the calendar quarter in which the participant failed to make a required installment payment.

**Distribution of Benefits**

Upon death, disability, retirement or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals or installments paid over various periods, as defined in the Plan agreement, less any applicable taxes. If the vested account balance is \$7,000 or less, the Plan Administrator may direct the Trustee to distribute this amount as a lump sum distribution without the participant's consent. In-service distributions may be requested upon attaining age 59 ½. Participants may also request a hardship withdrawal for qualifying expenses from their accounts using only elective deferral balances for distribution.

**Forfeitures**

Forfeitures occur when a participant terminates employment and has not vested in a portion of the Company's contribution amount. Forfeitures may be applied to reduce Employer contributions. Although Employer contributions under the current provisions of the Plan are fully vested immediately, forfeitures were transferred from the Plan's previous recordkeeper in 2018 and continue to gain earnings. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$200 and \$12,000, respectively. The Plan utilized forfeitures to reduce Employer contributions in the amount of approximately \$12,000 during the year ended December 31, 2024.

**Plan Termination**

The Company has no intentions to do so, but the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

**Note B – Summary of Significant Accounting Policies**

**Basis of Presentation**

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

**Note B – Summary of Significant Accounting Policies (continued)**

**Valuation of Investments**

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Employer, unless otherwise paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments

**Fair Value Measurements**

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1*        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2*        Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3*        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### Fair Value Measurements (continued)

*Money market funds:* Valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, a qualified institution. As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Ascensus Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note D – Income Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020 for its proto-type plan stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC.

**Note D – Income Tax Status (continued)**

The Plan Administrator evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

**Note E – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Note F – Party-In-Interest Transactions**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an Employer whose employees are covered by the Plan. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$46,000 during the year ended December 31, 2024.

**Note G – ERISA Bonding Requirement**

ERISA Section 412 and related regulations generally require that every fiduciary of an employee benefit plan and every person who handles funds or other property of such a plan shall be bonded. ERISA’s bonding requirements are intended to protect employee benefit plans from risk of loss due to fraud or dishonesty on the part of the persons who “handle” plan funds or other property. ERISA refers to persons who handle funds or other property of an employee benefit plan as “plan officials.” A plan official must be bonded for at least 10% of the amount of funds he or she handles, subject to a minimum bond amount of \$1,000 per plan with respect to which the plan official has handling functions. In most instances, the maximum bond amount that can be required under ERISA with respect to any one plan official is \$500,000 per plan.

Perform[cb], LLC 401(k), Plan Administrator and officials were not fully bonded and have not complied with the Fidelity bonding requirements as of December 31, 2024, and for the year then ended.

**Note H – Subsequent Events**

Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.
