INDEPENDENT AUDITORS' REPORT

To the 401k Investment Committee and Participants
Alabama Credit Union Capital Accumulation Plan
Tuscaloosa, Alabama

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Alabama Credit Union Capital Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Alabama Credit Union Capital Accumulation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Alabama Credit Union Capital Accumulation Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alabama Credit Union Capital Accumulation Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Alabama Credit Union Capital Accumulation Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the

financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS
FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

Note A - Plan Description

The following description of Alabama Credit Union (Sponsor) Capital Accumulation Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan available to qualifying employees of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Consolidated Appropriations Act of 2023 was signed into law on December 29, 2022, which includes the Setting Every Community Up for Retirement Enhancement Act ("SECURE Act") 2.0. SECURE Act 2.0 contains over 90 new provisions related to retirement, with varying effective dates through 2027. As these provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. There was no material impact on the Plan for these financial statements.

Eligibility. An employee is eligible to defer a portion of salary and receive employer matching and discretionary profit sharing contributions after six months of service and attainment of age 19. Entry dates are the first day of the month coinciding with or next following the date requirements are met.

Contributions. Eligible employees may elect to contribute up to 100 percent of compensation to the Plan, subject to limits set forth by the Internal Revenue Service. An individual, who has reached age 50, may defer an additional "catch-up" contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan provides for an automatic participant deferral equal to six percent of compensation. The Plan provides for a matching contribution equal to 100 percent of each participant's deferral amount, disregarding deferral contributions exceeding 5 percent of compensation. Additionally, the Plan permits discretionary profit sharing contributions and the Plan Sponsor approved contributions equal to 5 percent of participant compensation for 2024 and 2023.

On January 1, 2024, the Plan was amended to exclude special, non-regular, discretionary bonuses from the definition of compensation for all contribution types. This amendment also changed the determination period for employer contributions from each pay period to the Plan year, which creates the requirement for a potential annual true-up for each Plan year.

Note A - Plan Description – Continued

Participants' Accounts. Participant accounts are credited with the participant's contributions and the allocations of the employer's contributions, as well as Plan earnings, and charged with an allocation of administrative expenses. Participants may direct the investment of their account balances into various investment options offered by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are always fully vested in their deferral contributions. Vesting in the employer contributions is based on years of vesting service, as defined by the Plan. Employer match contributions are 100% vested after two years of service. Employer profit sharing contributions to a participant's account vest on a graduated schedule over six years of service, at which time the account is 100% vested.

Payment of Benefits. A participant's account becomes fully vested upon the participant's death, permanent and total disability, or attaining normal retirement age. Upon the participant's termination, death, total disability, or retirement, the vested benefits allocated to the participant's account may be paid in a lump sum payment, partial withdrawal or installment, or an annuity. Further, the Plan Administrator may permit a participant who experiences a qualified hardship, as defined, to receive a distribution of a portion of the participant's vested account balance. Distributions are subject to the applicable provisions of the Plan document.

Forfeitures. Amounts not vested at the time a covered employee ceases to participate in the Plan are forfeited and are used to reduce the amount of employer deposit or plan expenses. Forfeitures totaling \$106,896 and \$78,348 were applied to employer contributions for the years ended December 31, 2024 and 2023, respectively. The balance of the forfeitures account was \$18,156 and \$10,529 as of December 31, 2024 and 2023, respectively.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Note B - Summary of Significant Accounting Policies – Continued

Financial Statement Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investments and Investment Income

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements and Note E for a discussion of investments reported at contract value.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. All investments in the Plan are participant directed. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Employee and employer contributions are reported in the year services are rendered to the Company by Plan participants.

Payment of Benefits

Benefits are reported in the year paid.

Administrative Expenses.

The Sponsor pays most of the administrative costs of the Plan associated with professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent transactional fees paid directly by participants to the recordkeeper. In addition, certain investment related expenses are included in the net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note B - Summary of Significant Accounting Policies – Continued

Date of Management’s Review

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued, and noted no events occurring during such periods that would require recognition or disclosure in the financial statements.

Note C - Information Prepared and Certified by Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Standard Insurance Company has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments at fair value
- Investments at contract value
- Interest and dividends
- Net appreciation/depreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note D - Fair Value Measurements

FASB ASC Section 820 - *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset, including assumptions regarding risk.

Note D - Fair Value Measurements – Continued

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: The Standard buys and sells shares of mutual funds through its Separate Accounts. The Standard establishes a unit value which is different than share price of the underlying mutual fund and which is specific to an individual contract. The unit value calculation incorporates four specific components of mutual fund returns in one unit value on a daily basis, 1) changes in the market value (NAV) of the underlying mutual fund, 2) reinvestment of all dividends and capital gains received from the fund company, 3) any revenue sharing that Standard expects to receive from the fund company, and 4) Standard’s fee calculated on a daily basis and based on the total underlying assets in the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E - Guaranteed Insurance Contracts

For the years ended December 31, 2024 and 2023, the Plan held an investment in The Standard Stable Asset Fund A, a collective insurance contract. The Standard’s Stable Asset Fund A is an insurance contract for which contract value is guaranteed for participant transactions by the full faith and credit of Standard Insurance Company. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Note E - Guaranteed Insurance Contracts – Continued

This fund meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Generally, the term “fully benefit-responsive” describes the contract’s guarantee that (1) the crediting rate provided under the contract will not fall below zero, and (2) participant-initiated withdrawals from the fund will be covered at contract value. Because The Standard Stable Asset Fund A is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the stable value insurance contract. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of The Standard Stable Asset Fund A as of December 31, 2024 and 2023, was \$6,829,971 and \$4,809,684, respectively. The crediting interest rate is set by The Standard and approved by management but may not be less than one percent annually. Such interest rates are reviewed on a quarterly basis.

Certain events may limit the Plan’s ability to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement of plan incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value. Examples of such events include the contract owner’s failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Note F - Party-in-interest Transactions

Certain plan investments are managed by The Standard Life Insurance Company, the custodian of the Plan, therefore, these transactions qualify as party-in-interest.

Note G - Plan Termination

Although it has not expressed intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

Note H - Plan Tax Status

The Plan has adopted a defined contribution pre-approved plan document provided by The Standard that is restated to include the latest requirements. The document was approved by the Internal Revenue Service on June 30, 2020, as being designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator believes the Plan is currently operated in compliance with applicable requirements of the Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained by the tax authorities. The Plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S. federal tax examinations for years before 2022.
