### ***Basis for Opinion of the 2024 Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of BowFlex Inc. 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As further discussed in Note 1 and 9 to the financial statements, the board of directors of BowFlex, Inc., the Plan Sponsor, gave written consent to terminate the plan on August 20, 2024, and management determined that liquidation is imminent. As a result, BowFlex Inc. 401(k) Savings Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BowFlex Inc. 401(k) Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the BowFlex Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan established January 1, 1999 by BowFlex Inc. (the “Company” or “Plan Sponsor”), under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is administered by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

On March 4, 2024, the Plan Sponsor, filed voluntary petitions for reorganization under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the District of New Jersey.

On August 20, 2024, the board of directors of the Plan Sponsor gave unanimous written consent to terminate the Plan in connection with their Chapter 11 bankruptcy filing. See Note 10. UMB Bank, the Plan Sponsor’s bankruptcy trustee, was appointed as the plan administrator to handle the liquidation of the Plan. As a result of the plan termination and plan to liquidate the assets, the 2024 financial statements are presented on a liquidation basis of accounting.

b. Eligibility

The Plan was available to all full-time employees of the Company, excluding leased employees, collectively bargained employees, residents of Puerto Rico and certain other employees as defined by the Plan document, who were age 18 or older.

c. Contributions

Participants may voluntarily contribute between 1% and 75% of their eligible compensation. Employee contributions were limited to \$23,000 in 2024 and \$22,500 in 2023, as prescribed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral automatically increased by 1%, to a maximum of 6%, annually on January 1.

Effective June 1, 2023, the plan was amended to eliminate employer matching contributions, including safe harbor contributions. The Plan was also amended to allow for discretionary employer contributions. Prior to June 1, 2023, safe harbor matching contributions were subject to certain limitations by the Plan. For each eligible participant, the Company made safe harbor matching contributions equal to (i) 100% of the participant's elective deferrals up to 1% of compensation for the allocation period and (ii) 50% of the participant's elective deferrals up to the next 5% of eligible compensation for the allocation period.

d. Investment Options

Participants directed the investment of their contributions and the Company's matching contributions into various investment options offered by the Plan, including common collective trusts, and various mutual funds offered through a registered investment company. The Plan was amended effective June 1, 2023 to remove the ability to invest in the Company's stock. Prior to this, the participants could not direct more than 20% of their contributions or transfers to the Company's stock.

e. Participant Accounts

A separate account was maintained for each participant. Each account was credited with the participant's and Company's matching contributions and allocations of Plan earnings. All amounts in participant accounts were participant directed.

f. Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Effective February 1, 2023, the Plan was amended to remove the vesting schedule for employer contributions. Employees active on or after February 1, 2023, were 100% vested in employer match contributions. Anyone terminated before February 1, 2023, was still subject to the vesting schedule previously in effect.

On August 20, 2024, all participant accounts were considered 100% vested due to the Plan's termination. See Note 10.

g. Payment of Benefits

Upon termination of service, a participant may (i) receive a lump-sum distribution equal to their vested account value, (ii) elect to maintain their account in the Plan until a future date, or (iii) elect to receive distributions in the form of installment payments. The Company, at its discretion, can immediately distribute to a participant their vested account upon termination of employment if it does not exceed \$5,000.

h. Forfeitures

Participants who terminate employment forfeit the non-vested portion of Company discretionary non-elective and matching contributions and earnings thereon. At December 31, 2024 and 2023, forfeitures totaling approximately \$0 and \$23,000, respectively, were available to reduce future Company contributions or pay administrative expenses. Forfeitures totaling

approximately \$36,000 and \$16,000 were utilized to reduce Company contributions or pay administrative expenses during 2024 and 2023, respectively.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, were permitted to withdraw, in a single sum, a portion of their elective deferrals as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence. Hardship withdrawals have a minimum amount of \$500 and were limited to two per plan year.

j. Notes Receivable from Participants

The Plan allows participants to borrow from their accounts in amounts ranging from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan per participant may be outstanding at any time. Terms of all loans (other than primary residence loans) were for a period not greater than five years. Primary residence loans were limited to fifteen years. Interest rates were based on the Wall Street Journal's Prime Rate published on the prior business day plus 1%. Loans outstanding as of December 31, 2024 bear interest at a rate of 4.25% to 9.5% and the loans mature through 2033. Loan repayments were made via payroll deduction on a bi-weekly basis and were reinvested according to the participant's investment allocation in effect at the time of the loan repayment. Loans were due in full by the end of the last day of the calendar quarter following the calendar quarter in which the participant's employment with the Company was terminated.

**2. Summary of Significant Accounting Policies**

a. Basis of Accounting

As a result of the liquidation discussed in Note 1, the accompanying financial statement as of and for the year ended December 31, 2024 have been prepared using the liquidation basis of accounting in accordance with accounting principals generally accepted in the United State of America ("GAAP"). This basis of accounting is considered appropriate when, among other things, liquidation is imminent. Under this basis of accounting, assets are valued at fair value, i.e. the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The accompanying financial statements as of and for the year ended December 31, 2023 have been prepared on the accrual basis of accounting in accordance with GAAP.

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

d. Contribution Receivables

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. The Plan does not establish an allowance for credit losses on notes receivables since the receivables are fully secured by the participants' contributions to the Plan. Delinquent notes receivable from participants may be treated as a deemed distribution based on the terms of the Plan document.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Budget Account

The Plan entered into an agreement with the trustee whereby the trustee shares certain revenue generated by the Plan in excess of their fee. These deposits are included in other income on the statements of changes in net assets available for benefits and are available to pay Plan expenses. During 2024 and 2023, administrative budget account credits of approximately \$17,000 and \$52,000, respectively, were used to pay Plan expenses. At December 31, 2024 and 2023, approximately \$0 and \$128,000, respectively, of administrative budget account credits were available to pay future Plan expenses.

h. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**3. Investments**

Participants direct the investment of their contributions and the Company's matching contributions into various investment options offered by the Plan, including common trust funds and various mutual funds offered through a registered investment company. The Plan was amended effective June 1, 2023 to remove the ability to invest in the Company's stock. Prior to

this, the participants could not direct more than 20% of their contributions or transfers to the Company's stock.

#### 4. Fair Value Measurements

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common stock:* Valued at the closing price reported on the active market on which the individual security is traded.

*Common collective trust:* The common collective trust funds consist of:

- a. A stable value fund valued at the NAV of units of a bank collective trust that is comprised primarily of fully benefit-responsive investment contracts, and;

- b. Target date retirement funds which invest in underlying trusts that represent various asset classes and sectors. Based on target dates, the allocation to equity-based underlying trusts is expected to become increasingly conservative over time.

The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the common trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

## 5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

## 6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by the trustee, Charles Schwab Trust Bank, as of and for the years ended December 31, 2024 and 2023 as complete and accurate.

- Investments, at fair value
- Investment income
- Schedule of assets (held at end of year)
- Notes receivable from participants
- Interest on participant notes receivable

## 7. Party-in-Interest Transactions

Certain Plan investment funds are managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan. Additionally, certain investment fees are paid to the trustee and are reflected in the investment income or loss for the year. The Plan also

issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, BowFlex Inc. is a party-in-interest to the Plan. The transactions between the Plan and the Plan Sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan and are considered exempt transactions.

## **8. Tax Status**

The Plan adopted T. Rowe Price Retirement Plan Service Inc. Pre-Approved Defined contribution plan document that received a favorable opinion letter from the Internal Revenue Service ("IRS") dated August 19, 2020, which stated that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Plan Termination**

Due to the Plan Sponsor's bankruptcy filing, the Plan was officially terminated effective September 30, 2024, after which no more contributions were entered into the Plan. Participant accounts were considered as fully vested due to the termination of the Plan.

Since the Plan's assets were not completely distributed after the effective date, the Plan is still being updated to meet qualification requirements and was amended in November 2024 to include certain provisions from the Secure 2.0 Act which includes increasing the minimum cash out limit from \$5,000 to \$7,000 effective June 19, 2025.

The Plan expects to distribute all its assets to its participants in full before the end of 2025.

## **10. Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available for issuance.
