### 1. Description of Plan

The following description of the Shared Support South, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

#### General

Created on January 1, 2020, the Plan is a 401(k) plan covering all full-time employees of Shared Support South, Inc. (the Organization) who have completed one year of service (1,000 hours), excluding union employees whose employment is governed by a collective bargaining agreement and certain nonresident aliens who have no earned income from sources within the United States. Eligible employees may enroll into the plan the first day of the Plan Year quarter coinciding with or next following the date you satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Employee Contributions

All eligible employees are given the opportunity to enroll in the Plan through a salary deferral election. Such amounts are deducted from the participant's compensation each payroll period. Participants may change their salary deferral election at any time during the Plan year. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. All contributions are subject to Internal Revenue Code limitations.

Employee rollover contributions are also permitted.

Eligible employees may elect to opt out of participating in the Plan. There is no provision in the Plan document for automatic enrollment.

#### Employer Contributions

For each period the participant contributes to the Plan, the employer contributes a safe harbor matching contribution equal to 100% of the participant's salary deferral that does not exceed 4% of a participant's compensation. Safe harbor matching contributions are 100% vested.

The employer may at their discretion make an additional contribution to the plan. This contribution (if made) would be allocated to all eligible participants still employed as of the last day of the Plan Year. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

### Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contribution, Plan earnings (losses), and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit credited to the participant's account.

### Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any of the choices provided under the Plan as listed on the supplemental schedule, Schedule of Assets (Held at End of Year). These are determined by the Plan sponsor, and participants may change their investment options daily.

### Notes Receivable from Participants

Participant loans are permitted. A maximum loan is 50% of the participant's vested balance (never more than \$50,000 or less than \$1,000). Generally, the loan term must be 5 years or less. Participants can only have one loan outstanding at any time and payments must be made by participants through payroll deduction.

### Vesting

Participants are always 100% vested (which means that participants are entitled to all of the amounts) in their accounts attributable to the following contributions:

- salary deferrals including Roth 401(k) deferrals and "catch-up contributions"
- safe harbor contributions
- Employer profit sharing contributions
- "rollover" contributions

### Payment of Benefits

If a participant vested account balance does not exceed \$5,000, then the vested account balance may only be distributed in a single lump-sum payment. If a participant vested account balance exceeds \$1,000, a participant must consent to any distribution before it may be made.

If a participant vested account balance exceeds \$5,000, the participant may elect to receive a distribution of the vested account balance in:

- a single lump-sum payment
- partial withdrawals
- Partial distributions are permitted to be structured as a series of monthly payments of not less than \$100. Under this provision, the Participant shall have the right to modify the amount of the monthly payments or cease monthly payments at any time.

Distributions in the event of financial hardship may also be available to participants with a qualifying financial hardship.

## **2. Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reporting amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

All investments of the Plan are participant directed. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information

provided by the investment advisor or Plan custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees, if any, are recorded as administrative expenses and are expensed when they are incurred.

### Plan Benefits

Benefits are recorded when paid to participants.

### Administrative Expenses

Costs of administering the Plan may be paid out of Plan assets unless paid by the Organization. Administrative expenses paid out of Plan assets for the years ended December 31, 2024 and 2023 was \$10,760 and \$16,489, respectively.

### Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks near-term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

### 3. Investments and Fair Value Measurements

Authoritative guidance regarding Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value of hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The Plan's investments at fair value consist of the Plan's interest in pooled separate accounts and mutual funds. The following methods are used to value the investments:

### Pooled Separate Account

As of December 31, 2024 and 2023, the Plan held \$0 and \$885,116, respectively, in pooled separate accounts. The pooled separate accounts are valued at the net asset value of shares held by the Plan at year-end. Investments held in the separate accounts are stated at fair value. The pooled separate account is valued at net asset value per share as determined by investment managers under the so-called “practical expedient.” The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using this method are met. The pooled separate account consists of mutual funds actively traded that are easily redeemed. There are no unfunded commitments. The investment strategies of the underlying investment funds of the separate account include seeking growth and current income.

### Mutual Funds

As of December 31, 2024 and 2023, the Plan maintains \$2,928,773 and \$1,310,489, respectively, of investments in multiple registered investment companies (mutual funds). The mutual funds held by the Plan are deemed to be actively traded. The Plan determined that the valuation measurement inputs of the mutual funds represent the closing price reported on the active market. Accordingly, the Plan has classified these investments within Level 1 of the hierarchy framework.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **4. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### 5. Tax Status

The Plan operates under an adoption agreement in connection with a volume submitter profit sharing plan with cash or deferred arrangement (CODA). This plan document has been filed with the appropriate agency and has obtained an opinion letter dated December 15, 2016 from the Internal Revenue Service (IRS) stating that the Plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (Code) and that the related trust was tax-exempt. The Plan Administrator believes the Plan and the related trust are currently designed and being operated in compliance with the applicable requirements of the Code. The Plan annually files a Form 5500.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Related Party Transactions and Party-in-Interest Transactions

The Plan invests in investment vehicles of Citizen's and Northern Bank. Matrix Trust Company provides administrative and custodial services to the Plan. As a result, these transactions qualify as party-in-interest transactions. During the plan years ended December 31, 2024 and 2023, the plan sponsor was delinquent in remitting \$27,736 and \$16,183 of withheld participant contributions outside of the Department of Labor's required remittance window, respectively. The plan sponsor is currently working to address this matter.

### 7. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by the Plan's trustee, Matrix Trust Company, except for comparing such information certified by the trustee to information included in the Plan's financial statements. The trustee certified to the completeness and accuracy of all investment activity reflected on the accompanying
