Note 1. Description of Plan

General

The following brief description of the Evergreen Senior Management LLC 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan established as a 401(k) retirement plan for the employees of Chestnut Knoll at Home, LLC; Three Reading, LP; Renew HSL Lynchburg Subtenant; Renew HSL Mechanicsville Subtenant; Care HSL Heritage Hill Opco, LLC; Care HSL Belle Reve Opco, LLC; Care HSL Cardinal Village Opco, LLC; Care HSL Newtown Opco, LLC; GAHC3 Bethlehem PA ILF TRS Sub, LLC; GAHC3 Boyertown PA ALF TRS Sub, LLC; Care HSL Harleysville Opco, LLC; GAHC3 Palmyra PA ALF TRS Sub, LLC; GAHC3 York PA ALF TRS Sub, LLC; Renew HSL Douglassville Subtenant, LLC; Renew HSL Blandon Subtenant, LLC; Renew HSL Ephrata Subtenant, LLC; Highway 120 Senior Holding LLC; Old Milton Senior Holding LLC; Gwinnett Park Assisted LLC; Sandy Springs II Development LLC; IVQ Lansdale Opco LP; and IVQ Glassboro Opco LP; The Crossroads at Bon Air (collectively the Company). The Plan covers substantially all employees of the Company who are age twenty-one or older and have completed a minimum service requirement of twelve consecutive months. The Plan is subject to the provisions of *the Employee Retirement Income Security Act of 1974* (ERISA).

The Plan was adopted effective January 1, 2015, and was amended and restated effective January 1, 2022.

Eligibility

An employee is eligible to enter the Plan on the 1st day of the next month following the completion of 12 months of service and upon attaining age 21. Participants are eligible to receive Safe Harbor Matching Contributions as soon as they become eligible to participate in the Plan.

Contributions

Participants may elect to contribute pre-tax or Roth deferral contributions, up to the maximum amount permitted by the Internal Revenue Code (IRC). The Company makes a safe harbor matching of 100% of participant contributions up to 4% of eligible compensation. The Company may also make a discretionary contribution to the Plan in accordance with the provisions contained in the plan document. There were no discretionary contributions made by the Company for the year ended December 31, 2024.

Vesting

Participants are immediately 100% vested in their employee salary reduction, Roth 401(k) and employer safe harbor matching contributions, and related investment earnings.

Forfeitures

Participants are 100% fully vested in the Company matching contributions upon entry into the Plan; therefore, there are no forfeited balances as of December 31, 2024 or 2023.

Participant Accounts

Each participant's account is credited with their deferral contributions, employer contributions and the earnings thereon. Contributions to the Plan are invested by the trustees as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Payment of Benefits

Participants' vested interest in the Plan's assets are distributable generally upon termination, disability, retirement, or death. In addition, participants may request withdrawals pursuant to specific guidelines as set forth in the Plan document.

Notes Receivable from Participants

Each participant is permitted to borrow 50% of his or her vested account balance up to a maximum of \$50,000. The term of a loan may not exceed five years unless it is used to purchase a primary residence. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. Principal and interest are paid ratably through payroll deductions and monitored by the plan administrator. The loans are collateralized by the balance in the participant's account and bear interest at a rate of prime plus 1%. Interest rates at December 31, 2024 ranged from 4.25% to 9.50%.

Administrative Expenses

A portion of administrative expenses for the Plan is paid directly by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value as determined by plan management (see Notes 4 and 5). Purchases and sales of investment securities are recorded on a trade-date basis. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals, and administration expenses.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 16, 2025, the date the financial statements were available for issuance.

Note 3. Information Certified by the Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Life & Annuity Insurance Company of New York (ELAINY) and Empower Trust Company, LLC (ETC), qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds are valued daily based on readily determinable fair value of the mutual funds and classified within Level 1 of the fair value hierarchy.
- Collective trust fund fair value is determined by the trustee of the collective investment trust based on the underlying assets, which represents the net asset value. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

- Short-term investments are valued at quoted market prices in an exchange and active market, which represents the net asset value (NAV) of shares held by the Plan. The money market fund seeks to maintain a \$1.00 NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contracts with Insurance Companies

The Plan has a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Following are features and characteristics of the guaranteed investment contract:

- The contract offered a competitive quarterly gross interest rate. The net interest rate equaled the gross rate less the cost of services and will not go below 0.5%.
- The contract does not have a maturity date. The provisions do not provide for a distribution at book value at some specified future date.
- A contract holder can request a lump sum distribution with a market value adjustment, or an installment payout, at book value, over a period of years.
- The contract continues in force until all assets have been distributed, or no further payments are due.

All financial information related to the contract was reported to the plan participants at contract value. This is the value at which all participant-initiated transactions were performed. The contract was considered fully benefit-responsive, and contract value was the appropriate reported value.

When participant-initiated withdrawals were made, they were always made at contract value. Therefore, plan management does not believe a reasonable method exists for determining fair value at an amount that differs from the contract value, and thus, contract value was the most reasonable estimate of fair value.

Certain events limit the plans ability to transact at contract value with the issuer. Such events included the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (e) premature termination of the contract. Plan management believes that no events are probably of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, or (d) a material amendment to the agreement without the consent of the issuer.

Note 6. Risks and Uncertainties

The Plan's investments are concentrated in investment securities that invest in marketable securities, debt, and fixed income securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 7. Party-In-Interest Transactions

Certain Plan investments are in shares of funds and insurance contracts managed by the custodians of the plan. Therefore, these investments qualify as party-in-interest transactions under the Department of Labor's rules and regulations. Fees paid to Empower by the Plan for administrative services approximated \$34,057 for the year ended December 31, 2024. Services rendered by the investment advisor and third-party administrator qualify as party-in-interest transactions. Fees paid to the investment advisor and third-party administrator amounted to \$20,625 and \$41,440, respectively. These party in interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend, alter or terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, all participants' account balances shall be 100% vested and the account balances will be distributed to the participants by the Plan's trustees.

Note 9. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust sponsored by Alliant Insurance Services Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Plan Sponsor remitted all employee contributions to the Plan, contributions of \$448,487 were not remitted within the required time period for the year ended December 31, 2024. Employee contributions which were not remitted within the required time period and have not been corrected totaled \$528,200 at December 31, 2024.
