### **Scope and Nature of the ERISA Section 103(a)(3)(C)**

We have performed an audit of the financial statements of the Equity 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Equity 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### **DESCRIPTION OF PLAN**

The following brief description of the Equity 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan which covers all eligible employees of Equity Construction Solutions, Inc. (the Company or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

An employee shall be eligible to participate in the Plan upon attainment of age 21, and after one month of employment if the employee is not covered by a collective bargaining agreement, is not classified as an intern, and is not a nonresident alien who does not receive any U.S. source earned income.

#### **Contributions**

Participants may elect to contribute up to 100% of their pre-tax or post tax annual compensation, as defined by the Plan, subject to the maximum established by law. Participants who have attained age 50, before the end of the plan year, are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Deferrals are scheduled to increase by 1% per year up to a maximum of 10% automatically each year unless changed by the participant.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount based on each participant's contributions. The Company can also make non-elective profit sharing contributions using a formula to calculate the allocation of each participant's portion of the match. The formula takes a ratio of each participant's individual eligible compensation of the total eligible compensation for all eligible participants and multiplies that fraction by the total non-elective contribution. Contributions are subject to certain limitations. For 2024 and 2023, the Company made discretionary matching contributions of 50% up to 5% of employee contributions. The employer contributed \$121,094 and \$182,951 in matching contributions during the Plan years ended December 31, 2024 and 2023, respectively.

#### **Vesting**

Participants are immediately vested in their elective deferrals and actual earnings thereon. Participants shall have a vested percentage in employer matching contributions in accordance with a graded schedule with 100% vesting after three years of accredited service.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor's contribution and Plan earnings. Allocations are based on participants' earnings or account balances, as provided in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

#### **Payment of Benefits**

On termination of service due to death, disability, or normal retirement, a participant, or his or her beneficiary, will receive a lump-sum amount equal to 100% of the participant's account balance. Normal retirement age is 65 and early retirement is not permitted. In-service withdrawals are permitted for participants who have reached age 59 ½. For termination of service due to other reasons, a participant may receive the value of the vested interest as a lump-sum distribution.

#### ***Administrative Fees and Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees related to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### ***Forfeitures***

During the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$37,988 and \$27,269, respectively. During the years ended December 31, 2024 and 2023, \$62,041 and \$15,159, respectively, were used to reduce employer contributions and pay Plan expenses. At December 31, 2024 and 2023, \$6,015 and \$30,068, respectively, remained available to reduce future employer contributions.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balance or \$50,000. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus one percent. Principal and interest is paid ratably through payroll deductions.

### ***SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

Following are the significant accounting policies adopted by the Plan and used in the preparation of these financial statements:

#### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America and those common to employee benefit plans.

#### ***Contributions***

Contributions are recorded as earned on the accrual basis when withheld from the participant's earnings. Rollover contributions are recognized when received by the Plan.

#### ***Investment Valuation and Income Recognition***

At December 31, 2024 and 2023, the Plan was invested in various mutual funds and a common collective trust fund. Cost of investments is determined using average cost and is used when determining realized gains and losses upon disposition.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trust are reported at fair value using NAV as the practical expedient. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is the basis for current transactions. Transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations at the then current NAV will be carried out in an orderly business manner. The pooled separate accounts have a daily redemption frequency, no redemption notice period, and no unfunded commitments. The common collective trust has a daily redemption frequency, a redemption notice period of one year and no unfunded commitments.

#### ***Investment Valuation and Income Recognition - Continued***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Although their estimates are based on Plan Administration's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

#### ***Risks and Uncertainties***

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### ***INCOME TAX STATUS***

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which received its latest favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

Internal Revenue Service guidelines allow adopting employers of a volume submitter plan to rely on a favorable opinion for qualification requirements without requesting a separate determination letter if the following three requirements are met: 1) the employer's plan is identical to an approved volume submitter plan, 2) the employer has chosen only the options permitted under the terms of the approved plan, and 3) the employer has followed the terms of the plan.

Management believes the Plan has met the three guidelines stated above and intends to continue following the provisions of the volume submitter plan. Thus, the Company has not requested a separate determination letter for the Plan. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan complies with Accounting Standards Codification (ASC) 740-10 related to uncertain tax positions. This standard prescribes a recognition threshold and a measurement attribute for financial statement recognition and measurement of a tax position taken or expected to be taken on a tax return. The Plan administrator is not aware of any tax positions taken by the Plan that they consider to be uncertain. Tax returns for the years ended 2021, 2022, and 2023 are still open and subject to examination by the Internal Revenue Service.

### ***PARTY-IN-INTEREST TRANSACTIONS***

Notes receivable from Plan participants and the related interest income are considered party-in-interest transactions.

The Plan does not consider Company contributions to the Plan to be party-in-interest transactions. The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

### ***REPORTABLE TRANSACTIONS***

The Plan's assets are participant-directed, and thus, the schedule of reportable transactions and certain cost information is not required.

### ***PLAN TERMINATION AND AMENDMENTS***

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. No amendment to the Plan shall have the effect of eliminating or reducing a retirement benefit or eliminating an optional form of benefit with respect to benefits attributable to service before the amendment.

### ***INFORMATION CERTIFIED BY CUSTODIAN***

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus Trust Company (Ascensus) holds the Plan's investments and executed all related transactions for the years ended December 31, 2024 and 2023. The investments and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus for 2024 and 2023.

### ***FAIR VALUE MEASUREMENTS***

The Plan complies with ASC 820 *Fair Value Measurements and Disclosures* to account for and report fair value. ASC 820 provides a single definition of fair value, a framework for measuring fair value and expanded disclosures concerning fair value. It also defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Fair value of certain assets and liabilities are determined based on the fair value hierarchy established in the standard, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The standard describes three levels within its hierarchy that may be used to measure fair value which are:

#### ***Level 1***

Values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

##### **Level 2**

##### **Level 3**

Values are generated from unobservable inputs that are supported by little or no market activity and that are a significant component of the fair value of the assets or liabilities. These unobservable inputs would reflect management's estimates of assumptions that market participants would use in pricing related assets or liabilities. Valuation techniques might include the use of pricing models, discounted cash flow models or similar techniques.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the classification of fair value assets and liabilities within the fair value hierarchy levels.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with ASC 820, certain investments that are measured at fair value using the NAV practical expedient have not been classified in the fair value hierarchy. As noted earlier, the common collective trust funds are excluded from the fair value table since they are reported at NAV.

The Plan did not have any transfers between levels in either year presented, and the new accounting guidance did not have a significant impact on the Plan's financial results or reporting.
