Dear Sir or Madam:

I am writing on behalf of That's No Moon, Inc d.b.a. ShineOn (the "Company") to explain the circumstances surrounding the late filing of Form 5500 for the That's No Moon, Inc dba ShineOn 401(k) Plan (the "Plan") for the 2024 plan year. We respectfully request that any penalties associated with this late filing be abated based on reasonable cause.

Circumstances Leading to Late Filing

The late filing was the result of administrative oversight caused by a transition in our Human Resources department. The previous HR administration did not have proper access credentials to the 401(k) provider's website, despite frequent requests to the 401(k) providers which prevented them from monitoring compliance deadlines and accessing the necessary information to prepare and file Form 5500 on time. This access issue was not discovered or escalated prior to their departure from the Company.

I joined the Company as Human Resources Manager on September 29, 2025, and immediately began conducting a comprehensive review of our HR compliance obligations. During this review, I discovered that the Form 5500 for the 2024 plan year had not been filed. Upon discovering this oversight, I took immediate action to rectify the situation by:

1. Contacting our 401(k) provider to confirm the filing status and obtain necessary access
2. Gathering all required information and documentation for the delinquent filing
3. Initiating the process to file Form 5500 as expeditiously as possible
4. Implementing procedures to ensure timely filing of all future Form 5500 reports

Demonstration of Good Faith

The Company has always intended to comply fully with all ERISA reporting requirements. The failure to file was not intentional or due to willful neglect, but rather the result of an

administrative gap during a period of HR transition. The Company did not benefit from the failure to file, and we took immediate corrective action upon discovery of the oversight.

We have now established proper access protocols and internal controls to ensure that Form 5500 filings are completed timely in the future, including:

- Establishing calendar reminders for all compliance deadlines
- Ensuring proper administrative access to all necessary systems
- Implementing a compliance checklist for annual plan reporting requirements

The Company is committed to maintaining full compliance with all ERISA requirements going forward and regrets any inconvenience caused by this oversight. We respectfully request an abatement of any penalties associated with this late filing due to reasonable cause.
