### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of JCI 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. December 31, 2024 and 2023

#### (1) **Description of the Plan**

The following description of the JCI 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the amended plan agreement for a more complete description of the Plan’s provisions.

##### (a) **General**

The Plan is a defined contribution plan covering all employees of JCI Jones Chemicals, Inc. (the “Company” or the “Employer”) who have completed six months of service and have attained age twenty-one. The Plan was established effective June 1, 1986, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan has adopted certain provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”).

Effective July 27, 2021, the Plan adopted the Cycle 3 Restatement of the Defined Contribution Pre-Approved Plan document administered by Empower Trust Company (“ETC”), formerly Great-West Trust Company, the trustee of the Plan. Recordkeeping services are provided to the Plan by Empower Annuity Insurance Company of America (“EAIC”), formerly Great-West Life & Annuity Insurance Company.

##### (b) **Contributions**

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan also accepts rollover contributions from other qualified plans at any time. The Company contributes 100% of the first 6% of base compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

The Company may, at its discretion, make additional discretionary and qualified non-elective contributions to the Plan. There were no discretionary and qualified non-elective contributions made during 2024.

##### (c) **Participant investment account options**

The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

## JCI 401(K) PLAN

### Notes to Financial Statements - Continued

#### (1) **Description of the Plan - Continued**

##### (d) **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, rollover contributions from other qualified retirement plans, and allocations of the Plan's investment income and administrative expenses. The allocation of plan investment income and administrative expenses is based upon the participant's account balance.

##### (e) **Vesting**

Participants are immediately 100% vested in their voluntary and rollover contributions plus actual investment income thereon.

Participants are 100% vested in Company matching contributions plus the actual investment income thereon after completion of the second year of service.

##### (f) **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined at the time of the loan by the plan administrator. Principal and interest are paid ratably through payroll deductions. A participant may not have more than one outstanding loan balance at any time and not have more than five loans during any one year period. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

##### (g) **Payment of Benefits**

The Plan provides for payment of benefits of the participant's vested account balance as soon as reasonably practical upon retirement, death, total and permanent disability, or termination of employment. The Plan also provides for distribution to a participant upon reaching normal retirement age. Benefits are recorded when paid.

Participants, while employed, may make withdrawals against their vested account balance in accordance with the Plan, which generally requires the demonstration of financial hardship.

##### (h) **Forfeitures**

Non-vested benefits of terminated participants are forfeited on the date the employee terminates. Forfeitures are used to reduce Employer matching and Employer qualified non-elective contributions. At December 31, 2024 and 2023, \$23,358 and \$7,089 was available to offset Employer matching and Employer qualified non-elective contributions, respectively. The Company used approximately \$10,000 in forfeitures to reduce Employer match contributions and pay plan expenses during the year ended December 31, 2024.

#### (1) Description of the Plan - Continued

##### (i) Administrative Expenses

All significant costs related to plan administration are paid by the Company.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

##### (c) Investment Valuation and Income Recognition

Investments in mutual funds are stated at fair value as determined by quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

The Morley Stable Value Fund (the "Fund") is a common/collective trust fund. The Fund consists of a diversified portfolio of stable value investment contracts issued by life insurance companies, banks and other financial institutions, the performance of which may be predicted by underlying fixed income investments. The principal value of these assets are designed to remain stable regardless of stock and bond market fluctuations. The Fund is maintained by Principal Global Investors Trust Company who has retained Morley Capital Management to service as investment advisor. The Fund is valued based on the NAV of units reported by the sponsoring bank or trust company. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily and there are no restrictions on redemptions from this fund.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Included in net appreciation in fair value of investments are realized and unrealized gains and losses resulting from market value adjustments and from recording the results of sales of investments.

##### (d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### (2) Summary of Significant Accounting Policies - Continued

##### (e) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### (f) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### (g) Payment of benefits

Benefits are recorded when paid.

#### (3) Information Certified by Trustee (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations and Disclosures under ERISA. Accordingly, ETC, the Plan's trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments at fair value
- Notes receivable from participants
- Interest, dividends, and other income
- Interest income from notes receivable from participants
- Net appreciation in fair value of investments
- Schedule of asset (held at end of year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedule.

#### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### ***Mutual Funds***

Mutual funds are valued at quoted market prices in an exchange and active markets, which represent the NAV of shares held by the Plan at year end.

#### ***Common/Collective Trust***

Collective trust funds are valued based on the unit value as determined by the sponsoring bank or trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### (6) Party-in-Interest Transactions

The Plan paid approximately \$98,400 to EAIC, an affiliate of the trustee, for services provided to the Plan during 2024. The Plan also paid approximately \$37,200 for investment advisory fees during the year. Revenue received by ETC for administrative services is funded from sub-transfer fees (revenue sharing payments) paid to EAIC from non-ETC funds and from a portion of the expense ratio of ETC Proprietary funds. For the year ended December 31, 2024, approximately \$37,200 is included in other income in the statement of changes in net assets available and was utilized during the year to reduce plan expenses.

Participant loans are considered party-in-interest transactions, because they are transacted with plan participants. These transactions qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA; they are, however, expressly exempted from the prohibited transaction rules.

#### (7) Tax Status

The Plan has adopted the ETC Defined Contribution Prototype Plan and Trust, which received its latest opinion letter from the Internal Revenue Service dated November 14, 2022 stating that the prototype plan adopted by the Company, as then designed, was qualified under Section 401(a) of the Internal Revenue Code. The adopted plan document has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(7) **Tax Status - Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) **Delinquent Participant Contributions**

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. For the years ended December 31, 2024, 2023 and 2022, approximately \$47,000, \$134,000 and \$82,000, respectively, of participant contributions were not remitted or were not remitted within the Plan's remittance policy. The Company is in the process of remitting any applicable lost earnings and excise tax as a result of these delinquent participant contributions via the Voluntary Fiduciary Correction Program.

(9) **Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 2, 2025 the date the financial statements were available to be issued.
