Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Transit Team, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 31, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended January 31, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended January 31, 2022 and as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan merged into another plan effective January 1, 2022, when the decision was made to terminate the plan and management determined liquidation was imminent effective January 31, 2022. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Summary description of Plan:

The following description of the Transit Team, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan inception date was January 1, 1993, is subject to the provisions of ERISA and is a defined contribution plan covering all full-time employees who have completed three months of service and are age eighteen (18) or older. Entry dates to the Plan are the first day of the Plan year and the first day of the seventh month of the Plan year. Employees are eligible for profit sharing contributions upon entering the Plan. Employees are eligible to continue in the Plan even if they have a break in service subject to certain requirements. A break in service is a period of at least twelve consecutive months during which no services are performed for the Company.

Plan merger and termination:

Effective January 1, 2022, the Board of Directors of Beacon Mobility, a controlling party of Transit Team, Inc., approved the merger of this Plan into the Beacon Mobility Transportation Employee Retirement Plan. As a result, all investments were transferred from the Plan into the Beacon Mobility Transportation Employee Retirement Plan effective January 31, 2022 and the Plan was terminated as of that date. Upon termination of the Plan, all of its participants were immediately fully vested.

Contributions:

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, limited to the provisions of Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may provide discretionary matching and profit sharing contributions for eligible participants. For 2022, the discretionary matching contribution did not occur. For 2021, the discretionary matching contribution was equal to 1.5% of the base compensation contributed by each participant up to 6%. The Company did not make a profit-sharing contribution in 2022 or 2021.

Participant accounts:

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings (losses), and charged an allocation of investment fund and administration expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Summary description of Plan (continued):

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and discretionary matching contributions of their accounts plus actual earnings thereon is based on years of service as noted in the table below. Participants are fully vested if they have reached normal retirement age of 65, die, or become disabled.

Investment options:

A participant may direct employee contributions in one percent increments in any one or more of the Plan Sponsor's pre-determined investment options. Participants may change their investment options daily.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Loans are made on a pro rata basis from all investment funds in which an account is invested. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of benefits:

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or, as applicable, in Plan specified annual installments. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship distributions are not permitted.

2. Summary of significant accounting policies:

Basis of accounting:

The 2022 financial statements of the Plan are prepared on the liquidation basis of accounting due to the merger and plan termination.

2. Summary of significant accounting policies (continued):

Use of estimates:

The preparation of the 2021 financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Forfeited accounts:

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used to pay employer contributions and/or administrative expenses. Forfeited non-vested accounts available as of December 31, 2021 totaled \$44,218. During 2022 and 2021, \$2,137 and \$6,459 of forfeitures were used to pay administrative expenses, respectively. During 2021, \$11,795 was moved from participant accounts to forfeitures to correct over-contributions of the employer match. See Note 6.

Investments valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company of the Plan. See Note 4 for discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The investment in the guaranteed investment contract is reported at contract value. See Note 5 for discussion of the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 31, 2022 and December 31, 2021. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Payment of benefits:

Benefits are recorded when paid.

2. Summary of significant accounting policies (continued):

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid directly by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Concentrations:

As of December 31, 2021, approximately 30% of investments were held in two funds included in the pooled separate accounts. See Note 1 regarding termination of Plan, resulting in no investments or concentrations in the Plan at January 31, 2022.

Subsequent events:

Subsequent events were evaluated through October 8, 2025, the date the financial statements were available to be issued.

3. Information certified by Minnesota Life Insurance Company:

The following is a summary of the Plan's asset information as of and for the period ended January 31, 2022 and the year ended December 31, 2021, included throughout the Plan's financial statements that were prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information related to the following assets:

4. Fair value measurement:

The Plan’s investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). FASB ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. This statement establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. FASB ASC 820 also indicates investments that are measured at the net asset value (NAV) per share practical expedient should not be categorized within the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: The Plan has investments in participation units of mutual funds held in pooled separate accounts through sub-accounts of an insurance company as of December 31, 2021. The fair values of these pooled separate accounts are primarily valued at NAV per share, the practical expedient based on quoted market prices for the underlying securities or similar instruments.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate accounts funds have filed as direct filing entities; therefore, the investment's significant investment strategy is not required to be included in these financial statements.

5. Investment contract with Minnesota Life Insurance:

The Plan has a fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Minnesota Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life Insurance Company, represents/represented contributions made under the contract, plus interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. Investment contract with Minnesota Life Insurance (continued):

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants. The investment was included in the transfer as of January 31, 2022 when the Plan was terminated with no material change in value.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligations under the contract, (2) a material misrepresentation, or (3) a material amendment to the agreement without the consent of the issuer.

6. Corrective distributions:

No corrective distributions occurred during the period ended January 31, 2022. During the year ended December 31, 2021, the Company discovered an operational error relating to the definition of compensation used to calculate employee deferrals and related employer matching contributions. Corrective distributions were made to just over 100 participants in September 2021 to correct this error under IRS’ Employee Plans Compliance Resolution System (EPCRS) the self-correction program to distribute the over-contributions.

7. Income tax status:

The Plan obtained its latest opinion letter on March 31, 2014, in which the IRS stated that the Plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and, with the exception of the error corrected as noted in Note 6, is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate regulatory authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Transactions with parties in interest:

Plan investments are managed by Securian, as of January 31, 2022 and December 31, 2021. Securian is the current prototype plan sponsor and therefore, these transactions qualify as parties-in-interest.


