#### **NOTE A — DESCRIPTION OF THE PLAN**

##### **General**

AmeriTrust Group, Inc. (the “Corporation”) established the AmeriTrust 401(k) Profit Sharing Plan (the “Plan”) on July 1, 1984. The Plan, amended October 15, 2021, has been a defined contribution pension plan covering the employees of the Corporation. The Corporation is an affiliate of Meadowbrook, Inc. and was acquired by Emergent Holdings, Inc., which is an affiliate of Blue Cross Blue Shield of Michigan, on December 31, 2022.

##### **Eligibility**

All employees who have reached the age of 21 years or older and have completed six consecutive months of service have been eligible to participate in the Plan. An employee could become a participant on the first day of the month coincident with or next following the date the employee satisfied the eligibility requirements. All new hires who have become eligible employees have been automatically enrolled in the Plan unless they have made an election to not enroll in the Plan or to enroll at a higher rate.

##### **Plan Merger**

As of January 16, 2024, the Plan’s participants were transferred to the Emerging Markets Employees’ Savings Plan (the “Emerging Markets Plan”), a defined contribution pension plan sponsored by Emergent Holdings, Inc. On that date, the Plan’s participants became participants in the Emerging Markets Plan. The amount of net assets transferred to the Emerging Markets Plan was \$96,069,488.

##### **Administration**

The Corporation and the AmeriTrust 401(k) Profit Sharing Plan Committee have been responsible for the general administration of the Plan.

The Plan’s assets are held by Ascensus Trust Company (“Ascensus”), the Plan’s trustee, investment advisor, and recordkeeper. Participants’ savings and the Corporation’s contributions are invested by Ascensus in one or more of several investment funds, as specified by each participant.

##### **Contributions**

Participants could make pre-tax salary reduction contributions and/or Roth contributions up to 75 percent of their compensation, as defined by the Plan document.

**NOTE A — DESCRIPTION OF THE PLAN (CONTINUED)**

**Contributions (continued)**

For employees who have been automatically enrolled, pre-tax salary reduction contributions have commenced at a rate of three percent of compensation and, unless the participant has elected otherwise, have increased annually by one percent until six percent of the participant's compensation has been contributed to the Plan.

Participants who have attained or will attain age 50 before the end of a Plan year have been eligible to make catch-up contributions. Participants could also make rollover contributions of amounts distributed from certain plans and accounts, including qualified defined benefit or defined contribution pension plans and conduit individual retirement accounts.

The Plan provides that the Corporation could make annual discretionary matching contributions for the benefit of participants who have made salary reduction contributions during the Plan year. During 2024 and 2023, the Corporation contributed 50 percent of the first six percent of compensation that a participant contributed to the Plan, subject to certain limitations.

The Plan also provides that the Corporation could make profit sharing contributions to the Plan. Profit sharing contributions, if any, have been allocated to the accounts of participants who are employed on the last day of the Plan (or who died, became disabled, or retired after attaining early or normal retirement age during the Plan year). Such contributions would be allocated to participant accounts based on a calculation of the participant's compensation over the total employee compensation of all eligible participants. The Corporation did not make any profit sharing contributions in 2024 or 2023.

All contributions have been subject to certain limitations of the Internal Revenue Code ("IRC").

Participants have been responsible to direct the investment of contributions made to their accounts into any of the investment options offered by the Plan. Participants could change their investment options on a daily basis. All contributions for which a participant has not made an investment election have been invested into the various investment options offered by the Plan.

All participant and employer contributions are immediately 100 percent vested.

**Participant Accounts**

Each participant's account has been (a) credited with the participant's contribution and allocations of the Corporation's contributions, (b) adjusted for earnings and losses based on the participant's investment elections, and (c) charged with certain administrative fees.

**Participant Accounts (continued)**

Participants could, at any time, direct their account balances among various investment fund options offered by the Plan. The benefit to which a participant has been entitled under the Plan has been the value of the participant's vested account.

**Forfeitures**

Any amounts forfeited by participants under the Plan have been available to reduce subsequent contributions of the Corporation to the Plan or to reduce administrative expenses of the Plan. During the year ended December 31, 2023, \$77 in forfeitures were used to reduce employer matching contributions. There were no forfeitures available to reduce employer contributions or pay additional plan expenses as of January 16, 2024 or December 31, 2023.

**Distributions and Withdrawals**

On termination of employment, retirement, or death, a participant or a participant's beneficiary has been entitled to a distribution of the vested account balance. The normal form of payment is a single lump-sum. Participants whose account balances are less than \$5,000 could have the balance of their accounts distributed from the Plan.

A participant who has remained employed could elect to receive a withdrawal upon attaining age 59½. Withdrawals from the Plan could also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

**Notes Receivable from Participants**

Participants could borrow from the Plan an amount from a minimum of \$1,000 up to a maximum of the lesser of the following:

- One-half of the participant's total account balance
- \$50,000, reduced by the highest cumulative outstanding balance of loans during the preceding 12 months

The loans have been secured by the balance in the participant's account and have borne interest at one percent over the prime rate. The loan terms have ranged from one to five years. Loan terms could extend up to 30 years only in the event the loan proceeds have been used to purchase or construct the participant's principal residence.

The Plan has allowed for participants to take a maximum of two loans at any one time. Principal and interest have been paid ratably through payroll deductions. These loans have been subject to certain restrictions, as defined by the Plan document, and applicable restrictions under the IRC.

**NOTE B — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accounting records of the Plan have been maintained on the accrual basis of accounting.

**Investments**

The Plan's investments, except for the fully benefit-responsive investment contracts, have been stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

The Plan's investments have been valued as follows:

- Investments in registered investment companies have been valued at quoted market prices, which represent the net asset value of shares held by the Plan as of the end of the period.
- Fully benefit-responsive investment contracts have been stated at contract value, as described in Note F.

Purchases and sales of securities have been recorded on a trade date basis. Interest income has been recorded on the accrual basis. Dividends have been recorded on the ex-dividend date. Net appreciation and depreciation have included the Plan's gains and losses on investments bought and sold, as well as held, during the period.

**Notes Receivable from Participants**

Notes receivable from participants have been recorded at cost plus accrued interest. If a participant has ceased to make loan repayments and the Plan administrator has deemed the participant loan to be a distribution, the participant note receivable balance has been reduced and a benefit payment has been recorded. A valuation allowance for credit losses is not considered necessary as of January 16, 2024 or December 31, 2023.

**Fair Value Measurements**

The Plan has used fair value measurements in the preparation of its financial statements, which utilize various inputs, including those that can be readily observable, corroborated, or are generally unobservable. The Plan has utilized market-based data and valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Additionally, the Plan has applied assumptions that market participants would use in pricing an asset or liability, including assumptions about risk.

The measurement of fair value includes a hierarchy based on the quality of inputs used to measure fair value. Financial assets and liabilities are categorized into this three-level fair value hierarchy based on the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets and liabilities and the lowest priority to unobservable inputs.

The various levels of the fair value hierarchy are described as follows:

- Level 1 — Financial assets and liabilities whose values are based on unadjusted quoted market prices for identical assets and liabilities in an active market that the Plan has had the ability to access
- Level 2 — Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable for substantially the full term of the asset or liability
- Level 3 — Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement

The use of observable market data, when available, is required in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, as well as disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Administrative Expenses**

Transaction fees initiated by individual participants, such as loan set-up, loan maintenance, and overnight express mail fees, have been paid by the Plan and have been charged to the initiating participant's account. All other direct costs and expenses incurred in connection with operation of the Plan have been paid by the Corporation.

**Risks and Uncertainties**

The Plan has invested in various securities, including registered investment companies and investment contracts. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Subsequent Events**

The Plan's management has evaluated subsequent events through October 15, 2025, the date that the accompanying financial statements were available to be issued.

**NOTE C — PLAN TERMINATION**

As stated in Note A, the Plan was merged with the Emerging Markets Plan. In accordance with the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), Emergent Holdings, Inc. may, by action of its Board of Directors, discontinue its contributions or terminate the Emerging Markets Plan, although the expectation of Emergent Holdings, Inc. is to continue the Emerging Markets Plan as a permanent program. Upon termination of the Emerging Markets Plan, disbursements of participants' account balances would be made as of the date of termination in the same manner as described for retirement.

**NOTE C — PLAN TERMINATION (CONTINUED)**

Further, trustee fees and other operating expenses incurred after the termination date may, at the discretion of Emergent Holdings, Inc., be paid by the Emerging Markets Plan.

**NOTE D — INCOME TAX STATUS**

The Plan has used a non-standardized pre-approved plan document sponsored by Ascensus. Ascensus received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. In addition, the Plan administrator is not aware of any uncertain tax positions or unrecognized tax benefits as of January 16, 2024 or December 31, 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE E — PARTY-IN-INTEREST TRANSACTIONS**

Participant loan and distribution processing fees have been paid to Ascensus by participants. The Plan has paid certain expenses related to Plan operations and investment activity to various service providers. Therefore, these transactions qualify as party-in-interest transactions.

**NOTE F — UNALLOCATED INVESTMENT CONTRACTS**

The Plan's investments have included unallocated investment contracts investing in the Principal Standard Stable Asset Fund. The Principal Standard Stable Value Fund is a group annuity fully-benefit responsive investment contract entered into with the Standard Insurance Company. The Standard Insurance Company maintains contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Because the unallocated investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the unallocated investment contracts, since contract value is that amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily could direct the withdrawal or transfer of all or a portion of their investment at contract value.

There has been no reserve against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is a blended rate determined using a dollar-weighted average of all the guaranteed interest funds under this contract.

**NOTE F — UNALLOCATED INVESTMENT CONTRACTS (CONTINUED)**

Under the terms of the existing contract, the guaranteed minimum crediting interest rate is one percent and can be reset on a quarterly basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or a merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants have not been probable of occurring.
