Opinion

We have audited the accompanying financial statements of Bay Banks of Virginia, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation as of November 17, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2023 through November 17, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits in liquidation of the Plan as of November 17, 2023 and December 31, 2022, and the changes in net assets available for benefits in liquidation for the period from January 1, 2023 through November 17, 2023, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1. Description of the Plan

The following description of the Bay Banks of Virginia, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution employee stock ownership plan ("ESOP") covering all the eligible employees of the former Bay Banks of Virginia, Inc. ("Bay Banks"). As discussed below, Blue Ridge Bankshares ("Blue Ridge" or "Plan Sponsor") became the Plan Sponsor at the time of acquisition. The Plan was established effective January 1, 1984. The Plan operated as a leveraged ESOP through January 2021 when the ESOP loans were repaid. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Stock exchange and split:

The Plan purchased Bay Banks common stock primarily using the proceeds of multiple ESOP loans made between the Plan and Bay Banks and holds the common stock in a trust established under the Plan. The borrowings were to be repaid over a period of up to ten years by fully deductible Plan Sponsor contributions to the trust fund. As the Plan made each payment of principal and interest, an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the IRC. The ESOP loans were repaid in January 2021.

In January 2021, Blue Ridge, a publicly traded company, acquired Bay Banks, at which time Blue Ridge became the Plan Sponsor. As part of the acquisition, Bay Banks stock was exchanged at one share for one half share of Blue Ridge stock. The Blue Ridge stock then had a three for two stock split.

Transfer of plan assets:

The Board of Directors of the Plan Sponsor voted on November 17, 2021 to transfer the Plan matching fund account balances into the Blue Ridge Bankshares, Inc. 401(k) Plan effective December 31, 2021. As of December 31, 2021, the matching fund account balances of \$68,889 in cash and 68,576 shares of Blue Ridge Bankshares Common Stock were transferred to the control of Blue Ridge Bankshares, Inc. 401(k) Plan. While the control of the matching funds transferred at December 31, 2021, the physical transfer of funds occurred in May 2023 which enabled the Plan to finalize liquidation distributions.

Plan termination:

On April 20, 2022, the Company's Board of Directors voted to terminate the Plan. Upon this date, all active participants became 100 percent vested.

Eligibility:

Employees of Bay Banks were generally eligible to participate in the Plan after completion of 1,000 hours of service within a plan year and attainment of twenty-one years of age. Participants who did not have at least 1,000 hours of service within a plan year or were not employed on the last working day of the year were generally not eligible for an allocation of Plan Sponsor contributions for the year.

Contributions:

The Plan Sponsor was obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. The term loan was paid off during 2020. Employee contributions are not permitted. The Plan Sponsor did not make contributions for the period ended November 17, 2023.

Payment of benefits:

Pursuant to the Plan termination amendment, the plan administrator will direct the distribution of the accounts of participants and beneficiaries no later than within a reasonable period of time after distribution instructions were received. Distributions may be made in the form of cash, Blue Ridge common shares, or a combination of both. Any participant with a balance less than \$1,000 is paid in cash.

Voting rights:

For allocated shares, each eligible participant decided how the trustee will vote the shares held in the Plan on any matters requiring a shareholder vote. Eligible participants had one vote per share.

Participant accounts and forfeitures:

The Plan is a defined contribution plan under which a separate individual account was established for each participant. Each participant's account was credited with an allocation of the Plan Sponsor's contributions, plan forfeitures, plan earnings and charged with benefit payments.

Employer contributions and plan forfeitures were allocated to each participant's account based upon the relation of the participant's compensation to the aggregate compensation of all active participants for the plan year. Plan earnings were allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. For the period ended November 17, 2023 and the year ended December 31, 2022, there were no forfeitures.

Vesting:

All participants were 100 percent vested upon plan termination.

Diversification:

Diversification was offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Blue Ridge stock into investments, which are more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account subject to annual limitations within the plan agreement. Diversification was offered to each eligible participant over a six-year period. For each of the first five years, a participant could diversify up to 25 percent of their account, less any shares previously diversified. In the sixth year, the participant could diversify 50 percent of their account, less any shares previously diversified.

Note 2. Summary of Significant Accounting Policies and Activities

Basis of accounting:

Due to the decision to terminate the Plan during 2022, the financial statements have been prepared using the liquidation basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash:

The Plan maintains cash balances at certain banks which at times may exceed the Federal Deposit Insurance Corporation limits. The Plan's non-interest bearing cash balances were insured to a maximum account of \$250,000 per depositor at each financial institution at December 31, 2022. The Plan did not have any non-interest bearing cash balances at November 17, 2023.

Risks and uncertainties:

For the year ended December 31, 2022, the Plan investments consist primarily Blue Ridge common stock, which was exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it was at least reasonably possible that changes in the value of the common stock could occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition:

There were no investments remaining in the Plan as of November 17, 2023.

All investments on the 2022 Statement of Net Assets Available for Benefits in Liquidation are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The shares were valued based on the closing price reported on the active market on which the shares trade. See Note 5 for disclosure of fair value measurements. Dividend income and interest income were recorded on the liquidation basis. Purchases and sales of securities were recorded on a statement-date basis.

Realized gains and losses from stock transactions are reported on the average cost method. Net depreciation includes the Plan's gains and losses on Blue Ridge stock sold as well as in-kind transfers during the year.

Payment of benefits:

Benefits are recorded when paid.

Subsequent events:

The Plan has evaluated subsequent events through October 17, 2025, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standard-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 3. Administration of Plan Assets

The Plan's assets, which consist principally of Blue Ridge common shares as of December 31, 2022, are held by the trustee of the Plan.

Plan assets are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Plan Sponsor.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the methodologies used at November 17, 2023 and December 31, 2022:

Blue Ridge common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets held at fair value as of November 17, 2023. During the period ended November 17, 2023, the remaining 292,924 shares were redeemed through distributions.

The Plan invested in Blue Ridge common stock. These are related party and party in interest transactions.

Note 7. Tax Status

The Internal Revenue Service (the "IRS") has determined and informed Bay Banks by letter dated April 23, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator, trustee, and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Generally accepted accounting principles in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
