### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the 403(b) Thrift Plan for EIHAB Human Services, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of June 30, 2024, and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### 1. Description of the Plan

The following brief description of the 403(b) Thrift Plan for EI HAB Human Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of EI HAB Human Services, Inc. (the Employer), as defined in the Plan document. The Plan was established effective as of July 1, 2005 and amended since then. For purposes of making salary deferral contributions, employees may enter the Plan immediately. To be eligible to receive the non-elective employer contributions, the participant must also be employed by the Employer for more than one year and be at least 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Contributions*

Each year, participants may elect to defer a portion of their annual earnings to the Plan. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. The Employer makes a non-elective contribution of 2% of an eligible employee's salary to the Plan. For the years ended June 30, 2024 and 2023, the Employer contributed \$144,987 (net of forfeitures) and \$530,461, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Including in the employer contribution receivable amounts, for both 2023 and 2024, are \$145,811 of unfunded employer contributions from the years 2018 through 2021. Of this amount, \$87,145 has been funded in May 2025 and the remaining balance of \$58,666 were remitted as of September 2025.

#### *Investment Options*

All of the Plan's investment options are fully participant directed. Participants may direct the investment of their account balances into any of the Plan's available investment options with Mutual of America Life Insurance Company (Mutual of America) and Empower Trust Company, LLC, and Empower Life Annuity Insurance Company of New York (collectively, Empower).

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Contract Loans to Participants*

Participants may borrow from Mutual of America and use their Plan account balance (invested in the pooled separate accounts or guaranteed interest contract) as collateral. The collateral must be equal to or exceed 120% of the loan, and payments on the loan are made outside of the Plan. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of  $\frac{1}{2}$  of the vested account balance or \$50,000. The loans bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed, as determined by Mutual of America. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. These loans are not considered assets of the Plan and therefore are not reported in the statements of net assets available for benefits. As of June 30, 2024 and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$262 and \$356, respectively. As such, \$314 and \$427 as of June 30, 2024 and 2023, respectively, of account values serve as collateral for the related loans.

### *Notes Receivable from Participants*

Effective October 1, 2017, an active participant may borrow from his or her vested account balance. The maximum amount of any loan is the lesser of 50% of the participant's vested interest minus any existing loan balance, or \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months even if all or a portion of this amount has been repaid. The Plan limits the minimum amount of any loan to \$1,000. An individual may have no more than two loans outstanding at any one time. A general-purpose loan can have a term of anywhere between one to five years. The interest rate on loans is based on the prime rate of interest published by The Wall Street Journal as of the date of the loan, plus 4%. At June 30, 2024 and 2023, interest rates on the loans outstanding ranged from 4% to 12%.

### *Vesting*

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of service and follow the schedule below:

### *Payment of Benefits*

On termination of service due to death, disability, retirement, or severance from employment, a participant or beneficiary is entitled to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, or payments at will. Participants are entitled to retirement benefit payments beginning at the age of 65 based on the full value of their accounts at the normal retirement date. Participants will normally receive payment of their benefits as soon as practicable following their retirement date. For termination of

service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### ***Forfeitures***

If a participant leaves the Employer before becoming fully vested, any nonvested Employer contributions and investment earnings thereon are forfeited. These forfeitures are used to either reduce subsequent Employer contributions to the Plan or reduce reasonable expenses for administering the Plan. As of June 30, 2024 and 2023, the ending forfeiture balances amounted to \$21,386 and \$332,789, respectively. During the year ended June 30, 2024, \$70,639 was forfeited by withdrawing participants, the forfeiture account earned \$7,048 in investment income, and forfeiture balance were used to pay Plan-related expenses or Employer contributions in the amount of \$389,090. No forfeitures were used for the year ended June 30, 2023.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are presented under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. These estimates include fair values of investments. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The investments of the Plan (except for the fully benefit-responsive investment contracts) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Fully benefit responsive investment contracts are reported at contract value. The guaranteed investment contracts are presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mutual of America, Mass Mutual, and Great-West Life & Annuity Insurance Company of New York (GWLA of NY) represents contributions made under the contracts plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

### ***Contributions Receivable***

Participant contributions and the 2% non-elective contributions are recognized in the period when the Company processes the corresponding payroll deduction from the participant's compensation. Additionally, unfunded employer contributions from 2018 to 2021 are reported as contribution receivables for the current year. Non-elective contributions are recorded in the appropriate period as specified in the Plan document.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of benefit payments and general service charges are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits.

### ***Benefit Payments***

Benefit payments are recorded when paid.

### ***Notes Receivable***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

## **3. Risks and Uncertainties**

The Plan is invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended June 30, 2024, were obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America and Empower, qualified institutions.

## **5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual Funds* - These funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts* - These accounts are valued at their accumulation unit value (AUV), which approximates fair value. The AUV is determined daily based on the NAV of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The NAV, as provided by Mutual of America, is used as a practical expedient to measure fair value. The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Fully Benefit-Responsive Guaranteed Investment Contracts

The Plan entered into fully benefit-responsive guaranteed investment contracts with Mutual of America, and GWLA of NY. Mutual of America, and GWLA of NY maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and at a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) and (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contracts do not permit Mutual of America, Mass Mutual, and GWLA of NY to terminate the agreements prior to the scheduled maturity date.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

### 8. Tax Status

The Plan adopted the volume-submitter plan document provided by Dataair Employee Benefit Systems. Dataair Employee Benefit Systems received an opinion letter dated March 31, 2017 from the IRS stating that the volume-submitter plan document is acceptable under Section 403(b) of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Subsequently, the Plan has been amended. The plan has not obtained a determination letter from the Internal Revenue Service subsequent to the amendment. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Party-in-Interest Transactions

Certain Plan investments are managed by Mutual of America, and GWLA of NY. Any purchases and sales of these funds qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants and fees paid to Mutual of America, and GWLA of NY also qualify as exempt party-in-interest transactions.

### 10. Late Remittances

For the year ended June 30, 2024, employee salary deferral withholdings in the amount of \$1,899 were not remitted within the appropriate time period by the Employer. In prior years, employee withholdings in the amount of \$38,963 were not remitted within the appropriate time period by the Employer. These non-exempt party-in-interest transactions constitute a prohibited transaction, as defined by ERISA. In September 2025, the Company self-corrected the 2024 late remittances with a contribution of lost earnings. The Employer will take the appropriate steps to correct the 2024 delinquent contributions by calculating and depositing the corresponding lost earnings into the participant accounts. The Employer has further implemented a procedure to ensure all future remittances are done within the prescribed time period. The Company has not estimated the amount of potential fines or penalties related to these prohibited transactions.
