To the Board of Trustees

Opinion

We have audited the accompanying financial statements of OBI Health Choice Benefits Plan (the Plan), a multiple employer welfare arrangement (MEWA) subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for the Plan of as of December 31, 2024, and the changes in net assets available for benefits for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Emphasis of Matter-Adjustments to the 2023 Financial Statements

As more fully described in Note 7 to the financial statements, the Plan has adjusted its 2023 financial statements to reflect revenue in the proper period. The predecessor auditors reported on the financial statements before the restatement.

As part of our audit of the 2024 financial statements, we also audited the adjustments to the 2023 financial statements described in Note 6 that were applied to restate the 2023 financial statements. In our opinion, such adjustments are appropriate and have been properly applied. We were not engaged to audit, review or apply procedures to of OBI Health Choice Benefits Plan's 2023 financial statements other than with respect to the adjustments and, accordingly, we do not express an opinion or any other form of assurance on the 2023 financial statements as a whole.

I. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the OBI Health Choice Benefits Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was originally established effective July 1997. The Plan is administered by a Board of Trustees that is assisted by a contract administration organization and various professional service providers. Administrative expenses are paid from Plan assets. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Eligibility

To be eligible to participate, employers must be members in good standing of Oregon Business and Industry Association and satisfy the following requirements: 1) employer must have two common law employees who will enroll; 2) the principal address of the participating employer must be in Oregon with a majority of its employees living or working in Oregon.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of additions to and deduction from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Revenue Recognition

Sponsorship revenue is earned monthly as an exclusivity payment from the general agent for the Plan’s sponsored and endorsed health and welfare plans.

Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

2. TRANSACTIONS WITH PARTIES-IN-INTEREST

The plan sponsor, Oregon Business and Industry Association (OBI), a nonprofit trade association, performs customer service and outreach to potential and existing employers in addition to the distribution of documents for the Plan. The Plan reimburses OBI for costs associated with these services. During the year ended December 31, 2023 this fee totaled \$91,200. For 2024, the Plan no longer pays for these services.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions.

In the event of plan termination, the Board of Trustees shall determine the disposition of any assets in the Plan after all expenses of the Plan have been paid; provided that any such distribution will only be made for the benefit of former participants and for the purposes set forth in the Plan. If the assets are insufficient to pay all accrued benefits and liabilities, distribution of the assets shall be made in accordance with plan termination provisions and the requirements of ERISA and applicable government regulations.

4. INCOME TAX STATUS

The Plan is a taxable trust pursuant to the appropriate section of the Internal Revenue Code and is therefore subject to tax on operations under present income tax law. The Plan's Form 1041, U.S. Income Tax Return for Estates and Trusts, for the years ended 2024, 2023, and 2022, are subject to examination by the Internal Revenue Service (IRS), generally for three years after they were filed.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that for the years ended December 31, 2024 and 2023, income tax expense is appropriately stated. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

5. CONCENTRATION OF CREDIT RISK

The Plan maintains its cash balances in several financial institutions. Balances in each institution are insured by the Federal Deposit Insurance Corporation (FDIC) to \$250,000. The balances, at times, may exceed the federally insured limit. Balances in excess of insured limits total approximately \$8,000 and \$13,000 as of December 31, 2024 and 2023, respectively.

6. PRIOR PERIOD ADJUSTMENT

An adjustment was made to the prior year financial statements to remove activity that was recorded in the incorrect period. The adjustment affected the following balances:


