1. DESCRIPTION OF PLAN

The following description of the AMS 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a prototype non-standardized 401k defined contribution plan covering all full-time employees of AMS Impact Group, LLC and the participating affiliate companies: Academy of Math and Science, Inc., Academy of Mathematics and Science South, Inc., Math and Science Academy, Inc., and AMS National, Inc. (collectively the “Company”) who have one month of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year participants may contribute up to 90% of annual compensation (subject to certain limitations), as defined in the Plan. Participants are able to elect pre-tax or Roth deferrals. The Company makes a safe harbor matching contribution that equals 100% on the first 3% of the participant’s compensation which is deferred as an elective deferral and 50% on the next 2% of participant’s compensation which is deferred as an elective deferral. The Company may also, in its sole discretion, contribute and allocate to each eligible Participant’s account, a percentage of the participant’s elective deferral.

The Plan includes an auto enrollment feature whereby if the participant does not complete a salary reduction agreement, the Sponsor will automatically withhold 5% from the participant’s salary and contribute on their behalf starting the first pay period beginning on or after the entry date into the Plan. All automatic deferrals are to be invested into the Sponsor selected default investments until such time that the participant takes affirmative action to change their investment percentage or options. The auto enrollment feature also includes a graduated escalation percentage increase in each subsequent year of auto enrollment. The participants’ withholdings will increase one percentage point each Plan year following commencement of contributions until such time that the participant takes affirmative action or auto enrollment reaches the twelfth year and escalation is capped at 12%.

Participation

All employees of the Company are eligible to participate as of the first day of the of the first month following the completion of the eligibility requirements.

1. DESCRIPTION OF PLAN (continued)

Participant's Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) the Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant or designated beneficiary is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants generally become 100% vested in the Company's discretionary contribution portion of their account balances, plus actual earnings thereon, after one year of service.

Participants are, at all times, 100% vested in their contributions and safe harbor company match. Forfeitures occur when a participant incurs five consecutive years break in service or receives a cash-out distribution of their vested account balance upon termination. Forfeitures are retained in the Plan and used to reduce employer contributions or administrative expenses. During the year ended December 31, 2024, forfeitures reduced employer contributions by \$17,002.

Payment of Benefits

The participant or designated beneficiary will be entitled to the vested amount of the participant's individual account upon the occurrence of Plan termination, the participant's death, permanent disability, or normal retirement age as defined by the Plan document. The Plan also provides for "hardship" withdrawals as defined by the Internal Revenue Service.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Insurance

Because employee benefits depend solely on the amount in the employee's individual account, federal law provides that the Plan is not required to be insured under Title IV of the ERISA.

Expenses

The Plan document allows the Plan sponsor, AMS Impact Group, LLC, to pay administrative expenses incurred but not paid by the Plan.

(continued)

1. DESCRIPTION OF PLAN (continued)

Investment Options

The Plan provides for participant-directed investment elections among different types of money-market funds, mutual funds, and common/collective trusts. Participants may change their investment elections on any business day and as often as desired by communicating directly with the Plan's third-party administrator.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between investment funds and participant notes receivable. Loan terms typically range from 1 to 5 years, with longer terms granted for use in the purchase of a primary residence not to exceed 30 years. The loans are secured by the balance in the participant's account and bear interest at prime plus 2%. Principal and interest are paid ratably through payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the period. Investment expenses are recorded as a reduction in investment earnings. Investments for which fair value is measured using net asset value per share as a practical expedient have not been categorized within the fair value hierarchy.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with generally accepted accounting principles (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits at the date of the financial statements and the reported amounts of additions and reductions during the reporting period. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

3. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company, by a letter dated October 6, 2020, that the form of the Plan adopted by the employer qualifies under Section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan sponsor and the Plan’s third-party administrator believe that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, generally for three years following filing of required returns. However, there are currently no audits for any tax periods in progress. The Plan administrator believes it has not taken any uncertain tax positions that would subject the Plan to a tax liability or asset.

(continued)

4. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued based on the contractual terms of the underlying Guaranteed Investment Contracts' rate of return and liquidity. Reported at net asset value as a practical expedient.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value by \$837,063. Gain and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan measures its investments at fair value on a recurring basis in accordance with U.S. GAAP. Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that the authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritized the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value of measurement. The levels of the fair value hierarchy are as follows:

4. FAIR VALUE MEASUREMENTS (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets and the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Investments, at contract value

The Plan holds an interest in a stable value fund whose investment policy is to maximize current income and maintain principal stability by investing primarily in a diversified portfolio of guaranteed investment contracts (“GICs”), security-backed investment contracts (“SBICs”) and other high-quality money market instruments, cash, cash equivalents and stable value funds (including fixed income funds underlying SBICs) (“OICs”). GICs, SBICs, and OICs are types of investment contracts that are designed to provide stability and a competitive yield.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

4. FAIR VALUE MEASUREMENTS (continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The balance of investments in the stable value fund, reported at contract value was \$25,981 and \$32,859 at December 31, 2024 and 2023, respectively.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. CONCENTRATION OF CREDIT RISK

The participant notes receivable are due from Plan participants, almost all of whom live and work within Arizona and are employed by AMS Impact Group, LLC, the Plan sponsor. The notes are collateralized by the participants' accounts in the Plan.

7. RELATED-PARTY/PARTY-IN-INTEREST TRANSACTIONS

Exempt party-in-interest transaction:

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the asset custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Related party transactions:

AMS Impact Group, LLC provides certain accounting, administrative, and investment management services to the Plan, for which no fees are charged to the Plan.

Non-exempt party-in-interest transaction:

During the year ended December 31, 2024, the Sponsor failed to timely remit to the Plan certain employee deferral contributions totaling \$622,780. Under ERISA, these are considered nonexempt party-in-interest transactions. The Plan Sponsor intends to reimburse the Plan for lost earnings, file the Form 5330 and pay related excise taxes. The lost interest and excise taxes will be paid from the Plan Sponsor funds, not from the Plan's assets.

8. SIGNIFICANT ESTIMATES

The estimated fair market value of investments represents a significant estimate used by management that affects certain reported amounts and disclosures in the financial statements.

9. INFORMATION CERTIFIED BY ASSET CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulators for Reporting and Disclosure under ERISA. Accordingly, the asset custodian, Reliance Trust Company, has certified that the following data included in the financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i – schedule of assets (held at end of year), December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
