### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Globus Medical, Inc. 401(k) Plan, (the Plan) an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of Plan**

The following description of the Globus Medical, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established on June 30, 2005, covering all eligible employees of Globus Medical Inc. Inc. (the “Company”) and employees of related employers, Musculoskeletal Education and Research Center and, effective January 13, 2016, Globus Medical Inc. North America, Inc., who have completed three months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). The plan was restated and amended on February 21, 2022.

In 2024, the Company adopted a resolution to transfer the Plan’s assets and trusteeship effective January 1, 2025 from its custodian Fidelity Management Trust Company to Voya Retirement Insurance and Annuity Company. As part of the transition a portion of the investments and all of the notes receivable from participants were liquidated on December 31, 2024, with a settlement date of January 10, 2025 in the amount of \$228,003,896 and \$1,822,470, respectively, and were recorded as due from custodian on the accompanying statement of net assets available for benefits as of December 31, 2024. The plan was amended and restated effective January 1, 2025. Additionally, in June 2025, NuVasive Inc. 401 (k) Plan and the NuVasive PR Retirement Plan was merged with the Plan.

**Contributions**

Each year, participants may contribute up to 90% of eligible pre-tax compensation, as defined by the Plan, provided that in no event shall a participant’s contribution exceed the maximum dollar amount determined by the Internal Revenue Service (“IRS”) each year, which was \$22,500 for the year ended 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as permitted by the IRS. Participants may also contribute amounts representing distributions from other qualified plans. For the year ended December 31, 2024, the plan allows for participants to make pre-tax, Roth, or a combination of both deferrals.

The Company makes non-discretionary matching contributions equal to 100% of the first 3% of base compensation that a participant contributes during the Plan year or \$6,000, whichever is less.

The Plan has an auto enrollment feature whereby new eligible participants will default to a 3% pre-tax deferral contribution rate unless affirmatively elected otherwise.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s non-discretionary matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service. Participants begin to vest in Company contributions at a rate of 25% per year after completing one year of service as defined in the Plan document. Participants may be given credited service for service provided to entities acquired by the sponsor as defined in the Plan.

***Notes Receivable from Participants***

Participants may borrow, from their vested account balance, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator. As of December 31, 2024, the interest on the outstanding notes receivable from participants ranged from 3.25% to 8.50%. Principal and interest is paid ratably through participant payroll deductions. The terms of the loan cannot exceed five years unless the loan is used to acquire or construct a principal residence, which can be repaid over a longer period. Participants who terminate employment are required to repay any outstanding loan balance, or the balance is deemed a distribution.

***Payment of Benefits***

The Plan allows benefits to be paid in the form of one lump-sum payment. Upon termination of service due to death, disability, retirement or termination of employment, a participant or their beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the vested balance in the participant's individual account is greater than \$5,000, the participant (or beneficiary) may elect to maintain the account in the Plan. However, if the account balance is \$5,000 or less, the plan administrator will direct the trustee that any amount exceeding \$1,000 be distributed to an Individual Retirement Account ("IRA") for the participant's (or beneficiary's) benefit. If the account balance is \$1,000 or less, the plan administrator will direct the trustee to distribute the vested account balance to the participant without prior notice. Prior to such distribution, the participant may request that the amount be distributed to them in the form of a lump-sum payment or that it be rolled-over to an IRA or another retirement plan eligible to receive rollover contributions.

***Forfeited Accounts***

Forfeitures of non-vested Company contributions are used to reduce future employer contributions and administrative expenses. During 2024, \$74,634 and \$1,328,803 of forfeitures were used to reduce administrative expenses and the Company's contributions, respectively. At December 31, 2024 and 2023, \$0 and \$215,306, respectively, of forfeitures were available to reduce future Company contributions and/or administrative expenses.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company as provided in the Plan document.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Benefit Payments***

Benefit payments are recorded when paid.

**Note 3. Information Certified by the Plan's Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("FMTC"), the trustee of the Plan, has certified the following information as complete and accurate:

- Investments at fair value and notes receivable from participants included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- The supplemental schedule of assets (held at end of year) as of December 31, 2024.

**Note 4. Fair Value Measurements**

Accounting guidance titled *Fair Value Measurements and Disclosures* defines the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered investment companies and participant-directed brokerage accounts:* Valued using quoted market prices in an active market for each share held by the Plan.

*Common/collective trust:* Valued using observable market data on a U.S. registered exchange or publicly reported on the over the counter market.

*Stable Value Fund:* Valued at the net asset value ("NAV") of units of a stable value fund. The NAV, as provided by the trustee of the fund, is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Codification Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in the above tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The ultimate parent of the trustee of the Plan is Fidelity Investments. A majority of the Plan investment options are financial products managed by companies whose ultimate parent company is also Fidelity Investments. Transactions related to these investment options qualify as party-in-interest transactions. Recordkeeping fees paid to Fidelity amount to approximately \$264,853 for the year ended December 31, 2024.

The Plan has an agreement with Captrust Financial Advisors for investment advisory and consulting services.

The plan has engaged an independent accounting firm to perform an audit of the December 31, 2024 financial statements.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

**Note 7. Tax Status**

The Plan is a volume submitter profit sharing plan with a cash or deferred arrangement sponsored by Fidelity Management and Research Company ("Fidelity"). On March 31, 2014, the Internal Revenue Service ("IRS") stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. There, no provision for income taxes has been included in the Plan's financial statements.

Effective January 15, 2021, the Fidelity prototype plan documents adopted by the Plan were restated to adopt required amendments, regulatory changes, and other enhancements in order to maintain the Plan's tax-qualified status. On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as designed, qualifies under Section 401(a) of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administration has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

The plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit

**Note 9. Subsequent Events.**

The Plan has evaluated subsequent events through October 20, 2025, the date the financial statements were available for issuance.

As noted in Note 1, the Company transferred the Plan's assets and trusteeship effective January 1, 2025 to Voya Retirement Insurance and Annuity Company. In accordance with the transfer, Voya prototype plan documents were adopted by the Plan in order to maintain the Plan's tax-qualified status. On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as designed, qualifies under Section 401(a) of the IRC.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Globus Medical, Inc. 401(k) Plan, (the Plan) an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1. Description of Plan**

The following description of the Globus Medical, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established on June 30, 2005, covering all eligible employees of Globus Medical Inc. Inc. (the “Company”) and employees of related employers, Musculoskeletal Education and Research Center and, effective January 13, 2016, Globus Medical Inc. North America, Inc., who have completed three months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). The plan was restated and amended on February 21, 2022.

In 2024, the Company adopted a resolution to transfer the Plan’s assets and trusteeship effective January 1, 2025 from its custodian Fidelity Management Trust Company to Voya Retirement Insurance and Annuity Company. As part of the transition a portion of the investments and all of the notes receivable from participants were liquidated on December 31, 2024, with a settlement date of January 10, 2025 in the amount of \$228,003,896 and \$1,822,470, respectively, and were recorded as due from custodian on the accompanying statement of net assets available for benefits as of December 31, 2024. The plan was amended and restated effective January 1, 2025. Additionally, in June 2025, NuVasive Inc. 401 (k) Plan and the NuVasive PR Retirement Plan was merged with the Plan.

**Contributions**

Each year, participants may contribute up to 90% of eligible pre-tax compensation, as defined by the Plan, provided that in no event shall a participant’s contribution exceed the maximum dollar amount determined by the Internal Revenue Service (“IRS”) each year, which was \$22,500 for the year ended 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as permitted by the IRS. Participants may also contribute amounts representing distributions from other qualified plans. For the year ended December 31, 2024, the plan allows for participants to make pre-tax, Roth, or a combination of both deferrals.

The Company makes non-discretionary matching contributions equal to 100% of the first 3% of base compensation that a participant contributes during the Plan year or \$6,000, whichever is less.

The Plan has an auto enrollment feature whereby new eligible participants will default to a 3% pre-tax deferral contribution rate unless affirmatively elected otherwise.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s non-discretionary matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service. Participants begin to vest in Company contributions at a rate of 25% per year after completing one year of service as defined in the Plan document. Participants may be given credited service for service provided to entities acquired by the sponsor as defined in the Plan.

***Notes Receivable from Participants***

Participants may borrow, from their vested account balance, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator. As of December 31, 2024, the interest on the outstanding notes receivable from participants ranged from 3.25% to 8.50%. Principal and interest is paid ratably through participant payroll deductions. The terms of the loan cannot exceed five years unless the loan is used to acquire or construct a principal residence, which can be repaid over a longer period. Participants who terminate employment are required to repay any outstanding loan balance, or the balance is deemed a distribution.

***Payment of Benefits***

The Plan allows benefits to be paid in the form of one lump-sum payment. Upon termination of service due to death, disability, retirement or termination of employment, a participant or their beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the vested balance in the participant's individual account is greater than \$5,000, the participant (or beneficiary) may elect to maintain the account in the Plan. However, if the account balance is \$5,000 or less, the plan administrator will direct the trustee that any amount exceeding \$1,000 be distributed to an Individual Retirement Account ("IRA") for the participant's (or beneficiary's) benefit. If the account balance is \$1,000 or less, the plan administrator will direct the trustee to distribute the vested account balance to the participant without prior notice. Prior to such distribution, the participant may request that the amount be distributed to them in the form of a lump-sum payment or that it be rolled-over to an IRA or another retirement plan eligible to receive rollover contributions.

***Forfeited Accounts***

Forfeitures of non-vested Company contributions are used to reduce future employer contributions and administrative expenses. During 2024, \$74,634 and \$1,328,803 of forfeitures were used to reduce administrative expenses and the Company's contributions, respectively. At December 31, 2024 and 2023, \$0 and \$215,306, respectively, of forfeitures were available to reduce future Company contributions and/or administrative expenses.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company as provided in the Plan document.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Benefit Payments***

Benefit payments are recorded when paid.

**Note 3. Information Certified by the Plan's Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("FMTC"), the trustee of the Plan, has certified the following information as complete and accurate:

- Investments at fair value and notes receivable from participants included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- The supplemental schedule of assets (held at end of year) as of December 31, 2024.

**Note 4. Fair Value Measurements**

Accounting guidance titled *Fair Value Measurements and Disclosures* defines the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered investment companies and participant-directed brokerage accounts:* Valued using quoted market prices in an active market for each share held by the Plan.

*Common/collective trust:* Valued using observable market data on a U.S. registered exchange or publicly reported on the over the counter market.

*Stable Value Fund:* Valued at the net asset value ("NAV") of units of a stable value fund. The NAV, as provided by the trustee of the fund, is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Codification Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in the above tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

## **Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The ultimate parent of the trustee of the Plan is Fidelity Investments. A majority of the Plan investment options are financial products managed by companies whose ultimate parent company is also Fidelity Investments. Transactions related to these investment options qualify as party-in-interest transactions. Recordkeeping fees paid to Fidelity amount to approximately \$264,853 for the year ended December 31, 2024.

The Plan has an agreement with Captrust Financial Advisors for investment advisory and consulting services.

The plan has engaged an independent accounting firm to perform an audit of the December 31, 2024 financial statements.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

**Note 7. Tax Status**

The Plan is a volume submitter profit sharing plan with a cash or deferred arrangement sponsored by Fidelity Management and Research Company ("Fidelity"). On March 31, 2014, the Internal Revenue Service ("IRS") stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. There, no provision for income taxes has been included in the Plan's financial statements.

Effective January 15, 2021, the Fidelity prototype plan documents adopted by the Plan were restated to adopt required amendments, regulatory changes, and other enhancements in order to maintain the Plan's tax-qualified status. On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as designed, qualifies under Section 401(a) of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administration has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

The plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit

**Note 9. Subsequent Events.**

The Plan has evaluated subsequent events through October 20, 2025, the date the financial statements were available for issuance.

As noted in Note 1, the Company transferred the Plan's assets and trusteeship effective January 1, 2025 to Voya Retirement Insurance and Annuity Company. In accordance with the transfer, Voya prototype plan documents were adopted by the Plan in order to maintain the Plan's tax-qualified status. On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as designed, qualifies under Section 401(a) of the IRC.
