Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of St. John's Packaging LLC Retirement Savings and Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A – DESCRIPTION OF THE PLAN

The following description of the St. John's Packaging LLC Retirement Savings and Profit Sharing Plan (the "Plan") provides only general information concerning the operation of the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective June 30, 1997. The Plan is a defined contribution plan covering eligible employees of St. John's Packaging (the "Company") who have elected to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All full and part-time employees who have completed three months of service are eligible to participate in the Plan. A participant is also eligible to receive a discretionary Company contribution if the participant has worked 1,000 hours during the plan year and is actively employed on the last day of the plan year. Participants not actively employed on the last day of the plan year due to retirement, death or disability, remain eligible to receive a contribution.

Contributions

Participant contributions are subject to certain Internal Revenue Code ("IRC") limitations. The Company may provide discretionary matching contributions. During the years ended December 31, 2024 and 2023, the Company made a matching contribution equal to 50% of the first 6% of wages that a participant contributed. The Company may also provide a discretionary profit-sharing contribution to the Plan, at the discretion of the Company's board of directors. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions and allocations of discretionary Company contributions and plan earnings, and charged with any withdrawals, loan fees, allocations of plan losses and administrative expenses as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A – DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are immediately 100% vested in their contributions, the Company's discretionary matching contributions, rollover contributions, and any investment gains or losses thereon. The value of any discretionary profit-sharing contributions made by the Company to the participants' accounts vest according to the following schedule:

Forfeitures

The portion of the Company's contributions to the participant's account which is not vested upon exiting the Plan will be forfeited from the participant's account. Nonvested amounts that are forfeited from the accounts of terminated employees will be used to offset future discretionary matching and Company profit-sharing contributions of the Plan or to pay plan administrative expenses. No forfeitures were used during the years ended December 31, 2024 and 2023. As of December 31, 2024, and 2023, the balances of unallocated forfeitures were \$9,573 and \$7,692, respectively.

Investment Options

The Plan's assets are held by Vanguard Fiduciary Trust Company ("Vanguard") which provides investment management, trustee and recordkeeping services for the Plan. Participants have investment discretion over all contributions made on their behalf. The Plan currently offers approximately twenty mutual funds as investment options for participants.

Notes Receivable from Participants

Participants with at least one year of participation may borrow from their vested account a minimum of \$1,000 up to a maximum of the lesser of (1) \$50,000 or (2) 50% of the total value of their vested account balance. Participants are required to pay certain fees (origination and maintenance) upon borrowing. Note receivable transactions are treated as a transfer between the investment fund and the note receivable fund. Terms range up to 5 years or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest with rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

NOTE A – DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or, in the case of death, the participant's beneficiary, may elect to receive a single lump-sum payment. For termination of service due to leaving the Company, a participant will receive a single lump-sum payment for accounts with a value of less than \$5,000. For participant accounts with a value greater than \$5,000, a participant may elect to leave the amount in the Plan until death, disability or retirement. A participant may also receive a distribution in the event of financial hardship as defined by the Plan.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For investments in mutual funds, fair value is determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year. Investment fees charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected.

Payment of Benefits

Benefits are recorded when paid.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Administrative expenses are paid by either the Plan or the Plan Sponsor. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE C – NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are valued at the amortized cost of the note which is felt to approximate fair value. Interest income is recorded when received. The Plan currently does not have an allowance for doubtful accounts as all amounts are considered collectible.

NOTE D – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would only be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The Plan only invests in mutual funds and all such investments of the Plan are valued utilizing level 1 inputs. The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE F – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of any termination of the Plan the accounts of each affected participant shall become fully vested.

NOTE G – FEDERAL INCOME TAX STATUS

The Plan adopted a non-standardized prototype document which received a favorable determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype document, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of December 31, 2024. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2021, 2022, and 2023. There are currently no audits for any periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by The Vanguard Group, an affiliate of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$13,449 and \$13,323 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE J – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025 (the issuance date of the financial statements) and has determined that there were no subsequent events to recognize or disclose in these financial statements.
