### **Note 1 - Plan Description**

The following description of KKSP Precision Machining 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of KKSP Precision Machining, LLC (the "Company") who have completed three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

The Plan provides for employee pretax salary 401(k) contributions of up to 60 percent of annual compensation, as defined in the plan agreement, subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for safe harbor employer matching contributions. Safe harbor employer matching contributions provide for matching of 100 percent of the first 3 percent of the eligible participant's compensation and 50 percent of the next 2 percent of the eligible participant compensation during the year ended December 31, 2024.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately 100 percent vested in their pretax contributions, rollover contributions, safe harbor employer matching contributions, and any income or loss thereon.

#### ***Benefit of Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. In-service distributions from a participant's account are available to employees over the age of 59½.

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants are entitled to their account balances.

##### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance during the prior 12-month period) or 50 percent of their vested account balances. Loan terms range from 1 to 5 years unless used to purchase the participant's principal residence, in which case terms may be extended to a maximum of 10 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. All outstanding loans currently bear an interest rate of 5.25 percent. Principal and interest are paid ratably through payroll deductions.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

##### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

### **Note 1 - Plan Description**

The following description of KKSP Precision Machining 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of KKSP Precision Machining, LLC (the "Company") who have completed three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

The Plan provides for employee pretax salary 401(k) contributions of up to 60 percent of annual compensation, as defined in the plan agreement, subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for safe harbor employer matching contributions. Safe harbor employer matching contributions provide for matching of 100 percent of the first 3 percent of the eligible participant's compensation and 50 percent of the next 2 percent of the eligible participant compensation during the year ended December 31, 2024.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately 100 percent vested in their pretax contributions, rollover contributions, safe harbor employer matching contributions, and any income or loss thereon.

#### ***Benefit of Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. In-service distributions from a participant's account are available to employees over the age of 59½.

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants are entitled to their account balances.

#### **Note 1 - Plan Description (Continued)**

##### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance during the prior 12-month period) or 50 percent of their vested account balances. Loan terms range from 1 to 5 years unless used to purchase the participant's principal residence, in which case terms may be extended to a maximum of 10 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. All outstanding loans currently bear an interest rate of 5.25 percent. Principal and interest are paid ratably through payroll deductions.

#### **Note 2 - Summary of Significant Accounting Policies**

##### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value based on quoted market values.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

##### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

##### ***Benefit Payments***

Benefits are recorded when paid.

##### ***Administrative Expenses***

Various administrative costs are paid by the Company.

##### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

##### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

#### **Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

##### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

##### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

##### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

##### ***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

##### ***Money Market Fund***

The money market fund is valued at closing quoted prices reported in active markets.
