The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

#### **NOTE A - PLAN DESCRIPTION**

The following brief description of the Trilliant Food & Nutrition 401(k) Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a salary deferral plan covering employees of Trilliant Food & Nutrition, LLC and Horseshoe Beverage Company, LLC (collectively, Plan sponsor or Company) who have attained the age of 21 and have been credited with 60 days of service. The Plan is a qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). An employee is eligible to participate on the first day of each Plan quarter after 60 days of employment.

##### ***Plan Administration***

The Company is the administrator of the Plan. Alerus Retirement and Benefits is the record keeper and Alerus Financial, N.A. is the trustee of the Plan.

##### ***Participation and Contributions***

Participants may elect to defer up to 100% of their compensation on a pretax basis, not to exceed the maximum amount allowed under the Internal Revenue Code ("IRC"). The Plan currently offers a variety of investment options for participants. Participants may change their investment options daily.

All newly eligible participants are automatically enrolled in the Plan at an employee deferral contribution rate of 5% of eligible compensation. In general, such automatic enrollment will be effective the first day of the Plan quarter coinciding with the date the eligibility requirements are met, unless the participant elects to participate at a different rate or elects to opt out of enrollment.

The Plan allows participants to make Roth contributions. Roth contributions are elective deferrals that are made in the same manner as pretax elective deferrals. The sum of their Roth contribution and regular pretax 401(k) contributions may not exceed the annual limit on regular pretax 401(k) contributions.

Participants are eligible to receive employer matching contributions on the first day of the Plan quarter coinciding with or next following the date the eligibility requirements are met. The matching contribution is equal to 100% of the first 3% of the participant's elective deferral contribution, plus 50% of the participant's elective deferral in excess of 3%, not to exceed 5% of the participant's compensation for the Plan year. The employer match is done on a per payroll basis. The employer matching contribution was \$1,759,358 and \$1,463,881 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make discretionary profit-sharing contributions. Participants are eligible to receive profit sharing contributions after completion of 1,000 hours of service in the applicable Plan year and must be employed by the Company on the last day of the Plan year. No employer profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

The Company may make an additional discretionary matching contribution to the Plan upon approval of the Company. There was no discretionary matching contribution made for the years ended December 31, 2024 and 2023.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's matching and profit-sharing contributions, investment earnings (losses), and charged with benefit payments and administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting of Benefits***

Participants are immediately vested in their rollover contributions, voluntary contributions plus actual earnings thereon, employer matching contributions plus actual earnings thereon, and profit-sharing contributions plus actual earnings thereon.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant may not have more than one outstanding loan, unless the participant had more than one loan prior to January 1<sup>st</sup>, 2023 that has not been fully paid off as of December 31, 2024. Loan terms may not exceed five years unless such loan is used to acquire a dwelling unit which, within a reasonable time, will be used as the participant's principal residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates range from 4.25% to 9.50% at both December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

#### ***Benefits***

The Plan provides for withdrawals upon retirement, termination, disability, hardship or death. Normal retirement is on or after age 60. Withdrawals during employment of tax-deferred contributions may be made if the employee can prove financial hardship or if the employee has attained age 59. Hardship withdrawals do not require a deferral suspension period. Upon termination of employment for reasons other than retirement, death or disability, the accrued benefit will be all of the participant's contributions and all related earnings and losses. Payments may be made in the form of a lump sum or installment payments.

The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) changed the age at which participants are required to take required minimum distributions from their accounts. Under the law, participants' required minimum distributions may not be deferred past April 1 following the year in which the participant reaches the age of 72.

#### **NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows.

#### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded. Delinquent notes receivable from participants are recorded as benefit payments based upon the terms of the Plan.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

The Plan pays certain administrative costs and are expensed when incurred. Other expenses are paid by the Plan sponsor.

#### **NOTE C - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend, terminate or merge the Plan and discontinue its contributions at any time subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participants' accounts will remain 100% vested.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quote prices that are observable for the asset or liability, inputs that are

derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - Valued at the net asset value ("NAV") of shares held by the Plan at year end, as based on quoted market data.

*Pooled separate accounts* - Valued at the NAV of shares, which is calculated based on the valuation of the fund's underlying investments at fair value at the end of the year. As allowed under FASB guidance, fair value was determined using a practical expedient.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E - INCOME TAX STATUS

The prototype defined contribution plan and trust adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated the prototype plan and trust are designed in accordance with applicable sections of the IRC. The Company has determined that the Plan is eligible to and has chosen to rely on the current IRS opinion letter. The Plan has adopted certain discretionary amendments. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Transactions involving funds administered by Alerus Financial, N.A., the trustee of the Plan, are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of ERISA regulations.

The Plan allows participants to take out loans, which are also party-in-interest transactions.

#### NOTE G - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
