Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Pennakem Employees' Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Pennakem Employees' Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pennakem Employees' Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 – Description of plan

The following description of the Pennakem Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Penn A Kem LLC (the "Company") who are twenty-one years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute a percentage or dollar amount of pretax annual compensation subject to limits as defined by the Internal Revenue Code. Participants may also make Roth 401(k) contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Company contributes a matching contribution of 50 percent of deferrals up to 6 percent of each eligible participant's compensation, as defined in the Plan. Additional profit sharing amounts may be contributed at the discretion of the Company's Board of Directors. During the year ended December 31, 2024, no profit sharing contributions were made.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant accounts are valued yearly at the end of the Plan year.

Investments

Participants may direct contributions in various mutual fund investment options and a common collective trust fund. Participants may change their investment options and transfer previously contributed amounts between fund options at any time.

Vesting

Participants are immediately vested in their contributions and earnings thereon. Safe harbor matching contributions are also immediately 100% vested. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after 6 years of credited service.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum of 50% of their vested benefits up to \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate determined at the time the loan is made. Loan repayments and related interest are deducted from the participant's paychecks over installment periods up to five years. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$59,258 and \$214,874, respectively. These accounts will be used to pay plan expenses and reduce future profit sharing contributions or reduce future employer contributions. During the years ended December 31, 2024 and 2023, \$245,667 and \$21,150 were used to reduce employer contributions, respectively.

Note 2 – Summary of significant accounting policies*Basis of accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation). See Note 4 for further discussion of net appreciation (depreciation).

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, as these amounts are fully collateralized and deemed collectible.

Plan expenses

The Plan pays various transaction fees and some administrative expenses and the Company pays some basic administrative expenses of the Plan, as provided in the Plan document.

Payment of benefits

Benefit payments to participants are recorded when paid.

Date of management's review

Management has evaluated subsequent events through October 14, 2025, which was the date the financial statements were available to be issued, for possible recognition of disclosure in the financial statements. Management has determined that there are no material events or transactions that would require recognition or disclosure in the Plan's financial statements.

Note 3 – Information prepared and certified by trustee

The following is a summary of the information included in the Plan's financial statements and supplemental schedule for 2024 which was prepared by the trustee of the Plan assets, Reliance Trust Company, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

- A. Investments at the beginning and end of the year.
- B. Changes in net assets resulting from investment activities.
- C. Information included in the supplemental schedule of assets (held at end of year).

Note 4 – Fair value measurements

FASB Accounting Standards Codification (“ASC”) 820, Fair Value Measurement and Disclosures, provides a common definition of fair value and establishes a framework for measuring fair value. ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC Topic 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value, and describes three levels of inputs that may be used to measure fair value.

- Level 1 - Quoted prices for identical assets in active markets that the entity has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, and other inputs that are observable or can be correlated by observable market data.
- Level 3 - Significant unobservable inputs that reflect a plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trust funds: Valued at net asset value (NAV) per share (or its equivalent unit), as a practical expedient in accordance with ASC 820-10-35-59 through 62. The NAV is calculated by the trustee based on the fair value of the underlying assets of the fund, less liabilities. These investments are not classified within the fair value hierarchy (Levels 1–3). They are valued daily and redeemable at NAV, with no participant-level restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax status

The Internal Revenue Service has determined that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code. The plan has been amended since receiving the determination letter dated October 6, 2020. However, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6 – Plan termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts. Distributions are to be made as soon as administratively feasible.

Note 7 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefit.

Note 8 – Transactions with parties in interest

ADP, Inc. manages the Plan's investments. ADP, Inc. was the recordkeeper for 2024 as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment services amounted to \$48,310 for the year ended December 31, 2024.

Alerus Financial, N.A. and ADP, Inc. managed the Plan's investments for the year ended December 31, 2023. Alerus Financial, N.A. and ADP, Inc. were the trustee and recordkeeper for 2023 as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment services amounted to \$60,819 for the year ended December 31, 2023.

Note 9 – Separated participants

At December 31, 2024 and 2023, the Plan held balances for participants who have terminated totaling \$2,653,491 and \$3,252,301, respectively.
