Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500, Schedule H, line 4(i), Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of Tyson & Mendes, LLP (the Company) 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan initially effective on January 1, 2004 and restated on February 1, 2022. The Plan covers all employees of the Company who have attained the age of twenty-one and have completed 30 days of continuous employment. Employees are considered to have met the age and service requirements if employed on May 10, 2004. In order to be eligible for profit sharing contributions, the Plan requires the completion of 500 hours of service within the Plan year. If the participant is employed by the Company on the last day of the Plan year, the 500 hours of service requirement is waived. Participants may make elective deferrals into the Plan upon meeting the eligibility requirements and subject to an entry date, the first day of the month coinciding with or next following date requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendment

Effective June 1, 2023, the Plan was amended to include Roth elective deferrals.

Presentation

Certain amounts in the financial statements and associated notes may not add due to rounding.

Plan Administration

The Plan Sponsor is the administrator of the Plan and oversees governance of the Plan. As administrator, the Plan Sponsor has authority and responsibility for matters in connection with the operation and administration of the Plan (including the authority to select the Plan's investment options, which are available for employees to select for investment). Reliance Trust Company (RTC) is the trustee of the Plan and acts at the direction of the Plan's administrator. Automatic Data Processing, Inc. (ADP) is the recordkeeper for the Plan and is responsible for the day-to-day recordkeeping functions of the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. For this purpose, termination includes a complete discontinuance of contributions under the Plan or a partial termination. In the event of Plan termination, participants' accounts become fully vested and nonforfeitable. In the case of a partial termination, only those employees who are affected by the partial termination of the Plan will become fully vested and nonforfeitable.

Contributions

For the years ended December 31, 2024 and 2023, each eligible employee may contribute up to 75% of their pretax compensation, as defined in the Plan, to a maximum per year of \$23,000 and \$22,500, respectively. Participants who reach age fifty by December 31, 2024 and 2023 may contribute up to \$7,500 per year of additional tax deferred compensation under catch-up provisions of the Plan. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participant contributions at December 31, 2024 and 2023 were \$3,748,321 and \$2,910,797, respectively.

Plan participants are also eligible for a Company match. The Company matches participant pre-tax contributions at a rate of 100% up to 3%, plus 50% of the amount of participant salary deferral contributions between 3% and 5%. Employer contributions at December 31, 2024 and 2023 were \$1,833,433 and \$1,497,004, respectively.

The Plan provides for discretionary employer profit sharing contributions. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, if applicable, and (b) Plan earnings, and is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. A participant is entitled to benefits based on their vested account balance.

Vesting

Participants are immediately fully vested in their contributions and the employer matching contribution plus actual earnings thereon. Vesting in the Company's profit sharing contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service. Non-vested benefits are forfeited when a participant's employment terminates. Regardless of the vesting schedule, a participant shall become fully vested upon reaching retirement age, death, or disability.

Investment Options

The Plan offers a broad range of diversified investment options with different risk and return characteristics. The variety enables participants to select the options that best fit their investment style, from conservative to aggressive.

Notes Receivable from Participants

If authorized by the Plan's trustee, participants may borrow from their pretax vested account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Under no event will the loan amount exceed \$50,000. Loans are secured by up to 50% of the participant's vested account and bear interest at the prime rate plus 1%. Loan terms generally range from 1 to 5 years. Principal and interest is paid ratably through monthly payroll deductions. Notes receivable for the years ended December 31, 2024 and 2023 were \$456,923 and \$323,171, respectively.

Payment of Benefits

Distributions from a participant's account are generally made upon termination of employment, retirement, disability, or death. Terminated employees, with account values up to \$5,000, will receive a lump sum payment equal to their account value. Participants or their beneficiaries with account values greater than \$5,000 may receive distributions in a lump sum, installment, or partial withdrawals. Benefits paid to beneficiaries upon death of participants are made in accordance with elections available under the Plan. Total benefit payments made to participants for the years ended December 31, 2024 and 2023 were \$1,537,422 and \$2,445,892, respectively. Distributions payable to Plan participants at December 31, 2024 and 2023 totaled \$0 and \$5,265, respectively.

Forfeited Accounts

Forfeitures of non-vested employer contributions may be used to reduce plan administrative expenses or to reduce employer matching contributions. At December 31, 2024 and 2023, forfeitures remaining to be used were \$11 and \$10, respectively. Employer contributions were reduced by \$2,650 and \$415 during the years ended December 31, 2024 and 2023, respectively, from forfeited non-vested accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued. There were no material subsequent events which affected the amounts or disclosures in the financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual method of accounting.

Reclassifications

Certain amounts in the prior year financial statements have been reclassified for comparative purposes to conform with the presentation in the current year financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Loans are considered to be in default if scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. The Plan has the authority to take all reasonable actions to collect the balance due on the loan, including filing a lawsuit or foreclosing on the security for the loan. Under certain circumstances, a loan that is in default may be deemed a distribution from the Plan upon termination of the employee and could be considered taxable income to the delinquent participant. Deemed distributions to terminated employees totaled \$54,993 and \$320 for the years ended December 31, 2024 and 2023, respectively, and were included in benefit payments.

Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of the collective trust, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee determines the Plan's valuation policies. See Note C for discussion of fair value measurements. See Note E for discussion of the collective trust.

Purchases and sales of securities are recorded on trade-date basis, interest income is recorded on accrual basis, and dividends are recorded on ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant notes receivable are valued at face value which approximates fair value.

Payment of Benefits

Benefit payments to Plan participants are recorded upon distribution.

Administrative Expenses

The Company provides for certain administrative expenses for the Plan and pays for certain outside administrative services. The cost of Company provided services is not reflected in the financial statements. Investment related expenses are included in net appreciation of fair value of investments.

The Plan follows the methods of fair value measurement under FASB ASC 820 to value its financial assets. Fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, a fair value hierarchy that prioritizes observable and unobservable inputs used to measure fair value into three broad levels has been established, which are described below:

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical assets and have the highest priority.
- Level 2 Observable inputs other than quoted prices for identical assets (Level 1).
- Level 3 Unobservable inputs with the lowest priority.

The Plan uses appropriate techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs are not available. The Plan holds no Level 2 or Level 3 assets.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including Money Market Funds) - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). The funds must publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE D - INVESTMENTS

Unaudited Information Certified by RTC

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by RTC, a qualified institution.

The Plan's net assets (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$12,013,300 and \$7,178,327 for the years ended December 31, 2024 and 2023, respectively.

NOTE E - COLLECTIVE TRUST

The Plan invests in a collective trust through the Invesco Stable Asset Fund (the Fund). The primary investment objective of the Fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity.

The Fund invests primarily in synthetic guaranteed investment contracts (GICs). These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive stable value collective trust because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Fund, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan is required to provide the Fund an irrevocable written notice twelve months in advance for any withdrawal that is not a participant-initiated withdrawal, such as any withdrawal that results from an employer-initiated event. Examples of employer-initiated events include but are not limited to: termination of the plan or a request for total withdrawal of the Plan's assets from the Fund; elimination of the Fund from the Plan's investment line-up; and termination or consolidation of the plan resulting from the spin-off, sale or merger of the employer. The Fund has absolute discretion to determine that a withdrawal request is the result of an employer-initiated event. The Plan administrator does not believe that the occurrence of any such event is probable.

In addition to the limitations above, the Fund has certain rights to terminate the contract and settle at an amount that differs from contract value. For example, certain breaches by the Plan of its obligations, representations, or warranties under the terms of the investment contract can result in its termination at market value, which may differ from contract value.

NOTE F - RELATED PARTY TRANSACTIONS

ADP provides certain non-fiduciary administrative services and RTC provides directed trustee services on behalf of the Plan. In addition, the Company engages an independent third-party investment advisor to perform investment monitoring and reporting. Accordingly, transactions between these entities qualify as party-in-interest transactions. Fees paid by the Plan for these services were included in administration expense, and totaled \$168,098 and \$103,358 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE G - TAX STATUS

The Company has adopted a prototype plan and relies on the prototype plan's determination letter from the IRS dated October 6, 2020. The Company has not applied for a determination letter from the IRS specific for the Plan. Although the Plan has been amended since receiving the determination letter, the trustee and plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The Plan's exposure to a concentration of credit risk is dependent upon funds selected by participants. These risks and uncertainties could impact participants' account balances and the amounts reported in the financial statements. As a result of funds selected by participants, certain funds individually represent a concentration greater than 10% of the Plan's net assets available for benefits. As of December 31, 2024 and 2023, the following funds represented greater than 10% of the Plan's net assets available for benefits:
