### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed audits of the accompanying financial statements of Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 28, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits (liquidation basis) for the period January 1, 2024 through August 28, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of August 28, 2024 and for the period January 1, 2024 through August 28, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Company issued a formal resolution to terminate the Plan in June 2024, and the Plan was fully liquidated by August 28, 2024. As a result, the Plan changed its basis of accounting from the modified cash basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2: this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements under the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

We did not audit or review the financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2023 financial statement.

#### Note 1: Description of Plan

The following description of the Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement, including amendments, for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution pension plan covering all employees of Arizona Cardiology Group, P.C. (the "Company"). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan initially became effective on March 1, 1987.

Employees will become eligible to participate in the Plan, if they are not members of a collective bargaining unit, once they reach the age of 21. Additionally, they are eligible for nonelective contributions after completing 3 months of service, and for matching and profit-sharing contributions after 1 year of service. Plan eligibility dates are the first day of each month for elective deferrals and safe harbor matching contributions after satisfying eligibility requirements, and on the first day of the month of January and July for non-elective contributions after satisfying eligibility requirements.

##### Plan Termination

The board of directors of the Arizona Cardiology Group, P.C. issued a formal resolution to terminate the plan effective June 30, 2024. Thereafter, no further contributions were made to the Plan. In 2024 the Plan remained in operation while all account balances were distributed from the Plan. On August 28, 2024 the plan ceased to exist. The notes to the financial statements provide general information regarding the Plan's provisions up until the Plan terminated, upon which the liquidation basis of accounting was applied unless otherwise indicated.

##### Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, up to the IRC annual maximum. Such contributions may be Pre-Tax Elective Deferrals (as defined). Participants may also contribute amounts representing rollover distributions from other qualified plans ("rollovers"). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contribution into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

During 2024, the Plan operated as a safe harbor plan and the Company matched 50% of employee deferred compensation up to the first 6% of compensation contributed by the employee, resulting in a maximum employer contribution of 3% of the employee's compensation. The contributions are made annually after the close of the plan year. For the period January 1, 2024 through August 28, 2024, the Company made safe harbor matching contributions of \$64,880.

The Plan also allows for the Company to make a discretionary profit-sharing contribution. Participants who were terminated during the plan year are eligible to receive an allocation of the profit-sharing contribution if they reach the 3 months of service requirement. For the period January 1, 2024 through August 28, 2024, the Company made profit sharing contributions of \$102,888, which were reduced to \$0 by forfeitures.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their contributions, Company safe harbor contributions, plus actual earnings thereon. The Company's non-elective contributions, profit sharing contributions, and earnings thereon will be vested in accordance with the following schedule:

The vesting percentage for a participant who is an employee on or after the date the participant reaches normal retirement age (as defined by the Plan) will be 100% vested in employer contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant account. All loans shall bear an interest rate equal to the prime rate, which shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through payroll deductions. Each participant may have one loan outstanding at a time.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may also elect to rollover their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$5,000 will be immediately distributed in a lump-sum payment. With the Plan administrator's approval, participants may withdraw all or part of their aggregate contributions in the event of financial hardship. Active employees who attain age 59 1/2 are permitted to withdraw at any time any part of his or her vested account.

**Forfeited Accounts**

Prior to termination date, forfeitures were placed in an unallocated plan account, and could be used to pay Plan expenses, reallocated to plan participants or used to reduce future employer contributions. Participants in this Plan are vested 100% in both employer safe harbor and profit sharing contributions, so there were no forfeitures related to the termination of participants. Forfeitures could be created when a participant's contributions for the year exceed the IRC annual maximum and the employer contributions were the source of the overfunding. In these instances, the overfunded employer contributions were forfeited back to the Plan, and placed in the unallocated plan account. During the period from January 1, 2024 through August 28, 2024, the unallocated forfeitures of \$157,358 were reallocated to the plan's remaining participants in accordance with plan provisions.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

As discussed in Note 1, the Company terminated the Plan effective June 30, 2024. As a result, the Plan has changed its basis of accounting from the modified cash basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Under the liquidation basis, assets are stated at their estimated net realizable value and liabilities are stated at their anticipated settlement amounts. No adjustments were made to the investments at the fair value as a result of adopting the liquidation basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with the liquidation basis and modified cash basis of accounting for 2024 and 2023, respectively, requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on a cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable that are deemed by the plan administrator to be in default are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Fees and Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Date of Management's Review**

Events occurring after August 28, 2024 have been evaluated for possible adjustments to the financial statements or disclosures as of October 15, 2025, which is the date the financial statements were available to be issued.

**Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 3: Fair Value Measurements (Continued)**

*Interest-bearing cash:* Interest-bearing cash represents amounts held in bank deposit accounts or other short-term interest-bearing instruments. These amounts are valued at cost, which approximates fair value due to their short-term maturities and the liquidity of the underlying instruments. Interest-bearing cash may include amounts held temporarily pending investment transactions or benefit payments.

*Common collective trusts (“CCTs”):* Units held in common collectives are valued using the NAV practical expedient of the CCTs as reported by the CCTs managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCTs, minus liabilities, and then divided by units outstanding. The NAV practical expedient of a CCTs is calculated based on a compilation of primarily observable market information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, investments measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts in the following tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as December 31, 2023. There were no remaining assets in the Plan at August 28, 2024.

Regarding the classification of investment options offered by the Plan, there were no reclassifications in or out of levels 1, 2 or 3 during the year ended December 31, 2023. The nature, risks and investment objectives of the investments described above, including those for which fair value is estimated using NAV as a practical expedient, can be found in the Plan’s enrollment literature. These investments can be redeemed immediately and without a redemption notification period. For the year ended December 31, 2023, there were no unfunded commitments associated with any of these investments.

#### **Note 4: Certified Investment Information**

The Plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following information furnished by them and included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as reflected on the accompanying statement of net assets available for benefits as of August 28, 2024 (liquidation basis) and December 31, 2023.
- Net investment income and interest income on notes receivable from participants as reflected in the statement of changes in net assets available for benefits for the period January 1, 2024 through August 28, 2024 (liquidation basis).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information.

#### **Note 5: Party-In-Interest Transactions**

The Plan allows transactions with certain parties who may perform investment or recordkeeping services for the Plan. The Plan also issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

#### **Note 6: Tax Status**

The Plan uses a pre-approved plan document, which received an advisory letter from the IRS, dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The modified cash basis of accounting require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the statement of net assets available for benefits (modified cash basis).

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed audits of the accompanying financial statements of Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 28, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits (liquidation basis) for the period January 1, 2024 through August 28, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of August 28, 2024 and for the period January 1, 2024 through August 28, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Company issued a formal resolution to terminate the Plan in June 2024, and the Plan was fully liquidated by August 28, 2024. As a result, the Plan changed its basis of accounting from the modified cash basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2: this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements under the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Savings and Profit Sharing Plan, which comprises the statement of net assets available for benefits and the related notes to the financial statement in accordance with the modified cash basis of accounting. We did not audit or review the financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2023 financial statement.

#### Note 1: Description of Plan

The following description of the Arizona Cardiology Group, P.C. Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement, including amendments, for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution pension plan covering all employees of Arizona Cardiology Group, P.C. (the "Company"). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan initially became effective on March 1, 1987.

Employees will become eligible to participate in the Plan, if they are not members of a collective bargaining unit, once they reach the age of 21. Additionally, they are eligible for nonelective contributions after completing 3 months of service, and for matching and profit-sharing contributions after 1 year of service. Plan eligibility dates are the first day of each month for elective deferrals and safe harbor matching contributions after satisfying eligibility requirements, and on the first day of the month of January and July for non-elective contributions after satisfying eligibility requirements.

##### Plan Termination

The board of directors of the Arizona Cardiology Group, P.C. issued a formal resolution to terminate the plan effective June 30, 2024. Thereafter, no further contributions were made to the Plan. In 2024 the Plan remained in operation while all account balances were distributed from the Plan. On August 28, 2024 the plan ceased to exist. The notes to the financial statements provide general information regarding the Plan's provisions up until the Plan terminated, upon which the liquidation basis of accounting was applied unless otherwise indicated.

##### Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, up to the IRC annual maximum. Such contributions may be Pre-Tax Elective Deferrals (as defined). Participants may also contribute amounts representing rollover distributions from other qualified plans ("rollovers"). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contribution into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

During 2024, the Plan operated as a safe harbor plan and the Company matched 50% of employee deferred compensation up to the first 6% of compensation contributed by the employee, resulting in a maximum employer contribution of 3% of the employee's compensation. The contributions are made annually after the close of the plan year. For the period January 1, 2024 through August 28, 2024, the Company made safe harbor matching contributions of \$64,880.

The Plan also allows for the Company to make a discretionary profit-sharing contribution. Participants who were terminated during the plan year are eligible to receive an allocation of the profit-sharing contribution if they reach the 3 months of service requirement. For the period January 1, 2024 through August 28, 2024, the Company made profit sharing contributions of \$102,888, which were reduced to \$0 by forfeitures.

**Note 1: Description of Plan (Continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their contributions, Company safe harbor contributions, plus actual earnings thereon. The Company's non-elective contributions, profit sharing contributions, and earnings thereon will be vested in accordance with the following schedule:

The vesting percentage for a participant who is an employee on or after the date the participant reaches normal retirement age (as defined by the Plan) will be 100% vested in employer contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant account. All loans shall bear an interest rate equal to the prime rate, which shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through payroll deductions. Each participant may have one loan outstanding at a time.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may also elect to rollover their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$5,000 will be immediately distributed in a lump-sum payment. With the Plan administrator's approval, participants may withdraw all or part of their aggregate contributions in the event of financial hardship. Active employees who attain age 59 1/2 are permitted to withdraw at any time any part of his or her vested account.

**Forfeited Accounts**

Prior to termination date, forfeitures were placed in an unallocated plan account, and could be used to pay Plan expenses, reallocated to plan participants or used to reduce future employer contributions. Participants in this Plan are vested 100% in both employer safe harbor and profit sharing contributions, so there were no forfeitures related to the termination of participants. Forfeitures could be created when a participant's contributions for the year exceed the IRC annual maximum and the employer contributions were the source of the overfunding. In these instances, the overfunded employer contributions were forfeited back to the Plan, and placed in the unallocated plan account. During the period from January 1, 2024 through August 28, 2024, the unallocated forfeitures of \$157,358 were reallocated to the plan's remaining participants in accordance with plan provisions.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

As discussed in Note 1, the Company terminated the Plan effective June 30, 2024. As a result, the Plan has changed its basis of accounting from the modified cash basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Under the liquidation basis, assets are stated at their estimated net realizable value and liabilities are stated at their anticipated settlement amounts. No adjustments were made to the investments at the fair value as a result of adopting the liquidation basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with the liquidation basis and modified cash basis of accounting for 2024 and 2023, respectively, requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on a cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable that are deemed by the plan administrator to be in default are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Fees and Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Date of Management's Review**

Events occurring after August 28, 2024 have been evaluated for possible adjustments to the financial statements or disclosures as of October 15, 2025, which is the date the financial statements were available to be issued.

**Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 3: Fair Value Measurements (Continued)**

Interest-bearing cash: Interest-bearing cash represents amounts held in bank deposit accounts or other short-term interest-bearing instruments. These amounts are valued at cost, which approximates fair value due to their short-term maturities and the liquidity of the underlying instruments. Interest-bearing cash may include amounts held temporarily pending investment transactions or benefit payments.

Common collective trusts (“CCTs”): Units held in common collectives are valued using the NAV practical expedient of the CCTs as reported by the CCTs managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCTs, minus liabilities, and then divided by units outstanding. The NAV practical expedient of a CCTs is calculated based on a compilation of primarily observable market information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, investments measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts in the following tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as December 31, 2023. There were no remaining assets in the Plan at August 28, 2024.

#### **Note 4: Certified Investment Information**

The Plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following information furnished by them and included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as reflected on the accompanying statement of net assets available for benefits as of August 28, 2024 (liquidation basis) and December 31, 2023.
- Net investment income and interest income on notes receivable from participants as reflected in the statement of changes in net assets available for benefits for the period January 1, 2024 through August 28, 2024 (liquidation basis).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information.

#### **Note 5: Party-In-Interest Transactions**

The Plan allows transactions with certain parties who may perform investment or recordkeeping services for the Plan. The Plan also issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

#### **Note 6: Tax Status**

The Plan uses a pre-approved plan document, which received an advisory letter from the IRS, dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The modified cash basis of accounting require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the statement of net assets available for benefits (modified cash basis).
