I am writing to explain the reason for the late filing of our Form 5500 for the plan year ending 2024. The delay was not willful but an honest mistake that arose from confusion regarding who was responsible for submitting the form.

Our plan administrator believed that our payroll provider, ADP, would automatically handle the filing as part of their plan administration services. Unfortunately, this misunderstanding led to the filing not being completed by the required deadline. Once we became aware of the oversight, we immediately took steps to submit the form and bring our plan into full compliance.

We sincerely apologize for this unintentional error and any inconvenience it may have caused. This was our first time missing a filing deadline. Please know that we take our compliance obligations very seriously and have implemented clearer internal procedures to ensure that all future filings are completed accurately and on time.

We respectfully request that any penalties or fees associated with this late filing be waived in light of the good-faith nature of this mistake and our prompt corrective actions once it was identified. We hope the IRS will consider this request, as the delay was neither willful nor negligent but the result of an honest administrative misunderstanding.
