To whom it may concern,

On behalf of Luc Urethanes Inc. I respectfully submit this Reasonable Cause Letter for the group for FYE 2024, which was not filed on time in connection with Plan Number 001 (the "Plan"). Additionally, we respectfully request an abatement of any fines associated with this late filing.

The Luc Urethanes Plan was initially administered by the Plan Administrator, who also served as the Company Director. Due to adjustments of tasks internally, this work was moved to TABS Inc. During the transition period the email address on file with ADP was not updated properly to the new Plan Administrator resulting in missed notices of the filing requirements. This issue only came to our attention when the missed filing email was forwarded to the correct Plan Administrator. Once notified, the new Plan Administrator immediately acted and called ADP to update the contact information and promptly file the 5500 form. TABS has also implemented proactive measures to manage the Plan and ensure future compliance.

Form 5500 for FYE 2024 was subsequently submitted on October 21, 2025, after the filing deadline.

Upon identifying the missed filing, Luc Urethanes Inc, with guidance from TABS, took immediate corrective actions to address the error. We kindly request that you accept this late filing and waive any penalties, given the circumstances outlined above.
