We have performed audits of the accompanying financial statements of Eastern Airlines LLC 401(k) Profit Sharing Plan (the “Plan”), employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Note 1—Description of the Plan

The following brief description of Eastern Airlines LLC 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Eastern Airlines LLC, and its affiliate, Foxtrot Aero, LLC (collectively the “Company” or “Plan Sponsor”), as described in the Plan Agreement, who meet the eligibility requirements of the Plan. The Plan was established January 1, 2016, and was most recently amended effective September 1, 2023, to add Foxtrot Aero, LLC as an employer to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The administrative committee is responsible for oversight of the Plan, including the appropriateness of the Plan’s investment offerings and the monitoring of investment performance.

Contributions – The Plan allows for Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and collective trusts as investment options for participants. Participants may change their investment options at any time. The Plan has a fixed matching Company contribution of 50% of the first 10% of base compensation that a participant contributes to the Plan. Effective May 1, 2023, the Company’s matching contributions are limited to \$10,000, annually. The fixed matching Company contributions are participant directed as stated above. The Company may also elect to make nonelective profit sharing contributions to the Plan. There were no nonelective profit sharing contributions for the year ended December 31, 2024. The Company’s nonelective profit sharing contributions are participant directed as stated above. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts – Each participant’s account is credited with (a) the participant’s contribution, (b) the Company’s contributions, as well as allocations of the Company’s nonelective profit sharing contributions and Plan earnings (losses). Participant accounts are charged with benefits paid to participants and an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their contributions, including rollovers, along with the Company’s fixed-matching contributions and the Company’s nonelective profit sharing contributions, plus actual earnings thereon.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest ranging from 4.25% to 9.5% as of December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions. Participating employees may have a maximum of one loan outstanding at any time.

Note 1—Description of the Plan (continued)

Payment of Benefits – Upon termination of service due to death, disability, retirement, or upon termination of employment, a participant or their beneficiary(ies) will receive an automatic distribution for the participant's vested account balance under \$5,000 and, if the participant's vested account balance exceeds \$5,000, the participant or their beneficiary(ies) may elect to receive a lump-sum payment, partial payments, or installment payments equal to the value of the participant's vested account balance.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to reduce employer contributions or administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,328 and \$3,887, respectively. For the year ended December 31, 2024, \$341 in forfeitures was used to reduce employer contributions.

Hardship Withdrawals – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the IRS deems an immediate financial need of the participant.

Administration – Under the terms of a Plan Services Agreement between ADP Retirement Services and the Plan, ADP Retirement Services will provide the participant recordkeeping and other related services. All monies contributed to the Plan are forwarded to Reliance Trust Company (the "qualified institution") and invested in various funds as designated by the participant. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator and the Company to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results, as determined at a later date, could differ from those estimates.

Administrative Expenses – Professional and other fees of the Plan are typically paid by the Company; however, the Plan is allowed to pay for such expenses. Personnel and facilities of the Company are used by the Plan for its accounting and other activities at no cost to the Plan.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Options – Upon enrollment in the Plan, a participant may direct employee and the Plan Sponsor contributions in any of the investment options offered by the Plan.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the financial statements.

Note 3—Fair value measurements

Fair Value Measurements – The Plan follows the fair value measurements topic of the Financial Accounting Standards Board Accounting Standards Codification 820, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value:

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is calculated using quoted prices available in active markets and classified at Level 1 of the valuation hierarchy.

Common Collective Trust – Investments in the common collective trust are stated at estimated fair values, which have been determined based on the unit values of the fund. Unit values are determined by the organization sponsoring such funds by dividing the funds' net assets at fair value by its units outstanding at each valuation date. As there is no readily determinable fair value and the trust is valued at NAV as a practical expedient, it is shown outside the fair value hierarchy.

Note 4—Information prepared and certified by the qualified institution (unaudited)

The Plan Sponsor has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value and notes receivable from participants, as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, other income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by an affiliate of Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction in the net gain (loss) from investment activity. Fees paid by the Plan for administrative services amounted to \$90,264 for the year ended December 31, 2024. Notes receivable from participants also qualifies as party-in-interest transactions.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 7—Tax status

The Plan adopted a prototype non-standardized profit sharing with a cash or deferred arrangement plan which received a favorable opinion letter from the IRS on October 6, 2020, which stated the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.
