Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Sandstone Care Maryland 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 1, 2024 and December 31, 2023 and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through September 1, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Sandstone Care Maryland 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective September 1, 2024, the Plan merged into the Sandstone Care 401(k) Plan (see Note 7).

General

The Plan is a defined contribution plan covering all employees, excluding union, nonresident aliens, and leased employees, of Sandstone Care Maryland (the "Company") who meet certain length of service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan if they have completed three months of service and are age 18 or older.

Contributions

The Plan provides for employee pretax and after-tax salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.
