INDEPENDENT AUDITOR'S REPORT

Bishop Museum in USA Retirement Savings Multiple Employer Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bishop Museum in USA Retirement Savings Multiple Employer Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 27, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period from January 1, 2024 to December 27, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 27, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 27, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As further discussed in Note A to the financial statements, the Board of Directors of Bishop Museum, the Plan's Sponsor, resolved in September 2024 to transfer the Plan's assets to a third-party multiple employer plan and that all eligible participants would become participants of the third-party multiple employer plan. All of the Plan's assets were transferred to the multiple employer plan on December 27, 2024.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

For the Period from January 1, 2024 to December 27, 2024 and Year Ended December 31, 2023

NOTE A – DESCRIPTION OF PLAN

The Bishop Museum in USA Retirement Savings Multiple Employer Plan (Plan), formerly the Bishop Museum 401(k) Retirement Savings Plan, was established in June 2010 to provide retirement benefits to eligible employees of Bishop Museum (Museum). Effective January 1, 2019, the Plan became a participant in the USA Retirement Savings Multiple Employer Plan (MEP). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions. The Plan was amended and restated effective January 1, 2022.

In September 2024, the Board of Directors of the Museum resolved to transfer the Plan's assets to a third-party multiple employer plan and that all eligible participants would become participants of the third-party multiple employer plan. All of the Plan's assets were transferred to the multiple employer plan on December 27, 2024 and the Plan was terminated.

General

The Plan was a salary deferral plan, also known as a 401(k) plan, covering employees, who were not union members and nonresident alien employees, of the Museum. Employees who were at least 18 years of age become eligible for participation in participant deferrals on the first day of the quarter following the completion of three months of employment. Upon eligibility, employees were automatically enrolled into the Plan with a 3% deferral rate. Automatic enrollment provisions did not apply to existing participants. Employees of the Museum who met these eligibility requirements were also eligible for discretionary matching contributions.

Contributions

Participants could elect to make employee salary deferral contributions to the Plan up to the lesser of 100% of compensation or \$23,000 in 2024 and \$22,500 in 2023, adjusted annually for the cost of living, plus an additional \$7,500 in 2024 and \$7,500 in 2023, for employees age 50 and over. The Museum could also elect to make a discretionary matching contribution to eligible participants of a dollar amount or percentage to be determined by the Museum on a uniform basis for all employees. For the period from January 1, 2024 to December 27, 2024 and the year ended December 31, 2023, the Museum elected not to make any discretionary matching contribution. Total employee and employer contributions to each participant's account could not exceed the lesser of \$69,000 (\$76,500 with the catch-up contribution) in 2024 and \$66,000 (\$73,500 with the catch-up contribution) in 2023, or 100% of annual compensation, as defined. Excess contributions were refunded in accordance with provisions of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account was credited with the participant's contributions and the Museum's discretionary matching contribution (if applicable); plus an allocation, based on participant account balances of the Plan's net earnings; less an allocation of the administrative expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's account.

Vesting

Participant contributions and funds rolled over from other qualified plans, plus earnings thereon were always 100% vested. Contributions received from the Museum and earnings thereon, were fully vested upon entering the Plan.

Payment of Benefits

The vested amount in each participant's account was payable upon normal retirement (age 65), disability, death, or termination of employment. Participants could elect to receive the entire value of their accounts in a single lump-sum payment or through installment payments. Vested participant account balances of \$5,000 or less were distributed in a lump-sum distribution.

Notes Receivable from Participants

Participants could borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of the vested portion of their account balance. A participant could only have one loan outstanding at any one time. The notes receivable and related interest were required to be repaid within five years unless the note was used to acquire a principal residence. The notes were collateralized by the participants' account balances and bore interest at prevailing rates, which ranged from 8.00% to 8.50% at December 31, 2023 and matured on various dates through April 2026. Principal and interest were paid ratably through payroll deductions.

Withdrawals

Active participants could withdraw all or a portion of their vested account balances as in-service distributions after attaining age 59-1/2 or as hardship withdrawals from their elective deferral account balances, by submitting a written application that was approved by the plan administrator. Hardship withdrawals were allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals were strictly regulated by the Internal Revenue Service (IRS).

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value, except collective trust funds are reported at net asset value as a practical expedient, and guaranteed insurance contracts are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Future changes in market prices may make such investments less valuable. The Museum determined the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note E for discussion of fair value measurements.

Net appreciation in fair value of registered investment companies included the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded when earned.

Employer Contributions Receivable

Contributions receivable were recognized for amounts due from the Museum that were remitted to the Plan after year-end. Matching contributions from the Museum were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants were reported at the unpaid principal plus any accrued but unpaid interest. Interest income was recorded when earned. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses when they were incurred. No allowance for credit losses was recorded as of December 27, 2024 and 2023.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Expenses were recognized when the related liability was incurred. Investment related expenses were included in net appreciation in fair value of registered investments companies. Expenses that were paid by the Museum were excluded from these financial statements.

NOTE C – CERTIFICATION BY QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments, and note receivables from participants held at December 27, 2024 and 2023, and net appreciation in fair value of investments and interest for the period from January 1, 2024 to December 27, 2024 and year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America (Empower Insurance) and Empower Trust Company, LLC (Empower Trust), the qualified institutions of the Plan.

NOTE D – GUARANTEED INSURANCE CONTRACT

The Plan had an annuity contract with a fixed income option with Empower Insurance that maintained the contributions for these contracts in general accounts. The contract was classified as fully-benefit responsive and the value reported at contract value, which was the amount that would be received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value is the contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan and respective participants. The interest crediting rate was based on the earnings of the underlying assets of the contract in the entire medium-long term new portfolio of Empower Insurance compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate was reset quarterly. The average rate of interest credited was approximately 2.41% and 2.23% for the period ended December 27, 2024 and the year ended December 31, 2023, respectively.

The Plan's ability to receive amounts due was dependent on the contract issuer's ability to meet its financial obligations. The contract issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments. Participants could withdraw or transfer all or a portion of this investment at contract value. In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without the consent of the issuer.

Certain events limited the ability of the Plan to transact at contract value with the contract issuer. Such events included amendments to the plan documents including complete or partial plan termination or merger with another plan, bankruptcy of the plan sponsor or other plan sponsor events that caused a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA. As of December 27, 2024, the Plan was terminated, and as a result, the annuity contract no longer met the criteria for fully benefit-responsive responsive status and is now reported at fair value.

NOTE E – FAIR VALUE MEASUREMENTS

U.S. GAAP provides a hierarchy that prioritizes the inputs to the valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in registered investment companies were valued using quoted market prices, which is, a Level 1 input. Investments in collective trust funds were valued at the net asset value (NAV) of unit shares held by the Plan at year-end. The NAV, as provided by Empower Trust, was used as a practical expedient, which was based on the underlying assets of the collective trust funds. The collective trust funds were not categorized in the fair value hierarchy. There were no investments valued using Level 2 or Level 3 inputs.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan’s assets were administered by and in the custody of Empower Insurance and Empower Trust, the custodians, that held the Plan’s assets during the period from January 1, 2024 to December 27, 2024 and year ended December 31, 2023. Therefore, these transactions qualified as party in interest transactions. Certain administrative functions were performed by officers or employees of the Museum, who received no compensation from the Plan. Third-party administrator expenses were paid by the Museum. All other administrative expenses were the responsibility of the Plan. However, the Museum could have paid such expenses at its discretion. For the period from January 1, 2024 to December 27, 2024 and year ended December 31, 2023, the Museum did not pay for additional administrative expenses.

NOTE H – TAX STATUS

In a letter dated June 30, 2020, the IRS issued a “favorable determination” to the MEP as part of a non-standardized pre-approved profit-sharing/money purchase/cash or deferred arrangement plan because the MEP met the qualification requirements established by Section 401(a) of the IRC. The IRS letter to the MEP was relied upon by the Plan. The MEP’s plan document was amended since the determination letter. The plan administrator was aware of certain operational errors that, if not properly corrected, could have affected the tax qualified status of the Plan and the related custodial accounts. The plan administrator believed that the Plan was eligible to self-correct and was in the process of correcting those errors in a timely manner. Accordingly, the Plan believed it maintained its tax-qualified status and the related accounts are tax exempt.

U.S. GAAP requires uncertain tax positions to be recognized in the financial statements if they are more likely than not to fail upon regulatory examination. The plan administrator evaluated the Plan’s tax positions as of December 27, 2024 and 2023, and for the period from January 1, 2024 to December 27, 2024 and the year ended December 31, 2023, and determined that the Plan had no uncertain tax positions required to be reported. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities, including shares of collective trust funds, registered investment companies, and guaranteed insurance contracts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

The Plan and Museum operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effect on the financial statements of the Plan from such changes in economic conditions are not presently determinable.

NOTE J– DELINQUENT PARTICIPANT CONTRIBUTIONS

During the period from January 1, 2024 to December 27, 2024 and year ended December 31, 2023, the Museum made late payments of participant contributions totaling \$55,216 and \$2,766, respectively, which the Museum disclosed in Schedule H, line 4a of the 2024 and 2023 Form 5500. The Museum is working to correct the 2024 and 2023 delinquent contributions.
