Dear EBSA:

We are filing with this letter the Form 5500 for the above-named Plan for its calendar plan year ending 2021. This filing is late; however, we believe we have circumstances that qualify as “reasonable cause” and, therefore, request that both the EBSA and the IRS grant a waiver or abatement of any late filing penalties that may be assessed due to these late filings.

Fiskars Group acquired Georg Jensen, Inc in October 2023. Prior to our acquisition of Georg Jensen, the Georg Jensen, Inc. Profit Sharing Plan was transferred to another qualified retirement plan on January 4, 2021 (the “Former Plan”). In connection with that transfer, there was also a change in retirement plan service providers. Since Fiskars Group was not involved in this transfer, we had no previous knowledge as to what was, or was not done, by the former service providers until we attempted to file a final 5500 when the plan participants moved to Fiskars Group’s retirement plan this year. In doing so, we have learned there was a miscommunication between the former service providers such that the 2021 5500 for the Former Plan was never filed.

Upon this finding, we immediately sought the assistance of our current retirement plan service provider and are actively working to prepare and file electronically a 2021 Final Form 5500 and applicable schedules for the Former Plan.

Our organization has every intention – and a history - of complying with ERISA’s reporting and disclosure rules. The explanation for the lack of filing related to the Former Plan is the result of reasonable cause, not willful neglect. Accordingly, we request relief from any and all late filing penalties which the agencies may assess, or permission to apply for penalty reduction under the Delinquent Filer Voluntary Compliance Program (DFVC).

Under penalties or perjury, we present this information and declare that these statements are, to the best of our knowledge, true, correct and complete.
