Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i, as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1—Description of Plan

The following description of CapTech Ventures, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan established on January 1, 2001. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees, as defined, of CapTech Ventures, Inc. (the “Company”) who are 21 years of age or older and complete one month of service are eligible to participate in the Plan.

*Plan Administration* – The Company is the Plan sponsor and Plan administrator. Assets of the Plan are in the custody of Capital Bank and Trust Company, the “qualified institution” of the Plan. The qualified institution and American Funds are both part of the Capital Group, a large investment management firm, and are considered parties in interest. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan.

*Contributions* – Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to annual limitations established by the Internal Revenue Service (“IRS”).

The Plan provides for a 401(k) safe harbor employer matching contribution. The safe harbor matching contribution is equal to a percentage of the participant’s contributions. For the year ended December 31, 2024, the Company contributed 100% of the first 3% and 50% of the next 2% of compensation for each participant that contributed to the Plan. Additional discretionary amounts may be contributed at the option of the Company’s Board of Directors. No additional discretionary contributions were made for the year ended December 31, 2024.

*Investment Options* – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants as of December 31, 2024.

*Participant Accounts* – Each participant’s account is credited with the participant’s and Company’s contributions, an allocation of Plan earnings or losses, and charged with participant’s benefit payments and an allocation of administrative expenses. Allocations are based on participants’ compensation, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. The Plan is a safe harbor plan and, therefore, participants are immediately vested in the Plan sponsor’s safe harbor contributions to their accounts. Vesting in the Plan sponsor’s discretionary match contributions is based on years of continuous service as follows:

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The period of repayment for any loan shall be for a period not to exceed five years. The loans are secured by the balance in the participant’s account and bear interest at prevailing market rates. All outstanding loans bore an interest rate between 3.25% and 8.50% for the year ended December 31, 2024. Principal and interest are paid ratably through monthly payroll deductions.

### Note 1—Description of Plan (continued)

*Payment of Benefits* – Upon attainment of age 59½, termination, or permanent or total disability, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, installment payments, or annuity payments as defined by the Plan. At December 31, 2024 and 2023, there were no benefit payments that had been requested but not yet paid. A plan participant who is experiencing a financial hardship, as defined in the Plan document, may request a withdrawal of all or any portion of such salary deferral contributions, excluding earnings and rollovers, if any.

*Forfeited Accounts* – Forfeitures of terminated participants’ non-vested accounts are used to pay Plan expenses or reduce the Company’s contribution obligation, as directed by the Company. At December 31, 2024 and 2023, there were \$53,669 and \$42,794, respectively, forfeited non-vested accounts. During 2024, forfeitures of \$126,354 were applied to reduce employer contributions and no amounts were applied to reduce Plan expenses.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting. This basis conforms to accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits* – Benefits paid to the participants are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account.

*Risks and Uncertainties* – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution of the Plan has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, including realized and unrealized gains and losses, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### Note 4—Fair value of financial investments

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There were no transfers between levels during the year ended December 31, 2024.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 or 2023:

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Fund* – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high-quality, liquid debt, and monetary assets. The redemption and subscription frequencies are daily and the fund has no redemption notice periods or unfunded commitments. The money market fund is classified within Level 1 of the valuation hierarchy.

**Note 4—Fair value of financial investments (continued)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Tax status**

The Company adopted a prototype non-standardized plan with a deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6—Parties-in-interest transactions**

Certain Plan investments are managed by the qualified institution and these transactions qualify as party-in-interest transactions. The Company also paid certain administrative expenses of the Plan to the qualified institution and is also considered a party-in-interest. Fees paid by the Plan for quarterly administrative services were \$2,551 for the year ended December 31, 2024. Notes receivable from participants qualify as party-in-interest transactions.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.
