- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matters***

#### ***2024 Supplemental Schedule Required by ERISA***

The supplemental schedule of assets held as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

***Auditors' Report on the 2023 Financial Statements***

Predecessor auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated July 18, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

#### NOTE A - DESCRIPTION OF THE PLAN

The following description of The Motley Fool Holdings, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### [1] General:

The Plan is a defined contribution plan covering all employees of The Motley Fool Holdings, Inc. and its subsidiaries (the "Company"), except for union employees, non-resident aliens, leased employees, interns, and independent contractors. Employees are eligible to participate in the Plan upon employment. The Company is the Plan Sponsor. Charles Schwab Trust Bank serves as the Plan trustee (the "Trustee"), and Schwab Retirement Plan Services, Inc. serves as the recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### [2] Contributions:

Participants may contribute to the Plan on a pretax and/or after-tax basis, up to the lesser of 70% of annual compensation, as defined in the Plan, or the maximum allowable under the Internal Revenue Code ("IRC"). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also permits participants to make Roth elective deferrals. Participants may roll over amounts from other qualified plans to their accounts at any time during the plan year.

The Plan includes an automatic enrollment provision whereby all newly hired employees will be automatically enrolled into the Plan when the employee first becomes eligible to participate unless they affirmatively elect not to participate in the Plan. Prior to August 1, 2024, the automatic elective deferral contribution was 3% of compensation. Effective August 1, 2024, the Plan was amended to increase the automatic elective deferral contribution percentage from 3% to 6% of compensation.

In addition, prior to August 1, 2024, unless an employee affirmatively elected otherwise, deferral contributions for each active participant with automatic enrollment contributions made on their behalf were increased by 3% annually until the contribution percentage reached 9%. Effective August 1, 2024, unless an employee affirmatively elects otherwise, deferral contributions for each active participant with automatic enrollment contributions made on their behalf shall be increased by 2% annually until the contribution percentage reaches 12%.

The Company may make matching or non-elective discretionary contributions to the Plan in an amount determined annually by the Company. During 2024, the Company's matching contribution was 200% up to the first 1% of eligible compensation and 50% of the next 8% of eligible compensation. The Company made no non-elective discretionary contribution to participants for the 2024 plan year.

##### [3] Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and non-elective discretionary contributions, (b) Plan earnings and losses, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### [4] Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the employer's matching and non-elective discretionary contributions and the earnings thereon based on years of service as follows:

##### [5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime rate on the date of the application plus 1%. Interest rates on outstanding loan balances range from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

The Plan has implemented various provisions of the Secure 2.0 Act of 2022 for participants whose principal place of abode was located in a qualified disaster area and sustained an economic loss as a result ("Qualified Individual") at any time during the period specified by the Federal Emergency Management Agency that the disaster occurred ("Incident Period"). The provisions elected include suspension of loan repayment for Qualified Individuals beginning on the first day of the Incident Period and ending after 180 days and to change the maximum that Qualified Individuals can borrow during the applicable period from their fund accounts to the lesser of \$100,000 reduced by the excess of the highest outstanding balance of the participant's loans during the 1 year period to the new loan being made, or 100% of their vested account balance.

##### [6] Payment of benefits:

On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive either annual installments or a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants who are separated from service with a vested account balance at least \$1,000 but less than \$5,000 will have their account balance rolled over into an individual retirement account on the participant's behalf. If the participant's vested balance is \$1,000 or less, it is automatically distributed to the participant.

Upon proof of financial hardship, distributions may be available from the Plan.

A participant hired prior to February 1, 2021, is eligible for an early retirement option if they obtain the later of age 55 or four years of participation in the Plan.

##### [6] Payment of benefits: (continued)

The Plan has implemented various provisions of the Secure 2.0 Act of 2022 for Qualified Individuals to allow them to take a qualified disaster recovery distribution up to \$22,000, to permit a qualified birth or adoption distribution up to \$5,000, and to permit recontributions of qualified disaster recovery distributions and certain qualified hardship withdrawals for home purchases beginning on the first day of the Incident Period and ending after 180 days.

Effective August 1, 2024, the Plan elected to implement a provision of the Secure 2.0 Act of 2022 to permit in-service domestic abuse victim distributions to be taken by participants who are still employed by the Plan Sponsor.

##### [7] Forfeitures:

Forfeitures occur upon termination of employment by a participant who is not fully vested. Forfeiture amounts relating to employer contributions are used to pay the Plan's administrative expenses or to reduce employer contributions.

During the year ended December 31, 2024, forfeitures of \$50,000 were used to reduce employer contributions and forfeitures of \$61,402 were used to reduce administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$160,037 and \$40,578.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### [1] Basis of accounting:

The financial statements of the Plan are presented on the accrual basis of accounting.

##### [2] Subsequent events:

The Plan Sponsor has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

##### [3] Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### [4] Payment of benefits:

Benefits are recorded when paid.

##### [5] Plan expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, and other investment related expenses are included in administrative expenses on the accompanying statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation in fair value of investments.

##### [6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### [7] Reclassification:

Amounts in the 2023 financial statements and disclosures for cash have been reclassified to conform to the presentation in the 2024 financial statements.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity, notes receivable from participants and related activity, and cash in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes of net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. All of the Plan's investments are valued using Level 1 measurements.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**PCRA accounts, self-directed brokerage accounts** - Consists of investments in interest-bearing cash, common stock, mutual funds, exchange-traded funds, and money market funds which are valued on the basis of readily determinable market prices. The money market funds, mutual funds, and exchange-traded funds are required to publish their daily NAV and to transact at that price. The common stock is valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

##### **Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

#### **NOTE E - TAX STATUS**

The Plan has adopted the non-standardized pre-approved profit sharing/money purchase/CODA sponsored by Schwab Retirement Plan Services, Inc. On September 21, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE F - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Charles Schwab Trust Bank is the Trustee of the Plan; therefore, transactions with the Trustee qualify as party-in-interest transactions that are allowable under ERISA. For the year ended December 31, 2024, fees paid by the Plan to the Trustee totaled \$59,869. The Plan also pays accounting fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers totaled \$16,750 for the year ended December 31, 2024.

Additionally, certain Plan investments are shares of registered investment companies managed by Motley Fool Asset Management LLC, a subsidiary of the Company, and are included as a component of participant self-directed brokerage accounts. Transactions related to these investments qualify as related party transactions.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE H - PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### **NOTE I - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.
