**Opinion**

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Southeastern Freight Lines, Inc. Insurance Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### **General**

The Plan provides medical, pharmacy, dental, vision, critical illness, accident, disability, life insurance, hospital indemnity and flexible benefits to the full-time employees (excluding those living in Puerto Rico) who have been employed for a minimum of 30 days and eligible dependents of Southeastern Freight Lines, Inc. (the Company or Plan Sponsor). The Plan also provides continuation of certain health benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan and related trust were established on December 20, 1988. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

##### **Benefits - Fully Insured**

The Plan fully insures vision, critical illness, accident, disability, life insurance, and hospital indemnity benefits. The Company purchases annual insurance contracts for these insured benefits. The Company funds these programs through monthly premiums from participants. The Company remits the monthly premiums in arrears. December premiums collected and remitted in early January the following year were approximately \$986,000 and \$820,000 for 2024 and 2023, respectively.

##### **Benefits - Self Insured**

The Plan's medical, pharmacy and dental benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's Voluntary Employees Beneficiary Association (VEBA) trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan. Employees contribute a portion of the cost of their coverage and their dependent's coverage. Such employee contributions are used to reduce the Company's cost of providing benefits. Prior to the VEBA trust termination documented in Note 3, the Company's policy was to maintain a cash balance in the VEBA trust that approximates claims incurred but not reported. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

##### **Benefits - Other**

The Plan includes a Flexible Spending Arrangement (FSA), Health Savings Account (HSA), and Dependent Care Account (DCA). The FSA and DCA allow participants to set aside a portion of their earnings to pay for qualified expenses as defined in the Plan document. Participants can withdraw funds from their FSA and DCA up to the maximum amount of reimbursement, for eligible expenses related to healthcare and childcare, respectively. Individuals enrolled in certain high-deductible health plans can enroll in the HSA to make tax-favored contributions. Contributions made to the HSA are used on a tax-free basis to pay or reimburse qualifying health expenses. Activity related to the HSA has been excluded from these financial statements because the Plan is not obligated to pay the benefits.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared using the cash basis of accounting. Accordingly, all contributions to the Plan are recorded when received and all benefit claims, premiums, and administrative expenses are recorded when paid, rather than when such claims and expenses are incurred or submitted for payment. The cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

***Cash***

Cash consists of deposits with banks and financial institutions which are unrestricted as to withdrawal or use and which have original maturities of three months or less. The Plan maintains cash at high quality financial institutions which, at times, may exceed federally insured limits. However, the Company periodically evaluates the credit worthiness of those financial institutions and has not experienced any losses on such deposits.

***Plan Benefits***

Plan obligations as of December 31 for covered claims incurred by participants, but not paid by that date, are estimated by the Plan Administrator on the basis of past loss experience. Such estimated amounts are reported in Note 7 below.

The Plan Sponsor receives refunds and pharmacy rebates from service providers periodically during the year related to pharmacy claims processed through the Plan. During 2024, refunds and pharmacy rebates received totaled approximately \$13,408,000.

Refunds and rebates due to the Plan Sponsor are recorded when received. As of December 31, 2024 and 2023, refunds and rebates related to the pharmacy claims earned but not received, totaled approximately \$7,716,000 and \$6,900,000, respectively.

***Use of Estimates***

The preparation of financial statement disclosures requires plan management to make estimates, benefit obligations and changes therein, claims incurred but not reported, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Administrative Expenses***

The Plan is responsible for paying all claims processing fees, commissions, taxes and charges unless paid by the Company.

**NOTE 3 - TRUST TERMINATION**

The Plan is ongoing; however, effective June 30, 2024, the Administrative Steering Committee and the Board of Directors of Southeastern Freight Lines, Inc. approved the termination of the Plan's VEBA trust. The trust's assets that were held by Wells Fargo Bank, N.A. (the Plan's Custodian) were applied to claims for eligible participants and beneficiaries, which resulted in an ending balance within the Wells Fargo VEBA account of \$0 as of December 31, 2024.

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and contributions to the Plan. In the event that the Company decides to terminate the Plan, the assets of the

Plan will be used to continue to fund covered claims of the employees and their eligible dependents as described in the Plan document.

**NOTE 4 - TAX STATUS**

The VEBA trust established under the Plan to hold the Plan's assets was intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The trust has obtained an exemption letter from the Internal Revenue Service dated May 25, 1989 and the Plan sponsor believes that the trust, as subsequently amended, continued to qualify and to operate in accordance with the applicable provisions of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan as of December 31, 2024 and 2023, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

BlueCross BlueShield of South Carolina and Delta Dental of Missouri are service providers for the Plan and are paid claims processing fees. Therefore, transactions with both service providers qualify as parties-in-interest transactions. Fees paid by the Plan to the service providers were approximately \$4,253,000 for the year ended December 31, 2024. In addition, the Plan has several arrangements with service providers for fully insured coverage.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan benefit obligation is reported based on certain assumptions pertaining to past loss experience and employee demographics, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 7 - PLAN BENEFIT OBLIGATIONS**

In addition to historical claims paid, the average claim lag period of 16 days was a significant assumption used in the December 31, 2024 and 2023 determination of the Plan benefit obligation.

**NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

In connection with the termination of the VEBA trust in June 2024, Plan contributions and benefit payments that were previously paid to, or made from, the VEBA Trust ceased. All future Plan transactions will be funded from the Company's general assets. As a result, as of December 31, 2024 there are no assets, payables or obligations to be reported on the Plan's Form 5500 because the Plan is no longer funded through a trust.
