Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of JFGI, Inc. and Affiliated Agencies 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan was adopted effective January 1, 2011 and is a defined-contribution plan sponsored by the Jewish Federation of Greater Indianapolis, Inc. (Company) for the benefit of its employees who have at least one year of service with completion of 1,000 hours and are age 21 or older. Affiliated agencies who also participate in the Plan include Indianapolis Jewish Home, Inc. (d/b/a Hooverwood Living); and Jewish Community Relations Council, Inc. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Metropolitan Life Insurance Company (MetLife) is the Plan recordkeeper. Reliance Trust Company (Reliance) is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions of 100% of eligible compensation. Employee rollover and catch-up contributions are also permitted. The Company and its affiliated agencies have elected to make a "safe-harbor" nonelective contribution to eligible Plan participants, which equates to 3% of participant's eligible compensation. The Plan also provides for a discretionary matching contribution as determined by the participating agencies up to 4% of a participant's compensation. During 2024 and 2023, the discretionary matching contribution for the participating agencies ranged from 1% - 2% of eligible compensation. In addition, the Plan provides for a discretionary profit-sharing contribution as determined by the Company and its affiliated agencies. There were profit-sharing contributions of \$27,414 and \$0 in 2024 and 2023, respectively. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily. The main investment platform is a qualified Morningstar investment platform that also allows for target date funds. The Plan also provides a self-directed option for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company and its affiliated agencies' contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and safe harbor nonelective contributions plus earnings thereon. Vesting in the Company and its affiliated agencies' discretionary matching and profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service. The nonvested balance is forfeited as of the earlier of the last day of the Plan year in which the participant incurs five consecutive one-year breaks in service or the distribution of the participant's vested account. Forfeitures are used to pay administrative expenses and reduce Company and its affiliated agencies' contributions.

Payment of Benefits

Upon termination of service, an employee may elect to receive a lump-sum amount or installment payments equal to the value of his account, a partial withdrawal or a joint and survivor annuity. Hardship withdrawals are permitted by the Plan. In-service withdrawals of employee contributions to those participants who have attained age 59 1/2 are permitted by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,224 and \$2,706, respectively. These accounts will be used to pay administrative expenses and/or reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$10,080 and \$10,363, respectively, from forfeited nonvested accounts.

Plan Termination

Although it has not expressed an intention to do so, the Company and its affiliated agencies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at cost, which approximates fair value. The investments included within the self-directed brokerage account consist primarily of mutual funds and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants, from their employee contributions account. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's account balance of elective deferrals and rollover contributions. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence). Interest on the loans is based on the prime rate plus 1%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Plan Tax Status

The Plan operates under a nonstandard adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Metropolitan Life Insurance Company. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, MetLife Resources, a division of MetLife, and Reliance, the recordkeeper and trustee of the Plan, respectively, which are qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with MetLife. MetLife maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the fixed annuity investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed annuity investment contract. Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the investment contract at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a number of factors, including, but not limited to, the level of net investment income that can be earned on newly purchased general account assets, the absolute level of interest rates, the shape of the yield curve, how interest rates have moved since the inception of the contract, the minimum guaranteed interest rate and interest rates on alternative investments. MetLife reserves the right to restrict participants from beginning participation, increasing their percentage allocations or transferring from other investment options to the fixed income option.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan recordkeeper. The Plan paid \$28,019 and \$21,780 of recordkeeping fees to MetLife during 2024 and 2023, respectively. Additional fees paid to parties-in-interest totaled \$27,563 and \$24,675 during 2024 and 2023, respectively. During 2024 and 2023, the Plan received \$7,586 and \$5,684 of revenue sharing income, which was used to offset additional administrative expenses paid to MetLife. The Plan paid \$2,763 and \$4,661 in investment advisory fees to MetLife Securities, Inc. during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Company failed to remit employee contributions in the amount of \$18,358 in accordance with the Department of Labor's remittance policy for the year ended December 31, 2023. These employee contributions were remitted to the Plan in 2023. The Company failed to remit an employee contribution in the amount of \$32 in accordance with the Department of Labor's remittance policy for the year ended December 31, 2022 and remitted to the Plan during 2023.

Note 10. Subsequent Events

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
