To the Department of Labor,

I am writing to respectfully request a waiver of the penalty assessed on my account, Chads Landscaping, for the reporting period ending 11/15/2025. The penalty was incurred due to a late filing/payment, which was the result of technical issues that prevented me from accessing my online account in a timely manner.

I have always taken my compliance obligations seriously and have a history of timely filings. However, from 10/01/2025 to 10/22/2025 I was unable to access the online portal. Specifically, I was unable to log in, receiving an error message stating 'Invalid credentials,' despite entering the correct information.
