Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of the Harpeth Hall School Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period from January 1, 2024 through March 31, 2024 and statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and for the period ended March 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we are unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

(1) Description of plan

The following description of the Harpeth Hall School Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on November 1, 1967 to provide retirement benefits for employees of Harpeth Hall School (the "Plan Sponsor"). The Plan covered substantially all employees of Harpeth Hall School upon hire ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective April 1, 2024, the Plan merged into The Independent School Group Retirement Plan. Assets in the amount of \$47,636,112 were transferred from the Plan to The Independent School Group Retirement Plan on the effective date. The net assets transferred were recognized in the participants' accounts of The Independent School Group Retirement Plan as previously carried in the accounts of the Plan.

(b) Contributions

Participants who worked more than twenty hours per week could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 403(b) of the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions could not exceed the participant's statutory limitation under IRC Section 415 or Section 402(g), whichever was less. For participants age 50 and over, this amount included any additional catch-up contribution permitted under IRC 414(v).

For eligible participants, the Plan Sponsor would contribute a discretionary amount (equal to 10% of the participant's compensation for 2024 and 2023) once the participant had reached age 21 and had completed one year of service at Harpeth Hall School or another educational institution. Employees who worked less than twenty hours per week were not eligible for these Plan Sponsor contributions. There were \$291,172 and \$1,249,318 in Plan Sponsor contributions made during 2024 and 2023, respectively. Plan Sponsor and participant contributions could not exceed the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, Plan Sponsor contributions, investment earnings (losses) and administrative expenses. According to the plan agreement, Plan Sponsor contributions were allocated based on participant's compensation, and investment earnings (losses) and administrative expenses were allocated based on account balances. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

(d) Vesting

Participants were immediately vested in their elective salary deferral and Plan Sponsor's contribution plus actual earnings (losses) thereon.

(e) Payment of benefits

On termination of service due to death, permanent disability, retirement or termination of service due to other reasons, a participant could elect to receive either a lump-sum payment subject to certain restrictions described in Note 5 or a lifetime monthly payment that could continue to a designated beneficiary if the participant died after retirement.

(f) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(g) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the processing of distributions were included in administrative expenses and charged directly to the participant's account. Investment related expenses were included in net appreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments were stated at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, TIAA and College Retirement Equity Fund ("CREF"). See Note 4 and Note 5.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between March 31, 2024 and October 13, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Information related to investments reported and disclosed in the accompanying financial statements, including investments at fair value and contract value held at December 31, 2023, and net appreciation in fair value of investments, interest income, and dividend income for the period from January 1, 2024 through March 31, 2024 and the year ended December 31, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TIAA and CREF.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

- (i) *Money market fund*: Valued at the net asset value ("NAV") of shares held by the Plan at year end.
- (ii) *Registered investment company shares*: Valued at the NAV of shares held by the Plan at year end in an active market.

- (iii) *Fixed annuity contracts*: The two TIAA Traditional Non Benefit Responsive contracts are valued based on the market approach at contract value, which is calculated as the accumulated cash contributions and interest credited to the plan's contracts, less any withdrawals. Contract value approximates fair value. TIAA seeks to construct a portfolio that optimizes returns within the regulatory constraints and capital requirements on life insurance company general accounts. The contracts generally have liquidity restrictions applicable to participant withdrawals and transfers. These vary based on the type of annuity contract and include but are not limited to restrictions on lump sum withdrawals and annual installments, a waiting period to withdraw funds after certain events, and the payment of surrender charges.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Fixed annuity contracts with insurance companies

The Plan held four fixed annuity contracts with TIAA at December 31, 2023. TIAA maintained the Plan's contributions in general accounts which were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The two TIAA Traditional Non Benefit Responsive contracts were included in the financial statements at fair value, which approximate contract value as reported to the Plan by TIAA. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

The TIAA Traditional Benefit Responsive contract and the TIAA Stable Value Fund met the fully benefit-responsive investment contract criteria and therefore were reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

For the fixed annuity contracts with TIAA, the crediting interest rate was based on a formula agreed upon with the issuer, but could not be less than 1% to 3%, depending on the sub contract. The fixed annuity contracts with TIAA were offered through a variety of sub contracts which determined the applicability of certain account features, such as the degree of liquidity of the participant's account and the options for receiving income upon retirement. The sub contract, Retirement Annuity ("RA"), did not allow lump-sum cash withdrawals from the fixed annuity contracts and transfers were spread over a period of 10 annual installments. For the sub contract Group Retirement Annuity ("GRA"), lump-sum withdrawals were available from the fixed annuity contract only within 120 days after termination of employment and were subject to a surrender charge. All other withdrawals and transfers from the RA or GRA fixed annuity contract to other investment options available to the Plan were spread over a period of 10 annual installments (or five annual installments for withdrawals after termination of employment). For the sub contract, Retirement Choice ("RC"), participant withdrawals and transfers were taken in 84 monthly installments, except when a lump sum distribution was available, if permitted under the plan, in the 120 day period following termination of employment with a surrender charge. The sub contracts Supplemental Retirement Annuity ("SRA"), Group Supplemental Retirement Annuity ("GSRA"), and Retirement Choice Plus ("RCP") contracts had no liquidity restrictions.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

Certain events could have limited the ability of the plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. In management's opinion, there were no events with probability of occurring that could have limited the ability of the Plan to transact at contract value with the contract issuers and that also would have limited the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

(6) Income tax status

The Plan Sponsor adopted a 403(b) volume submitter plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on March 31, 2017, which stated that the 403(b) volume submitter plan was designed in accordance with the applicable requirements of the IRC. The Plan itself had not yet received a determination letter from the IRS stating that the Plan was qualified under Section 403(b) of the IRC. However, the plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of March 31, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related party and party-in-interest transactions

Certain Plan investments were a money market fund, a pooled separate account, registered investment company shares, and fixed annuity contracts managed by TIAA and CREF and, therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualified as party-in-interest transactions.
