1. Description of Plan

The following description of the Tribute Baking Company 401(k) Plan (the “Plan”) provides only general information. The Plan was originally effective October 1, 2022. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Tribute Bakery Acquisition, LLC d/b/a Tribute Baking Company, and participating employers, (collectively the “Company”), who are age 18 and completed six months of service with the Company. Eligible employees who have satisfied the eligibility requirements are able to enter the Plan on the first day of the month coinciding with the date the eligibility requirements were met. Union employees, nonresident aliens, and residents of Puerto Rico are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Reliance Trust Company (“Reliance”) is the trustee of the Plan.

Contributions

Each year, participants may contribute a minimum of 1% up to a maximum of 90% of their pretax compensation, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed by law. Participants may designate contributions as Roth contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions each pay period equal to 100% of a participant’s salary deferrals that do not exceed 3% of eligible compensation, plus 50% of a participant’s salary deferrals that exceed 3% of eligible compensation but do not exceed 5% of eligible compensation.

Additional employer matching contributions may be contributed on a discretionary basis. The Company did not make any discretionary employer matching contributions to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, safe harbor matching contributions, and discretionary employer matching contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeited Accounts

Forfeitures are generally used to pay administrative expenses or to offset any employer contributions. The total unallocated forfeiture account balance was \$21 and \$21 at December 31, 2024 and 2023, respectively. No forfeitures were used to offset employer contributions or pay administrative expenses during the year ended December 31, 2024.

Vesting

A participant, at all times, has a fully vested (100%) interest in their own contributions, safe harbor matching contributions and rollover contributions, including actual earnings thereon. Vesting in discretionary employer matching contributions, and earnings thereon, occurs at a rate of 20% per year beginning after two years of service, with 100% vesting occurring after 6 years of service. A participant will also become 100 percent vested upon death, disability or reaching normal retirement age (age 65) while an employee.

Payment of Benefits

On termination of service due to death, disability, retirement, or otherwise, a participant may elect to receive the value of the participant's vested interest in his or her account in a lump-sum amount, partial withdrawals or installments. Plan provisions allow for distributions to be made as soon as administratively feasible following severance of employment, regardless of account balance. Participant consent for a distribution is only required if the distribution is over \$7,000 (\$5,000 prior to the modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE Act 2.0")). In-service distributions are also permitted from participant accounts, based on the terms of the Plan document. Hardship distributions are not permitted.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% as of the date of the loan application. Principal and interest are generally paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence. A participant may have only one loan outstanding at any given time.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants, safe harbor matching contributions and discretionary employer matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including custodial, trustee and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Reliance Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment activity, including net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

Effective October 1, 2022, through the adoption of an ADP Defined Contribution Pre-Approved Plan, the Plan was amended. The Internal Revenue Service (“IRS”) issued an opinion letter dated October 6, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. As the Plan became effective October 1, 2022, all years remain subject to income tax examination as of December 31, 2024.

6. Related-Party and Party-In-Interest Transactions

Transactions with ADP Retirement Services, the recordkeeper of the Plan, and Reliance Trust Company, the trustee of the Plan, are considered party-in-interest transactions. Fees paid by the Plan to ADP, Inc. amount to \$4,790 for the year ended December 31, 2024. These transactions are not, however, considered prohibited transactions under the ERISA regulations. Fees paid directly from participant accounts, including those for the administration of participant loans, are included in administrative expenses. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
