## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Coastal Family Health Center Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Coastal Family Health Center Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Coastal Family Health Center Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

**NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the Coastal Family Health Center Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General - The Plan is a defined contribution profit sharing plan generally covering all full-time employees of Coastal Family Health Center, Inc. (the Company) who have completed three (3) consecutive months of employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with Section 4975 (e) (7) of the Internal Revenue Code of 1986 (the Code). The Plan is administered by Coastal Family Health Center, Inc. However, various record-keeping, compliance, and financial reporting requirements are performed through an independent, contracted plan administrator (AIG VALIC Retirement Services Company and Mutual of America). The Plan's investments are held by the Plan's administrator (the Company's Executive Director, its Finance Officer, and one of its Board members), and managed by AIG VALIC and Mutual of America. All investments are directed by the employees.
- b. Contributions - Participants may contribute a percent of their annual compensation to the Plan not to exceed the limits allowable by the Internal Revenue Service. The Company matches employee deferrals up to 5%. The Company also pays a significant amount of the Plan's administrative expenses. Total contributions to the Plan during the years ended December 31, 2024 and 2023 were \$1,073,828 and \$1,082,455, respectively.
- c. Participant Accounts - Each participant's account is credited with employee elective deferrals plus an allocation of (a) the Company's contribution, if any, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- d. Vesting - Employees are immediately vest in all account additions.
- e. Participant Loans - Participants may borrow up to half of the present value of their vested account balance, up to the \$50,000 limits according to the guidelines established by the Plan's Trustees. Loans are payable through payroll deductions over terms ranging up to 5 years, except for certain participant home loans which may allow an additional reasonable period of time. Loans accrue interest at rates determined by the Plan's Trustees which range from 4.25% - 9.50% as of December 31, 2024.
- f. Payment of Benefits - Benefit payments are generally made in a lump sum payment, in cash, upon the participant's death, disability, or retirement. Normal retirement is at age 65. Early retirement can be elected at age 60 if the participant has at least 10 years of service.
- g. Forfeited Accounts - For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$-0-, respectively. Such forfeitures reduce employer contributions.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation (depreciation) on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

**NOTE 3: PLAN AMENDMENTS AND TERMINATIONS**

Effective January 1, 2012, the Plan was amended to a safe harbor plan which eliminates the four-year vesting schedule (i.e. 100% immediate vesting) and provides for 100% employer matching contributions on discretionary employee deferrals up to 5%. Also, hardship withdrawals and loans of employee deferred amounts are allowed.

In November 2024, the Plan was restated again in connection with the transition to a new recordkeeper, Mutual of America, and the related change in Plan trustee. This pre-approved plan document incorporated administrative and operational updates to align with Mutual of America's platform requirements. The restatement did not result in any material changes to the benefits provided under the Plan or to participant account balances.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 4: TAX STATUS**

The Plan is currently maintained under two separate plan documents. The primary plan document, which governs the majority of Plan assets, is a pre-approved plan document that received a favorable IRS opinion letter dated November 30, 2020. This opinion letter confirmed that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

In addition, a second plan document remains in place for a portion of Plan assets still held at a prior trustee. This is due to restrictions under the Corebridge Fixed Account Plus contract(Note 7), which limits transfers to no more than 20% of the account value per contract year during the accumulation phase. As a result, not all assets could be immediately transferred when the Plan transitioned to Mutual of America as the primary recordkeeper and custodian. This pre-approved plan document received a favorable IRS opinion letter dated June 30, 2020.

The Plan administrator and the Plan's tax counsel believe that both plans are currently designed and operating in compliance with such requirements.

The federal income tax return of the Plan is subject to examination by the IRS for a period of three years after the return is filed.

**NOTE 5: UNAUDITED INFORMATION**

VALIC and Mutual of America each served as custodians of the Plan's investment assets during the year ended December 31, 2024, and executed transactions therein. Financial information relating to these assets is included in the accompanying financial statements and is based on information provided by the respective custodians. The financial information presented on pages 3 and 4 and in Notes 6 and 7 with respect to investments, investment income, and appreciation (depreciation) in fair value of investments, as well as fully benefit-responsive investment contracts, has not been audited by the independent auditors.

**NOTE 6: FAIR VALUE MEASUREMENTS - UNAUDITED**

Fair Value Accounting - Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - valued using net asset value of shares held by the plan trustee at year end.

Guaranteed Interest Accounts - valued using the unit values provided by the plan trustee at year end.

Mutual Funds - valued using net asset value of shares held by the plan trustee at year end.

Guaranteed Interest Accounts - valued using the unit values provided by the plan trustee at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT - UNAUDITED**

In 2001, the Plan entered into a fully benefit-responsive investment contract with The Variable Annuity Life Insurance Company for a Group Fixed and Variable Deferred Annuity Contract. VALIC maintains the contributions in a fixed account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value approximates fair value. The balance at December 31, 2024 and 2023 was \$2,545,970 and \$3,996,336, respectively.

Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guaranteed interest rate under the contract is an average annual effective rate. The guaranteed interest rate varies by participant and depends on the date the participant established their account. Participants set up before December 1, 2003 have a minimum guaranteed interest rate of 3%. The minimum guaranteed interest rate for accounts set up on or after December 1, 2003 is 2%. Effective January 1, 2011, contracts issued to new participants have an indexed guaranteed minimum rate.

Certain events limit the Plan's ability to transact at contract value with VALIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example,

divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

**NOTE 8: LATE REMITTANCE OF PARTICIPANT CONTRIBUTIONS**

During the year ended December 31, 2024, certain participant contributions and/or loan repayments were not remitted to the Plan within the time frame required by the Department of Labor (DOL) regulations, which require that such amounts be remitted as soon as they can reasonably be segregated from the employer's general assets. The Plan sponsor has since remitted the delinquent contributions to the Plan. As of the date of this report, the Plan sponsor is in the process of calculating and remitting the applicable lost earnings associated with these late remittances.

**NOTE 9: SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 8, 2025 the date the financial statements were available to be issued. There were no events which require disclosure at December 31, 2024.
