Following reasons:

1. We are a small health care company with very few office employees left to handle most of our paperwork; the handful of staff left is working constantly just to keep up with the workload. Most of our office staff has been laid off just to decrease cost in order to cover payroll and other expenses.
2. The number of clients /income coming in is presently very low.
