INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
Academy for Advancement of Children with Autism 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Academy for Advancement of Children with Autism 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Academy for Advancement of Children with Autism 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Academy for Advancement of Children with Autism 401(k) Plan’s ability to continue as a going concern for one year after the date financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Academy for Advancement of Children with Autism 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan, established on January 1, 2021, is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The Plan is a defined contribution plan which was established for the benefit of substantially all employees of Academy for Advancement of Children with Autism (collectively, the "Employer") and meets all requirements under Sections 401(a) and 401(k) of the Internal Revenue Code ("IRC").

2. Eligibility

All employees of the Company who have completed six months of service are eligible to participate on the first day of the calendar month following the date of eligibility. The Plan includes an automatic enrollment provision by which eligible employees who do not affirmatively elect a deferral rate are automatically enrolled into the Plan at a default elective deferral rate of 3%.

3. Contributions

Eligible employees may elect to defer up to 100% of their annual compensation, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan does not offer employer matching contributions.

The Employer may make non-elective contributions. These contributions are discretionary, including the discretion to forego a contribution for one or more plan years. For the year ended December 31, 2024, the Employer did not make a non-elective contribution.

For the years ending December 31, 2024 and 2023, the Plan had Employer receivables totaling \$-0- and \$8,956, respectively. The full balance is 25% of the actual lost deferral plus lost earnings. Plan management has worked with their TPA to rectify the errors.

4. Administration of Plan Assets

Certain officers of the Employer are administrators of the Plan. Certain administrative functions are performed by the officers or employees of the Employer. No such officer or employee received compensation from the Plan. Certain custodial fees are paid by the Plan. Other administrative expenses including auditing and accounting fees may be paid by the Plan or directly by the Employer.

5. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions as desired, in any of a variety of investment options made available by Matrix Trust Company, the custodian of the Plan. Participants may change their investment options daily.

6. Participant Accounts

Each participant's account is credited with the participant's contributions, employee rollovers, and allocations of non-elective contributions, if any, Plan earnings or losses, and forfeitures of terminated participants' nonvested accounts. Allocations of non-elective contributions, if any, are based on the ratio of the participant's compensation to the total compensation of all eligible participants. The benefit to which a participant ultimately is entitled is the value of the participant's account, subject to vesting provisions, upon separation from the Plan or retirement.

7. Vesting

Participants are immediately vested in their salary deferral contributions, any rollovers from other plans, plus actual earnings thereon. Vesting in the Employers' non-elective contributions, if any, is 25% after one year of service, with vesting increasing 25% each year, thereafter, until the fourth year, at which time participants become 100% vested.

8. Payment of Benefits

Upon termination of service, a participant is entitled to receive their vested account balance. In the event of reaching normal retirement age, permanent disability, or in the event of death while employed, a participant or a participant's beneficiary is entitled to receive 100% of their account balance. Distributions from the Plan are made in the form of lump-sum cash payments or installment payments, if needed to satisfy required minimum distribution rules. In-service and hardship withdrawals are permitted if certain criteria are met.

9. Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to reduce future Employer contributions or Plan expenses. There were no forfeited nonvested amounts at December 31, 2024 and 2023.

10. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions, and Plan assets are distributed to the Plan participants in accordance with the provisions of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Payment of Benefits

Benefits are recorded when paid.

7. Administrative Expenses

Administrative expense incurred by the custodian and certain service providers in the performance of their duties are paid from the assets of the Plan. Investment related expenses are included in net appreciation/depreciation of fair value of investments. All other out-of-pocket administrative expenses are paid by the Employer. Expenses paid by the plan sponsor are excluded from these financial statements.

8. Contributions

Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Exchange-traded funds (“ETFs”): Valued at the daily closing price as reported by the fund. ETFs held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. ETFs held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Employer adopted a Non-Standardized Pre-Approved Profit-Sharing Plan (“pre-approved plan”) which received its latest favorable opinion letter from the Internal Revenue Service (“IRS”) dated March 14, 2022, which stated that the pre-approved plan is designed in accordance with applicable sections of the IRC. The plan administrator and the Plan’s advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administrations errors, if any, which are insignificant or operational in nature are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Matrix Trust Company is the custodian of the Plan. All investments are held with the custodian. Vestwell is the recordkeeper for the Plan. These transactions qualify as party-in-interest transactions.

INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
Academy for Advancement of Children with Autism 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Academy for Advancement of Children with Autism 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

Basis for Opinion

Other Matter - Supplemental Schedule Required by ERISA



NOTE A - DESCRIPTION OF THE PLAN

The following description of the Academy for Advancement of Children with Autism 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan, established on January 1, 2021, is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The Plan is a defined contribution plan which was established for the benefit of substantially all employees of Academy for Advancement of Children with Autism (collectively, the "Employer") and meets all requirements under Sections 401(a) and 401(k) of the Internal Revenue Code ("IRC").

2. Eligibility

All employees of the Company who have completed six months of service are eligible to participate on the first day of the calendar month following the date of eligibility. The Plan includes an automatic enrollment provision by which eligible employees who do not affirmatively elect a deferral rate are automatically enrolled into the Plan at a default elective deferral rate of 3%.

3. Contributions

Eligible employees may elect to defer up to 100% of their annual compensation, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan does not offer employer matching contributions.

The Employer may make non-elective contributions. These contributions are discretionary, including the discretion to forego a contribution for one or more plan years. For the year ended December 31, 2024, the Employer did not make a non-elective contribution.

For the years ending December 31, 2024 and 2023, the Plan had Employer receivables totaling \$-0- and \$8,956, respectively. The full balance is 25% of the actual lost deferral plus lost earnings. Plan management has worked with their TPA to rectify the errors.

4. Administration of Plan Assets

Certain officers of the Employer are administrators of the Plan. Certain administrative functions are performed by the officers or employees of the Employer. No such officer or employee received compensation from the Plan. Certain custodial fees are paid by the Plan. Other administrative expenses including auditing and accounting fees may be paid by the Plan or directly by the Employer.

5. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions as desired, in any of a variety of investment options made available by Matrix Trust Company, the custodian of the Plan. Participants may change their investment options daily.

6. Participant Accounts

Each participant's account is credited with the participant's contributions, employee rollovers, and allocations of non-elective contributions, if any, Plan earnings or losses, and forfeitures of terminated participants' nonvested accounts. Allocations of non-elective contributions, if any, are based on the ratio of the participant's compensation to the total compensation of all eligible participants. The benefit to which a participant ultimately is entitled is the value of the participant's account, subject to vesting provisions, upon separation from the Plan or retirement.

7. Vesting

Participants are immediately vested in their salary deferral contributions, any rollovers from other plans, plus actual earnings thereon. Vesting in the Employers' non-elective contributions, if any, is 25% after one year of service, with vesting increasing 25% each year, thereafter, until the fourth year, at which time participants become 100% vested.

8. Payment of Benefits

Upon termination of service, a participant is entitled to receive their vested account balance. In the event of reaching normal retirement age, permanent disability, or in the event of death while employed, a participant or a participant's beneficiary is entitled to receive 100% of their account balance. Distributions from the Plan are made in the form of lump-sum cash payments or installment payments, if needed to satisfy required minimum distribution rules. In-service and hardship withdrawals are permitted if certain criteria are met.

9. Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to reduce future Employer contributions or Plan expenses. There were no forfeited nonvested amounts at December 31, 2024 and 2023.

10. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions, and Plan assets are distributed to the Plan participants in accordance with the provisions of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Payment of Benefits

Benefits are recorded when paid.

7. Administrative Expenses

Administrative expense incurred by the custodian and certain service providers in the performance of their duties are paid from the assets of the Plan. Investment related expenses are included in net appreciation/depreciation of fair value of investments. All other out-of-pocket administrative expenses are paid by the Employer. Expenses paid by the plan sponsor are excluded from these financial statements.

8. Contributions

Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Exchange-traded funds ("ETFs"): Valued at the daily closing price as reported by the fund. ETFs held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. ETFs held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Employer adopted a Non-Standardized Pre-Approved Profit-Sharing Plan (“pre-approved plan”) which received its latest favorable opinion letter from the Internal Revenue Service (“IRS”) dated March 14, 2022, which stated that the pre-approved plan is designed in accordance with applicable sections of the IRC. The plan administrator and the Plan’s advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administrations errors, if any, which are insignificant or operational in nature are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Matrix Trust Company is the custodian of the Plan. All investments are held with the custodian. Vestwell is the recordkeeper for the Plan. These transactions qualify as party-in-interest transactions.
