Independent Auditor's Report

The Plan has applied the liquidation basis of accounting effective January 1, 2024 as a matter of convenience, as doing so prior to May 15, 2024 has no material impact qualitatively or quantitatively to the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. MERCER BUCKS ORTHOPAEDICS, P.C. 401(k) AND PROFIT SHARING PLANNOTES TO FINANCIAL STATEMENTSDECEMBER 31, 2024NOTE 1. Description of the Plan

The following description of Mercer Bucks Orthopaedics, P.C. 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of Mercer Bucks Orthopaedics, P.C. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Administrative Committee of the Plan is responsible for oversight of the Plan.

Investment options: Upon enrollment in the Plan, a participant may direct both employee and employer contributions into any of the investment funds offered by the Plan's trustee, Capital Bank and Trust Company. Participants may change their investment options at any time. The investment advisor determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Administrative Committee.

Contributions: Amounts are to be contributed to the Plan by the employees through payroll withholdings on eligible earnings, as defined in the Plan. Catch-up contributions are allowed if the employee has attained age 50 before the end of the Plan year. The Company may make discretionary matching contributions in accordance with an allocation formula that specifies a percentage of an eligible employee's elective deferrals. Participants are allowed to make rollover contributions to their accounts from other qualified retirement plans. Contributions are subject to certain IRS statutory limitations.

Participant accounts: Each participant's account is credited with the participant's elective deferral contribution, the Company's matching contribution, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses and investment advisory fees that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. In the event of plan termination, the participant is 100% vested.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator.

NOTES TO FINANCIAL STATEMENTS - ContinuedNOTE 1. Description of the Plan - continued

The interest rate must be a reasonable one based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are repaid in level payments over a period not extending beyond five years and with a frequency not less than quarterly, generally through payroll deductions. If a loan is for the purchase of a principal residence, it may then be repaid over a fifteen-year period.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may also receive the value of their vested interest in his or her account as a lump sum distribution. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed via participant deferrals may be withdrawn for a hardship purpose.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0- and \$19,681 respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$15,686 in 2024 and \$19,698 in 2023 from forfeited nonvested accounts.

NOTE 2. Summary of Significant Accounting Policies

Basis of accounting: The plan prepared its 2023 financial statements on the accrual basis of accounting. As a result of the Company's decision to terminate the Plan effective May 15, 2024, further described in Note 7 to the financial statements, the Plan has prepared its 2024 financial statements using the liquidation basis of accounting in accordance with FASB ASC 205-30-25-2. This change has no material qualitative or quantitative impact on the Plan's financial statements. Thus, the Plan has applied the liquidation basis of accounting effective January 1, 2024, as a matter of convenience, instead of the May 15, 2024 date of imminent liquidation.

Use of estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES TO FINANCIAL STATEMENTS - ContinuedNOTE 2. Summary of Significant Accounting Policies - continued

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The interest rates charged during the 2024 and 2023 plan years were 5.25% to 10.50%. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess contributions payable: Amounts payable to participants for contributions in excess of amounts allowed by the IRS, if any, are recorded as a liability with a corresponding increase in benefits paid to participants. The Plan distributes such excess contributions to the applicable participants prior to March 15 of the following year. There were no excess contributions payable at December 31, 2024 or 2023.

Payment of benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees paid by the Plan to a third party investment advisor are allocated to participant accounts as defined in the Plan, and are classified as investment advisory fees. Fees paid by the Plan to a third party administrator related to the general administration of the Plan are allocated to participant accounts as defined in the Plan, and are classified as administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE 3. Tax Status

The IRS issued a determination letter dated June 30, 2020, stating that the plan is a pre-approved plan and qualified under the IRC Section 401(a). Thus, the Plan is qualified under IRC Section 401(a) and the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTES TO FINANCIAL STATEMENTS - ContinuedNOTE 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and Exchange Traded Funds (ETF): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and preferred stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

NOTES TO FINANCIAL STATEMENTS - ContinuedNOTE 4. Fair Value Measurements - continued

Corporate and municipal bonds and marketable certificates of deposit: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

U.S. government securities: Valued using pricing models maximizing the use of observable inputs for similar securities.

NOTE 5. Information Prepared and Certified by Trustees

The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all information related to investments and notes receivable from participants, with the exception of information related to self-directed brokerage accounts, disclosed in the accompanying financial statements and net appreciation (depreciation) in fair value of investments and interest and dividend income for the periods ended October 2, 2024 and December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan). All investments and notes receivable from participants for which the above certification applies were completely liquidated and transferred out of the Plan on or before October 2, 2024.

NOTES TO FINANCIAL STATEMENTS - ContinuedNOTE 6. Group Annuity Contract with Reliance Trust Company

The Plan offers as benefit options, traditional fully benefit-responsive group annuity contracts with the Reliance Trust Company (the contract issuer) ("Reliance"), known as the Reliance Trust Company Stable Value Fund Collective Investment Trust, Series 25053 ("Trust"). The Trust maintains the contributions in a pooled separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Trust. The crediting rates are based on a formula established by the contract issuers. The guaranteed investment contracts do not permit the issuers to terminate the agreements prior to the scheduled maturity dates. At December 31, 2024 and 2023, the amount invested in contract Series 25053 was \$-0- and \$413,015, respectively.

The group annuity contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Although the Plan terminated effective May 15, 2024, this did not limit the ability of the Plan to transact at contract value with the issuer or the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract (3) a material misrepresentation, or (4) a material amendment to an agreement without the consent of the issuer.

NOTES TO FINANCIAL STATEMENTS - ContinuedNOTE 7. Plan Termination

On May 10, 2024, the Company, through the administrative committee, adopted a corporate resolution to terminate the Plan, effective May 15, 2024, and all contributions to the plan ceased as of that date. All participants were fully vested in their account balances and the account balances were liquidated and distributed to participants as soon as administratively possible after the effective date, with all accounts being liquidated on or before December 31, 2024.

Prior to the termination, the Company, in accordance with plan provisions, had the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination for reasons other than a merger, participants would have become 100% vested in their employer contributions.

NOTE 8. Party-in-Interest Transactions

As described in Note 1 and Note 2, the Plan paid certain expenses to service providers related to plan administration and investment advisory services. These transactions are party-in-interest transactions under ERISA.

NOTE 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
